PLEASE TAKE NOTICE that on January 15, 2021, Alan D. Halperin, in his capacity as the Liquidating Trustee (the “Liquidating Trustee”) of the FBI Wind Down, Inc. By the Motion, the Liquidating Trustee is seeking entry of an order of the Bankruptcy Court directing that (a) all distributions relating to the claims of holders that have failed to provide required tax information (collectively, the “No TIN Claims”) be deemed “unclaimed”; (b) the holders of the No TIN Claims not be entitled to share in any distribution from the Liquidating Trust on account of such No TIN Claims; and (c) the Liquidating Trustee be authorized to (i) disregard the No TIN Claims for purposes of calculating and making any further distributions, and (ii) distribute or use all funds reserved for or relating to the No TIN Claims in accordance with the terms of the Confirmation Order, the Plan, and the Trust Agreement, all as described more fully in the Motion.
