**SUPPLEMENTAL DECLARATION OF ANDREW GRAISER
IN SUPPORT OF THE APPLICATION OF DEBTORS FOR ENTRY
OF AN ORDER AUTHORIZING THE RETENTION AND EMPLOYMENT OF
A&G REALTY PARTNERS, LLC AS REAL ESTATE CONSULTANT
AND ADVISOR TO THE DEBTORS EFFECTIVE AS OF THE PETITION DATE**

I, Andrew Graiser, pursuant to 28 U.S.C. § 1746, hereby declare under penalty of perjury that the following is true and correct to the best of my knowledge, information and belief:

1. I am a Co-President of A&G Realty Partners, LLC (“**A&G**”), which has a principal place of business at 445 Broadhollow Road, Suite 410, Melville, New York 11797. As such, I have personal knowledge of the facts set forth herein and am duly authorized to submit this Supplemental Declaration on A&G’s behalf in support of the Application of NPC International, Inc. and its debtor affiliates in the above-captioned chapter 11 cases (“**Debtors**”) for entry of an order authorizing the employment and retention of A&G as the Debtors’ real estate consultant and advisor effective as of the petition date [Docket No. 207] (“**Application**”).²

2. I file this Supplemental Declaration to supplement my declaration that was filed with the Court on July 14, 2020 [Docket No. 207] (“**Original Declaration**”) and include clarifications and additional disclosures.

3. By way of background, A&G was formed in January 2012. A&G is a private New York limited liability company whose majority members are me and Emilio Amendola. LI Realty Investments, LLC (“**LI Realty**”) is a minority member of A&G. LI Realty became a member in A&G for the sole purpose of serving as a capital source for A&G, if needed, for potential real estate investment transactions. A&G will not be tapping that financing source for any purpose in these cases.

4. As set forth in the Original Declaration, the Debtors, Weil Gotshal & Manges LLP, Debtors’ counsel (“**Weil**”), and A&G entered into the Services Agreement as of April 24, 2020. It is my understanding that pursuant to the order approving the Debtors’ retention of A&G, any references to Weil as a party to the Services Agreement (or otherwise) will be removed from the Services Agreement. A&G consents to such modification of the Services Agreement.

5. As further set forth in the Original Declaration, Kimco Realty Corp. or affiliates (“**Kimco**”) is one of the Debtors’ landlords. Upon information and belief, Kimco is the landlord of two (2) of the Debtors’ retail locations.

6. Upon information and belief, Kimco Realty Services II, Inc. (“**Kimco Realty**”) is one of three members of LI Realty; Kimco Realty owns a 33.3% membership interest in LI Realty. Upon further information and belief, Kimco Realty is an affiliate of Kimco.

7. No Kimco employee, principal, officer or director is an employee, principal, officer, or director of A&G, participates in A&G's management in any fashion, has access to any of A&G's systems or corporate information, or exercises any control over A&G.

8. Kimco Realty's indirect interest in A&G was obtained in 2013 and, therefore, was created under circumstances wholly unrelated to these Chapter 11 Cases.

9. A&G, on behalf of the Debtors, can be adverse to Kimco in these cases.

10. With respect to clients for which A&G obtained lease restructurings in the past 12 months, including leases where Kimco or a Kimco affiliate was the landlord, the fees realized on such matters represent less than one percent (1%) of the aggregate fees incurred by A&G during that time period and thereby distributed to its members during the 12 months prior to the commencement of these cases.

11. The identity of Potential Parties in Interest, referenced and defined in Paragraph 19 of my original declaration, is set forth in **Schedule 1** attached hereto.

12. Additionally, based on (a) my original Declaration in support of the Application and (b) this Supplemental Declaration, to the best of my knowledge, information and belief, A&G (i) does not hold or represent any interest adverse to the Debtors' estate and (ii) is a "disinterested person" within the meaning of section 101(14) of the Bankruptcy Code.

13. Lastly, A&G has determined that it will be utilizing the services of independent contractors ("**Contractors**") in connection with the Services Agreement. A&G will: (a) exclusively bear the cost of such Contractors and not pass on to the Debtors any costs or expenses of such Contractors, (ii) ensure that the Contractors are subject to the same conflict checks as required for A&G, and (iii) file with the Court such disclosures as are required by Bankruptcy Rule 2014 with respect to the Contractors.

I declare under penalty of perjury that the foregoing is true and correct.
