**SUPPLEMENTAL DECLARATION OF NEIL A. AUGUSTINE IN
SUPPORT OF APPLICATION OF DEBTORS FOR ENTRY OF AN ORDER
(I) AUTHORIZING THE EMPLOYMENT AND RETENTION OF GREENHILL & CO.,
LLC AS INVESTMENT BANKER TO THE DEBTORS AND DEBTORS IN
POSSESSION, EFFECTIVE AS OF PETITION DATE, (II) MODIFYING CERTAIN
TIME-KEEPING REQUIREMENTS, AND (III) GRANTING RELATED RELIEF**

I, Neil A. Augustine, declare, pursuant to 28 U.S.C. § 1746, under penalty of perjury that

1. I am a Vice Chairman and Co-Head of North American Financing Advisory and Restructuring at Greenhill & Co., LLC (“**Greenhill**”), a leading independent investment bank which has its principal office at 300 Park Avenue New York, NY 10022². I am authorized to execute this Supplemental Declaration on behalf of Greenhill. This supplemental declaration (the “**Supplemental Declaration**”) is being submitted to supplement my initial declaration (the “**Initial Declaration**”) attached as Exhibit C to the *Debtors’ Application of*

Debtors for Entry of Order (I) Authorizing the Employment and Retention of Greenhill & Co. LLC as Investment Banker to the Debtors and Debtors in Possession Effective as of the Petition Date, (II) Modifying Certain Time-Keeping Requirements, and (III) Granting Related Relief [Docket No. 224] (the “**Application**”).³ I submit this Supplemental Declaration to provide the disclosures required under Bankruptcy Rule 2014(a).

2. Except as otherwise stated in this Supplemental Declaration, I have personal knowledge of or have relied upon the knowledge of others employed by Greenhill with respect to the matters set forth herein.⁴ If called to testify, I could and would testify competently to the facts set forth herein.

3. Greenhill & Co, LLC is the sole Greenhill entity providing services, pursuant to its regulatory license and permissions, as it relates to the Engagement Letter, the Application and these chapter 11 cases. To the extent that any additional Greenhill entities seek to be retained by Debtors to provide services in connection to these chapter 11 cases, such retention and services will be subject to Court approval in accordance with the Bankruptcy Code, the Bankruptcy Rules, and the Local Rules.

4. To the extent that Greenhill uses the services of independent contractors, subcontractors, or employees of foreign affiliates or subsidiaries (collectively, the “**Contractors**”) in the Chapter 11 Cases, Greenhill shall (a) pass-through the cost of such Contractors to the Debtors at the same rate that Greenhill pays the Contractors, (b) seek reimbursement for actual costs only, (c) ensure that the Contractors are subject to the same

conflict checks as required for Greenhill, and (d) file with this Court such disclosures required by Bankruptcy Rule 2014.

5. The term “Services” as used in the Application and pursuant to the Engagement Letter shall be limited to those services as agreed upon between Greenhill and the Debtor, and does not include services listed in the Engagement Letter between Greenhill and Weil, Gotshal & Manges LLP (“Weil”). It is my understanding that pursuant to the proposed order approving the Debtors’ retention of Greenhill (the “**Proposed Order**”), any references to Weil as a party to the Engagement Letter (or otherwise) will be removed from the Engagement Letter. Greenhill consents to such modification of the Engagement Letter. Accordingly, in consideration for the compensation contemplated by the Engagement Letter, Greenhill will, to the extent reasonably requested by the Debtors, render the following investment banking services (collectively, the “**Services**”):⁵

- a. review and analyze the Debtors’ assets and the historical financial performance of the Debtors, including their liquidity;
- b. analyze and monitor the Debtors’ financial results and key operating performance indicators;
- c. review and analyze the business plan and financial projections prepared by the Debtors, including, but not limited to, testing assumptions and comparing those assumptions to Debtors’ historical trends and industry trends;

- d. assist the Debtors' management in determining the value maximizing strategy with respect to renegotiating the Debtors' franchisee agreements and in developing alternative operating structures with the franchisors;
- e. evaluate the Debtors' potential debt capacity in light of their capital requirements and projected cash flows;
- f. assist in the determination of an appropriate capital structure for the Debtors and their affiliates;
- g. assist in the determination of a range of values for the Debtors as a going concern;
- h. identify and/or initiate a potential Transaction and/or a New Capital Raise;
- i. assist the Debtors in raising, structuring and effecting new debt, equity or other securities, including, but not limited to, bridge, debtor-in-possession and/or exit financing, including assisting in developing marketing materials, creating and maintaining a data room and contact log, initiating contact with potential capital providers, running the process for a New Capital Raise, evaluating proposals received and assisting in negotiating final commitment letters and definitive documentation;
- j. evaluate strategic alternatives of the Debtors, develop Transaction and/or New Capital Raise frameworks;
- k. provide advice and coordinate with management to develop a strategy for Transactions and/or New Capital Raises and other transactions, as applicable;
- l. provide financial advice and assistance to the Debtors in structuring any new securities, other consideration or instruments to be offered and/or issued in connection with a Transaction and /or a New Capital Raise;

- m. assist the Debtors in reviewing the terms of any proposed Transaction, in responding thereto and, if directed, in evaluating alternative proposals for a Transaction;
- n. advise the Debtors on the risks and benefits of considering a Transaction and/or New Capital Raise with respect to the Debtors' intermediate and long-term business prospects and strategic alternatives to maximize the business enterprise value of the Debtors;
- o. assist or participate in negotiations with the parties in interest, including, without limitation, any current or prospective franchisors, cooperatives, landlords, creditors, and other related counterparties of the Debtors and/or their respective representatives in connection with a Transaction;
- p. advise the Debtors with respect to, and attend, meetings of the Debtors' senior management, board of directors, special committee of the board of directors, audit committees (as necessary), other advisors, creditor groups and other interested parties, as necessary, with respect to matters on which the Financial Advisor has been engaged to advise under the Engagement Letter;
- q. if requested by the Debtors, participate in hearings before the United States Bankruptcy Court in which such cases are commenced and provide relevant testimony with respect to the matters described herein and issues arising in connection with any proposed Plan in the Financial Advisor's area of expertise concerning a Transaction and/or New Capital Raise; and

- r. provide such other general advisory services and investment banking services (to the extent permitted by further orders of the Court) as are customary for similar transactions and as may be mutually agreed upon by the Debtors and Greenhill.

6. For the avoidance of doubt, although Greenhill is defined in the Engagement Letter as “Financial Advisor”, the services Greenhill will perform are those typically provided by an investment bank. During the course of these chapter 11 cases, Greenhill understands that the Debtors have retained and may retain additional professionals and advisors, including Alix Partners LLP and A&G Realty Partners LLC. Greenhill will work cooperatively with such professionals and advisors to integrate and not duplicate work conducted by the other professionals on behalf of the Debtors.

7. Paragraph 27 of the Application makes reference to a “Monthly Fee.” For the avoidance of doubt, this is a reference to the “Monthly Advisory Fee.”

8. Greenhill is a leading independent investment bank focused on providing financial advice globally. Greenhill has three primary types of advisory business: mergers and acquisitions (M&A), capital advisory, and restructuring. Greenhill has 19 operating legal entities worldwide through which it conducts these businesses (the “**Affiliated Entities**” and, together with Greenhill, the “**Greenhill Corporate Group**”). The Greenhill Corporate Group does not have any trading, lending, underwriting, research or asset management operations.

9. As described in my Initial Declaration, in connection with its proposed retention by the Debtors in these cases, Greenhill obtained from the Debtors and/or their counsel the names of individuals and entities that may be parties-in-interest in these chapter 11 cases (the “**Potential Parties in Interest**”). The Potential Parties in Interest are each listed in **Schedule 1**, annexed hereto.

10. Following receipt of the list of the Potential Parties in Interest, Greenhill undertook to determine whether it had any conflicts or other connections that might cause it not to be disinterested or to hold or represent an interest adverse to the Debtors or their estates. To do so, Greenhill used a software program to compare the names of the Potential Parties in Interest against an internal database maintained by the Greenhill Corporate Group that includes all current and former Greenhill Corporate Group client engagements, with the comparison limited to current and former client engagements that ended within three years prior to the date hereof. Greenhill also compared the names of the Potential Parties in Interest against an internal database of all Greenhill Corporate Group vendors, employees and those entities for which Greenhill Corporate Group employees sit on a board of directors or other governing body, again limiting the comparison to in each case for the three years prior to the date hereof. Greenhill subsequently analyzed the results produced by the software comparison program to eliminate false positives. To the extent that this process revealed that any of the Potential Parties in Interest (or their apparent affiliates or entities that Greenhill believes to be affiliates, as the case may be) had a connection to a member of the Greenhill Corporate Group, such parties are listed on the revised **Schedule 2** annexed hereto or this Supplemental Declaration.

11. In **Schedule 3** annexed hereto, Greenhill has provided additional disclosure with respect to engagement agreements entered into in the three year prior to the date hereof between a member of the Greenhill Corporate Group and certain KKR or Deutsche Bank entities.

12. To the best of my knowledge, based on the search described above, neither Greenhill nor I, nor any other employee of Greenhill that will provide services to the Debtors in connection with this engagement, has any connection with or holds or represents any interest

adverse to the Debtors, its estates or the Potential Parties in Interest, except (a) as set forth in **Schedule 2** and (b) as otherwise set forth below:

- a. To the best of my knowledge, Greenhill has not represented any Potential Parties in Interest in the last three years in connection with matters relating to the Debtors, their estates, assets or businesses, and will not represent entities other than the Debtors in matters relating to these chapter 11 cases. Greenhill can be adverse to its current and former clients in matters relating to these chapter 11 cases.
- b. As part of its practice, Greenhill appears in numerous cases, proceedings and transactions involving many different professionals, some of which may represent claimants and parties in interest in these chapter 11 cases. Furthermore, Greenhill has in the past and will likely in the future be working with or against other professionals involved in these chapter 11 cases in matters unrelated to these chapter 11 cases. Based on my current knowledge of the professionals involved, and to the best of my knowledge, none of these connections represents an interest adverse to the Debtors or their estates.
- c. I have a limited partnership interest in a fund managed by one of the withdrawn bidders on the redacted list of NPCQB bidders in **Schedule 2**.⁶ This bidder was at one time a potential bidder in connection with a sale process in these chapter 11

In the interest of maximizing participation in the sale processes, the Debtors have requested that Greenhill not disclose the identity of the NPCQB bidder.

cases. However, this bidder has withdrawn from the sale process and is therefore not an active bidder and has no other connection with the Debtors. Furthermore, my limited partnership interest in this fund managed by the withdrawn bidder is a minority interest that is de minimis to the withdrawn bidder and represents less than 2% of my net worth. I have no knowledge or control over the withdrawn bidder's decisions and am unaware of their rationale for determining not to pursue the sale process further. For these reasons, I believe this connection is not disqualifying and does not represent an interest adverse to the Debtors or their estates.

13. Insofar as I have been able to ascertain after reasonable inquiry, Greenhill has not been retained to assist any entity or person other than the Debtors on matters relating to, or in connection with, these chapter 11 cases. Greenhill will, however, continue to provide professional services to entities or persons that may be creditors or equity security holders of the Debtors or interested parties in these chapter 11 cases; provided that such services do not relate to, or have any connection with, these chapter 11 cases or the Debtors.

14. I am not related to or connected to, and, to the best of my knowledge, no other professional of Greenhill who will work on this engagement is related or connected to, any United States Bankruptcy Judge for the Southern District of Texas, the United States Trustee for Region 7 or any person employed by the U.S. Trustee in the Southern District of Texas Division.

15. To the best of my knowledge, as of the date hereof, Greenhill: (a) is a "disinterested person," as such term is defined in section 101(14) of the Bankruptcy Code and as is required under section 327(a) of the Bankruptcy Code; (b) does not hold or represent an interest adverse to the Debtors' estates; and (c) has no connection to the Debtors, their creditors,

shareholders, or other parties in interest, except as disclosed in this Supplemental Declaration, the Initial Declaration, and in **Schedule 2** attached hereto.

16. To the best of my knowledge, columns 3 and 4 of **Schedule 3** disclose all transactions in which any of the listed KKR or Deutsche Bank entities is, or was, involved in any role (including, but not limited to, matters in which a KKR or Deutsche Bank entity was a Greenhill client). With respect to the matters in which the KKR or Deutsche Bank entities listed on **Schedule 3** was a client of Greenhill, no such matter accounted for more than 1.0% of Greenhill's revenue during the 12 months prior to the date hereof. Greenhill can be adverse to the KKR and Deutsche Bank entities listed on **Schedule 3** in matters relating to these chapter 11 cases.

17. The payments referenced to in paragraph 11 of the Initial Declaration, during the 90-day period prior to the Petition Date, of (i) \$154,511.22 on April 8, 2020; (ii) \$154,055.00 on May 12, 2020; (iii) \$150,000 on June 10, 2020 and (iv) \$150,798.00 on June 26, 2020, were made by NPC International, Inc.
