**NOTICE OF FINAL DESIRED 365 CONTRACTS
DESIGNATED FOR ASSUMPTION AND ASSIGNMENT
IN CONNECTION WITH THE WENDY’S SALE TRANSACTION**

PLEASE TAKE NOTICE OF THE FOLLOWING:

On January 20, 2021, a hearing was held electronically via video/telephone before the Honorable David R. Jones at which the Debtors sought and were granted approval of the Stalking Horse Sale Transaction and the Wendy’s Sale Transaction.²

On January 25, 2021, the Court entered the (i) *Order (A) Authorizing the Sale of Acquired Assets Free and Clear of Liens, Claims, Encumbrances, and Other Interests, (B) Authorizing and Approving the Purchase Agreement For Such Sale, (C) Approving the Assumption and Assignment Of Certain Executory Contracts and Leases in Connection Thereto and, (D) Granting Related Relief* [Docket No. 1474] (the “**Stalking Horse Sale Order**” and the (ii) *Order (A) Authorizing the Sale of Acquired Wendy’s Assets Free and Clear of Liens, Claims, Encumbrances, and Other Interests, (B) Authorizing and Approving the Wendy’s Purchase Agreement For Such Sale, (C) Approving the Assumption and Assignment Of Certain Executory Contracts and Leases in Connection Thereto and, (D) Granting Related Relief* [Docket No. 1475] (the “**Wendy’s Sale Order**,” and Exhibit B attached thereto, the “**Desired 365 Contracts List**”).

Pursuant to Section 2.02 of the Wendy’s Purchase Agreement³ at any time prior to the date that is forty-five (45) days following entry of the Wendy’s Sale Order, and in any event no later than fourteen (14) days prior to Closing (the “**Extended Determination Period**”), the Wendy’s

Purchaser is entitled, in its sole discretion, to add or remove any executory contracts to the Desired 365 Contracts List.

You are receiving this notice because you may be a Counterparty to a Desired 365 Contract (i) identified in Exhibit A attached hereto that the Wendy's Purchaser has decided to add to the Desired 365 Contracts List (the "Additional Desired 365 Contracts"). Attached hereto as Exhibit B is the final Desired 365 Contracts List (the "Final Desired 365 Contracts List").

Objections to Added Contracts

Counterparties to the Additional Desired 365 Contracts listed on Exhibit A hereto designated by the Wendy's Purchaser for assumption and assignment in the Extended Determination Period in accordance with Section 2.02 of the Wendy's Purchase Agreement shall have **seven (7) days** to object to adequate assurance and/or the assumption and assignment of the applicable Desired 365 Contract in connection with the Sale Transaction (each, a "**Contract Objection**"). Contract Objections must: (i) be in writing, (ii) comply with the applicable provisions of the Bankruptcy Rules and Local Rules, (iii) state with particularity the legal and factual basis for the objection and the specific grounds therefor, and (iv) be filed with the Bankruptcy Court, via ECF, on or prior to **March 18, 2021 at 5:00 p.m. (CT)** (the "**Objection Deadline**").⁴

If no such objections are filed with the Bankruptcy Court and served on the Debtors and the Wendy's Purchaser by the Objection Deadline in accordance with paragraph GG of the Wendy's Sale Order, then the Debtors may proceed with the assumption and assignment of the applicable Desired 365 Contract to the Wendy's Purchaser, and the terms of the Wendy's Sale Order shall govern such assumption and assignment.

IF NO CONTRACT OBJECTION IS TIMELY RECEIVED WITH RESPECT TO ASSUMPTION AND ASSIGNMENT OF A DESIRED 365 CONTRACT: (I) THE COUNTERPARTY TO SUCH DESIRED 365 CONTRACT SHALL BE DEEMED TO HAVE CONSENTED TO THE ASSUMPTION BY THE DEBTORS AND ASSIGNMENT TO THE WENDY'S PURCHASER, AND BE FOREVER BARRED FROM ASSERTING ANY OBJECTION WITH REGARD TO SUCH ASSUMPTION AND ASSIGNMENT (INCLUDING, WITHOUT LIMITATION, WITH RESPECT TO THE CURE AMOUNT AND ADEQUATE ASSURANCE OF FUTURE PERFORMANCE BY THE WENDY'S PURCHASER); (II) ANY AND ALL DEFAULTS UNDER THE DESIRED 365 CONTRACT AND ANY AND ALL PECUNIARY LOSSES RELATED THERETO SHALL BE DEEMED CURED AND COMPENSATED PURSUANT TO BANKRUPTCY CODE SECTION 365(B)(1)(A) AND (B) UPON PAYMENT OF THE CURE AMOUNT SET FORTH IN THIS NOTICE FOR SUCH DESIRED 365 CONTRACT; AND (III) THE CURE AMOUNT SET FORTH HEREIN SHALL BE CONTROLLING, NOTWITHSTANDING ANYTHING TO THE CONTRARY IN SUCH DESIRED 365 CONTRACT OR ANY OTHER RELATED DOCUMENT, AND THE COUNTERPARTY

SHALL BE DEEMED TO HAVE CONSENTED TO THE CURE AMOUNT AND SHALL BE FOREVER BARRED FROM ASSERTING ANY OTHER CLAIMS RELATED TO SUCH DESIRED 365 CONTRACT AGAINST THE DEBTORS AND THEIR ESTATES OR THE WENDY'S PURCHASER.
