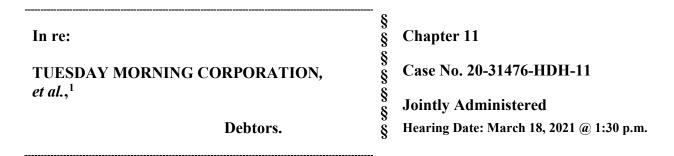

SUPPLEMENTAL DECLARATION OF TERO JÄNNE IN SUPPORT OF THE SECOND MONTHLY, FIRST INTERIM, AND FINAL FEE APPLICATION OF PJ SOLOMON, L.P. AND PJ SOLOMON SECURITIES, LLC FOR ALLOWANCE OF COMPENSATION FOR SERVICES RENDERED AND FOR REIMBURSEMENT OF EXPENSES INCURRED AS FINANCIAL ADVISOR AND INVESTMENT BANKER TO THE OFFICIAL COMMITTEE OF EQUITY SECURITY HOLDERS FOR THE PERIOD FROM OCTOBER 8, 2020 THROUGH AND INCLUDING DECEMBER 31, 2020

- I, Tero Jänne, under penalty of perjury, declare as follows:
- 1. I am a Managing Director of PJ Solomon, L.P. and PJ Solomon Securities, LLC ("PJ Solomon"), which has its principal office at 1345 Avenue of the Americas, 31st Floor, New York, New York 10105. I am authorized to make this supplemental declaration (this "Supplemental Declaration"), pursuant to §§ 328, 330(a), and 331 of title 11 of the United States Code, §§ 101 et seq. (the "Bankruptcy Code"), Rule 2016-1(c) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and Rule 2016 and Appendix F, "Guidelines for Compensation and Reimbursement of Professionals in Chapter 11 Cases," appended to the local rules for the United States Bankruptcy Court for the Northern District of Texas (the "Local").

Bankruptcy Rules"), as modified by the Order Authorizing PJ Solomon, L.P. and PJ Solomon Securities, LLC As Financial Advisor and Investment Banker To The Official Committee of Equity Security Holders Effective As Of October 8, 2020 [Docket No. 1722] (the "Retention Order"), and in support of the Second Monthly, First Interim, and Final Fee Application of PJ Solomon, L.P. and PJ Solomon Securities, LLC for Allowance of Compensation for Services Rendered and for Reimbursement of Expenses Incurred as Financial Advisor and Investment Banker to the Official Committee of Equity Security Holders for the Period from October 8, 2020 through and Including December 31, 2020 [Docket No. 2067] (the "Fee Application")² filed on February 15, 2021 by PJ Solomon, L.P. and PJ Solomon Securities, LLC ("PJ Solomon"), requesting final approval and allowance of compensation for services rendered and reimbursement of expenses incurred as Financial Advisor and Investment Banker to the Official Committee of Equity Security Holders (the "Committee") appointed in the chapter 11 cases of the above-captioned debtor and debtors-in-possession for the period from October 8, 2020 through and including December 31, 2020 (the "Final Application Period").

- 2. Except as otherwise noted, I have personal knowledge of the facts set forth herein and, if called as a witness, I would testify thereto.
- 3. As stated in the Fee Application, PJ Solomon requests the entry of an order regarding all fees and expenses incurred in this matter as actual, reasonable, and necessary. In addition to the total amounts specified in the Fee Application, PJ Solomon has expended additional actual, reasonable, and necessary expenses in the amount of \$17,501.20 incurred in connection with the preparation of the Fee Application. A summary of expenses incurred during the Compensation Period is attached hereto as **Exhibit A**. These expenses were incurred in accordance with the *Application Of The Official Committee of Equity Security Holders Pursuant*
