**ORDER SUSTAINING THE LIQUIDATING TRUSTEE'S FIRST OMNIBUS
OBJECTION TO CERTAIN PROOFS OF CLAIM (DUPLICATE CLAIMS,
LATE FILED CLAIMS AND AMENDED CLAIMS)**

[Relates to Docket No. 795]

Upon the objection (the “Objection”)² of the Liquidating Trustee for entry of an order (this “Order”) sustaining the *Liquidating Trustee’s First Omnibus Objection to Certain Proofs of Claim (Duplicate Claims, Late Filed Claims, and Amended Claims)*, all as more fully set forth in the Objection; and the Court having reviewed the Declaration; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and it appearing that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and it appearing that the Court may enter a final order consistent with Article III of the United States Constitution; and it appearing that venue of this proceeding and the Objection in this district is proper pursuant to 28 U.S.C. § 1408; and it appearing that the relief requested in the Objection is in the best interests of the Debtors’ estates, their creditors, and other parties in interest; and it appearing that the Debtors’ notice of the Objection and opportunity for a hearing on the Objection were appropriate under the

circumstances and no other notice need be provided; and the Court having reviewed the Objection; and the Court having held a hearing on the Objection; and all objections, if any, to the Objection have been withdrawn, resolved, or overruled; and the Court having determined that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is **HEREBY ORDERED THAT:**

1. Each of the Duplicate Claims identified on **Schedule 1** attached to this Order is disallowed in its entirety; provided, further, that the Liquidating Trustee reserves his right to object to any proof of claim identified in the “Surviving Claim” column of **Schedule 1** attached to this Order on any additional applicable grounds.

2. Each of the Late Filed Claims identified on **Schedule 2** attached to this Order is disallowed in its entirety; provided that Claim 294 is disallowed in its entirety as a Late Filed Claim and the original claim it purports to amend, Claim 150, is allowed in the amount of \$20,500.

3. Each of the Amended Claims identified on **Schedule 3** attached to this Order is disallowed in its entirety; provided, further, that the Liquidating Trustee reserves his right to object to any proof of claim identified in the “Surviving Claim” column of **Schedule 3** attached to this Order on any additional applicable grounds.

4. Epiq Corporate Restructuring, LLC, as claims and noticing agent, is authorized and directed to update the claims register maintained in these chapter 11 cases to reflect the relief granted in this Order.

5. With respect to any response filed regarding any Objected Claim, each such Objected Claim, and the Objection as it pertains to such Objected Claim, constitute a separate

contested matter as contemplated by Bankruptcy Rule 9014. This Order shall be deemed a separate order with respect to each Objected Claim.

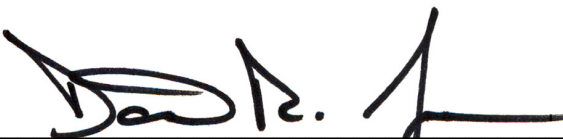
6. Notwithstanding the relief granted in this Order and any actions taken pursuant to such relief, nothing in this Order shall be deemed: (a) an admission as to the validity of any prepetition claim against a Debtor; (b) a waiver of the Liquidating Trustee's right to dispute any prepetition claim on any grounds; (c) a promise or requirement to pay any prepetition claim; (d) an implication or admission that any particular claim is of a type specified or defined in the Objection or any order granting the relief requested by the Objection; (e) a request or authorization to assume any prepetition agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; or (f) a waiver of the Liquidating Trustee's rights under the Bankruptcy Code or any other applicable law.

7. Notwithstanding Bankruptcy any applicability of Bankruptcy Rules 6004(h), 7062, or 9014, the terms and conditions of this Order are immediately effective and enforceable upon its entry.

8. The Liquidating Trustee is authorized to take such action necessary to effectuate the relief granted in this Order.

9. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
