**ORDER REGARDING THE REORGANIZED DEBTORS' THIRD OMNIBUS  
OBJECTION (NON-SUBSTANTIVE) TO CERTAIN CLAIMS  
(Duplicate Claims)  
[Docket No. 2088]**

The Court has considered the *Reorganized Debtors' Third Omnibus Objection (Non-Substantive) to Certain Claims (Duplicate Claims)* (the "Objection")<sup>2</sup>, filed by Tuesday Morning

Corporation and its debtor affiliates, as debtors and debtors-in-possession in the above-referenced chapter 11 cases (collectively, the “Reorganized Debtors”); and the Court having jurisdiction to consider the Objection and the relief requested therein pursuant to 28 U.S.C. § 1334, and the *Order of Reference of Bankruptcy Cases and Proceedings Nunc Pro Tunc*, Miscellaneous Rule No. 33 (N.D. Tex. August 3, 1984); and consideration of the Objection and the requested relief being a core proceeding pursuant to 28 U.S.C. § 157(b); and it appearing that venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Objection having been provided, and it appearing that no other or further notice need be provided; and the Court having reviewed the Objection; and all objections, if any, to the Objection having been withdrawn, resolved, or overruled; and the Court having determined that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and upon all of the proceedings had before the Court and after due deliberation and sufficient cause appearing therefor,

**IT IS HEREBY ORDERED THAT**

1. The Objection is SUSTAINED to the extent set forth herein with respect to the Disputed Claims shown on Exhibit 1.
2. The Disputed Claims shown on Exhibit 1 to this Order are hereby disallowed in their entirety and expunged from the official claim register.
3. This Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order to the extent permitted by applicable law.
