PLEASE TAKE FURTHER NOTICE that the hearing at which the Court will consider approval of the Disclosure Statement and Confirmation of the Plan (the "Combined Hearing") will commence on May 25, 2021 at 10:00 a.m., prevailing Eastern Time, before the Honorable Laurie Selber Silverstein, in the United States Bankruptcy Court for the District of Delaware.
