JOINT STIPULATION AND AGREED ORDER (I) AUTHORIZING THE ISSUANCE OF CERTAIN SURETY BONDS AND (II) GRANTING RELATED RELIEF

This joint stipulation and agreed order (this "Stipulation and Agreed Order") is made and entered into by and among (a) Gulfport Energy Corporation and the other debtors in possession in the above-captioned chapter 11 cases (the "Debtors") and (b) Everest Reinsurance Company ("Everest"). The Debtors, together with Everest, are collectively referred to herein as "Parties." The Parties hereby stipulate and agree as follows:

RECITALS

WHEREAS, on November 13, 2020 (the "Petition Date"), each of the Debtors filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the Southern District of Texas (the "Court"). The Debtors' chapter 11 cases are being jointly administered for procedural

purposes. The Debtors continue to operate their businesses and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code;

WHEREAS, prior to the Petition Date, certain of the Debtors entered into various payment and indemnity agreements and/or related agreements with Everest, pursuant to which certain surety bonds² were issued;

WHEREAS, following the Petition Date, the Debtors continued to maintain such surety bonds;

WHEREAS, on April 27, 2021, the Court entered the *Order (I) Confirming the Amended Joint Chapter 11 Plan of Reorganization of Gulfport Energy Corporation and its Debtor Subsidiaries* [Docket No. 1262] (the "Confirmation Order"), pursuant to which the Debtors assumed certain surety bonds (the "Existing Surety Bonds")³ issued by, amongst other sureties, Everest; and

WHEREAS, the Parties wish to enter into additional payment and indemnity agreements, pursuant to which new surety bonds (the "New Surety Bonds") shall be issued by Everest, as set forth on **Exhibit 1** attached to this Stipulation and Agreed Order, and the New Surety Bonds shall replace the related Existing Surety Bonds (as detailed on **Exhibit 1**) (the "Prior Surety Bonds").

THEREFORE, IT IS HEREBY STIPULATED AND AGREED, AND UPON APPROVAL BY THE COURT OF THIS STIPULATION AND AGREED ORDER, IT IS SO ORDERED as follows:

A list of the relevant surety bonds is attached as **Exhibit 1** to the *Order (I) Approving Continuation of the Surety Bond Program and (II) Granting Related Relief* [Docket No. 121].

³ A list of the Existing Surety Bonds is set forth on **Exhibit D** to the Confirmation Order.

- 1. The Debtors are hereby authorized to enter into any transactions relating to the posting of the New Surety Bonds, as set forth on **Exhibit 1** attached to this Stipulation and Agreed Order, which shall replace the Prior Surety Bonds, which shall be released in their entirety. For the avoidance of doubt, all other Assumed Surety Bonds set forth on **Exhibit D** to the Confirmation Order shall remain in full force and effect, and the New Surety Bonds shall constitute Assumed Surety Bonds, as defined in the Confirmation Order.
- 2. The Reorganized Debtors shall post additional collateral in the amount of \$5.1 million to Everest on account of the Existing Surety Bonds, reimbursement for attorneys' fees and the fees of consultants, and past due premiums relating to the Prior Surety Bonds and Assumed Surety Bonds (the "Additional Collateral").
- 3. The Reorganized Debtors shall pay premiums for all Assumed Bonds issued by Everest in the ordinary course of business.
- 4. Following the posting of the Additional Collateral, Everest shall withdraw with prejudice any and all proofs of claim arising from or related to the Existing Surety Bonds.
- 5. The Parties have agreed that the Debtors shall only be required to post \$500,000 as collateral for the issuance of the New Surety Bonds, and the Parties agree that Everest may not require any additional collateral from the Reorganized Debtors for a period of two (2) years following the Effective Date on account of the New Surety Bonds (the "Collateral Demand Holiday"). For the avoidance of doubt, except for the Collateral Demand Holiday, the Reorganized Debtors reaffirm all obligations to Everest under the Agreement of Indemnity it executed on January 21, 2020. The Collateral Demand Holiday shall cease and terminate if a claim is made under any of the Assumed Surety Bonds, including the New Surety Bonds; *provided* that notwithstanding the foregoing, the Collateral Demand Holiday shall not cease and terminate if a

claim is made under any of the Remaining Surety Bonds, as defined in the Confirmation Order.

Upon receiving a claim, Everest shall have all rights under the Agreement of Indemnity, including

the right to demand collateral acceptable to Everest. In the absence of any claims, the Collateral

Demand Holiday shall self-terminate on May 15, 2023 and upon such termination, Everest shall

all rights under the Agreement of Indemnity, including the right to demand collateral acceptable

to Everest.

6. Except as expressly provided herein, nothing contained in this Stipulation and

Agreed Order or any actions taken by the Debtors or Everest pursuant to relief granted in this

Stipulation and Agreed Order shall be construed as a waiver or limitation of the rights of the

Debtors or Everest under the Bankruptcy Code or any other applicable law.

7. The terms and conditions of this Stipulation and Agreed Order shall be effective

and immediately enforceable upon its entry by the Clerk of the Court.

8. The Parties are authorized to take all actions necessary to effectuate the relief

granted in this Stipulation and Agreed Order.

9. This Court retains exclusive jurisdiction with respect to all matters arising from or

related to the implementation, interpretation, and enforcement of this Stipulation and Agreed Order

to the maximum extent allowed by law under the applicable circumstances.
