**NOTICE TO CERTAIN DRIVER CLAIMANTS OF
DEADLINE TO CLARIFY PREVIOUSLY SUBMITTED
SETTLEMENT FORM AND ASSERT AN ADMINISTRATIVE CLAIM**

PLEASE TAKE NOTICE that, on January 29, 2021, the Honorable David R. Jones, United States Bankruptcy Judge for the United States Bankruptcy Court for the Southern District of Texas, signed the *Findings of Fact, Conclusions of Law, and Order Confirming Second Amended Joint Chapter 11 Plan of NPC International, Inc. and Its Affiliated Debtors* [Docket No. 1528], confirming the *Second Amended Joint Chapter 11 Plan of NPC International, Inc. and Its Affiliated Debtors* [Docket No. 1477] (as supplemented and amended, the “**Plan**”).² On April 1, 2021, the Debtors filed the *Notice of (I) Entry of Order Confirming Joint Chapter 11 Plan of NPC International Inc. and Its Affiliated Debtors, (II) Occurrence of Effective Date, (III) Administrative Expense Claim Bar Date, and (IV) Driver Claimant Admin Bar Date* [Docket No. 1643]. All administrative claims must have been filed by May 17, 2021 (the “**Driver Claimant Administrative Claim Bar Date**”).

PLEASE TAKE FURTHER NOTICE that pursuant to the settlement between NPC International, Inc. (“NPC”) and certain delivery drivers of NPC as memorialized in Section 5.2(c) of the Plan,³ certain delivery drivers may be compensated based on miles driven while delivering pizza from July 1, 2020 through March 31, 2021 (the “**Administrative Claim Period**”). To be compensated for the Administrative Claim Period, delivery drivers needed to complete both the settlement form and file an administrative expense proof of claim form (the “**Administrative Expense Claim Form**”) by the Driver Claimant Administrative Claim Bar Date.

You are receiving this notice because you completed a settlement form but did not file an Administrative Expense Claim Form before the Driver Claimant Administrative Claim Bar Date even though you worked as a delivery driver for NPC during the Administrative Claim Period. Based on the information you sent it is unclear if you intended to file only a settlement form and not an Administrative Expense Claim Form. To be reimbursed for costs during the Administrative Claim Period you must complete both forms. Recipients of this notice will be able
