SUPPLEMENTAL DECLARATION OF MATTHEW PASCUCCI IN SUPPORT OF DEBTORS' APPLICATION FOR ORDER PURSUANT TO SECTIONS 105(a) AND 363(b) OF THE BANKRUPTCY CODE (I) AUTHORIZING THE DEBTOR TO RETAIN MACKINAC PARTNERS, LLC TO PROVIDE THE DEBTORS WITH A CHIEF RESTRUCTURING AND RELATED SERVICES, NUNC PRO TUNC TO THE PETITION DATE AND (II) APPROVING THE AGREEMENT RELATED THERETO

- I, Matthew Pascucci, hereby declare:
- 1. On June 5, 2020, I submitted my declaration (the "<u>Initial Declaration</u>") in support of the *Debtors' Application for Order Pursuant to Sections 105(a) and 363(b) of the Bankruptcy Code (I) Authorizing the Debtor to Retain Mackinac Partners, LLC to Provide the Debtors with a Chief Restructuring and Related Services, Nunc Pro Tunc to the Petition Date and (II) Approving the Agreement Related Thereto* (the "<u>Application</u>") [Docket No. 123],<sup>2</sup> seeking Court approval of the Debtors' retention and employment of Mackinac Partners, LLC ("<u>Mackinac</u>") to provide Chief Restructuring Officer ("<u>CRO</u>") and related services.
- 2. On June 29, 2020, the Court entered the Order Granting Debtors' Application for Order (I) Authorizing the Debtors to Retain Mackinac Partners, LLC to Provide the Debtors with

A Chief Restructuring Officer and Related Services, Nunc Pro Tunc to the Petition Date and (II) Approving the Agreement Related Thereto [Docket No. 304] (the "Mackinac Retention Order").

- 3. I submit this declaration to supplement the Initial Declaration as follows:
- 4. In May of 2021, Mackinac was acquired by Accordion Partners LLC ("Accordion"). As a result of the acquisition, Mackinac now operates as a subsidiary of Accordion.
- 5. Accordion and Mackinac provide similar services, including financial and operational consulting services.

### MACKINAC'S DISINTERESTEDNESS

- 3. In connection with the acquisition, Accordion undertook to determine (a) whether it had any relationships that might cause Mackinac not to be disinterested or to hold or represent an interest adverse to the Debtors and (b) all "connections" (as such term is used in Bankruptcy Rule 2014) to the Debtors, their creditors, other parties in interest, the United States Trustee or any person employed in the Office of the United States Trustee.
- 4. To the best of my knowledge, information, and belief, neither Accordion nor any employee of Accordion is a creditor, an equity holder, or an insider of the Debtors. To the best of my knowledge, information and belief, neither Accordion nor any employee of Accordion is or was, within two (2) years before the Petition Date, a director, an officer, or an employee of the Debtors. Also, neither Accordion nor any Accordion employee will assist the Debtors in these chapter 11 cases nor are they related or connected to any United States Bankruptcy Judge for the District of Delaware, the U.S. Trustee, or any persons employed in the office of the U.S. Trustee.
- 5. To check potential relationships and connections in these chapter 11 cases, Accordion searched its client database to determine whether it had any relationship or
