**TWENTY-EIGHTH OMNIBUS OBJECTION TO CERTAIN PROOFS OF CLAIM
(NO LIABILITY—ROYALTY CLAIMS)**

The Debtors filed their Twenty-Eighth Omnibus Objection to certain Proofs of Claim (No Liability—Royalty Claims) (the “Objection”). This matter is a core proceeding pursuant to 28 U.S.C. § 157(b)(2) and this Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334. The Court may enter a final order consistent with Article III of the United States Constitution and the Court finds that venue of this proceeding and this Objection in this district is permissible pursuant to 28 U.S.C. §§ 1408 and 1409. After considering the Objection, any responses to the Objection, and any arguments or evidence presented at any hearing on the Objection, IT IS ORDERED THAT
