**NOTICE REGARDING TWENTY-THIRD DISTRIBUTION PURSUANT TO  
THE MODIFIED THIRD AMENDED JOINT CHAPTER 11 PLAN OF  
LEHMAN BROTHERS HOLDINGS INC. AND ITS AFFILIATED DEBTORS**

As previously disclosed, additional Distributions under the *Modified Third Amended Joint Chapter 11 Plan of Lehman Brothers Holdings Inc. and Its Affiliated Debtors*, dated December 5, 2011 [ECF No. 23023],<sup>1</sup> will commence on October 7, 2021 (the “Twenty-Third Distribution Date”).

Attached hereto as Exhibit A is a list that indicates the percentage recovery that Lehman Brothers Holdings Inc. will distribute to holders of Allowed Claims as well as the cumulative percentage recovery distributed to holders of Allowed Claims in each Class under the Plan (other than secured, administrative or priority claims). The amounts on Exhibit A exclude the “Final Distributions” made pursuant to the *Order Authorizing Final Distribution for Certain Creditors of Lehman Brothers Holdings Inc. and Granting Related Relief*, dated July 1, 2021 [ECF No. 61161].

Attached hereto as Exhibit B is a summary of the aggregate amount of Allowed Claims eligible for Distributions on the Twenty-Third Distribution Date, listed by Plan Class. In aggregate, approximately 4,350 creditors which represent 84% of all record holder creditors of Lehman Brothers Holdings Inc. will receive a Final Distribution on the Twenty-Third Distribution Date.

<sup>1</sup> Capitalized terms used herein shall have the meanings ascribed to them in the plan.

The aggregate amount that will be distributed on the Twenty-Third Distribution Date will total approximately \$122.5 million, including approximately \$8.4 million in Final Distributions.
