**ORDER GRANTING MOTION FOR AN ORDER AUTHORIZING FINAL
DISTRIBUTION TO HOLDERS OF ALLOWED CLASS 5 CCG UNSECURED CLAIM
AND CLASS 7 GENERAL UNSECURED CLAIMS UNDER THE CONFIRMED PLAN**

Considering the Motion for an Order Authorizing Final Distribution to Holders of Allowed Class 5 CCG Unsecured Claim and Class 7 General Unsecured Claims Under the Confirmed Plan [P-1221] (“Motion”) filed by Clifford Zucker, the Plan Administrator (“Plan Administrator”) which was scheduled for hearing on December 14, 2021; jurisdiction over the matters in the Motion is proper pursuant to 28 U.S.C. § 157(b) and 1334, and Sections 105 and 1142 of the Bankruptcy Code; venue is proper in this Court pursuant to 28 U.S.C. §§ 1408 and 1409; proper and adequate notice of the Motion has been provided and no further notice is needed; the relief sought in the Motion is in the best interests of the Debtors’ estate, creditors, and all parties-in-interest; no objections to the Motion have been filed; and good and sufficient cause exists for granting the relief requested in the Motion,

IT IS ORDERED that the Plan Administrator is authorized to make a final distribution of the remaining Unsecured Distribution² in the amount of \$2,295,863 in accordance with the
