STIPULATION BY AND BETWEEN DEBTORS AND PICKENPACK ENTITIES REGARDING ALLOWANCE, SOLICITATION AND VOTING OF CLAIMS IN THE DEBTORS' CHAPTER 11 PLANS OF REORGANIZATION

This stipulation ("Stipulation") is entered into by and between the Debtors and

Pickenpack Entities² (collectively the "Parties"):

WHEREAS, on September 27, 2021, the Debtors filed two (2) separate plans of reorganization, each as may be further amended or modified:

(i) First Amended Joint Chapter 11 Plan of Reorganization of China Fishery Group Limited (Cayman), Pacific Andes Resources Development Limited (Bermuda), and

(BVI), Golden Target Pacific Limited (BVI), Pacific Andes International Holdings (BVI) Limited, Zhonggang Fisheries Limited (BVI), Admired Agents Limited (BVI), Chiksano Management Limited (BVI), Clamford Holding Limited (BVI), Excel Concept Limited (BVI), Gain Star Management Limited (BVI), Grand Success Investment (Singapore) Private Limited, Hill Cosmos International Limited (BVI), Loyal Mark Holdings Limited (BVI), Metro Island International Limited (BVI), Mission Excel International Limited (BVI), Natprop Investments Limited, Pioneer Logistics Limited (BVI), Sea Capital International Limited (BVI), Shine Bright Management Limited (BVI), Superb Choice International Limited (BVI), Toyama Holdings Limited (BVI) and Pacific Andes Enterprises (Hong Kong) Limited ?).

- Certain of Their Affiliated Entities (the "CFGL-PARD Plan") [ECF No. 2684-1]; and
- (ii) First Amended Joint Chapter 11 Plan of Reorganization of Pacific Andes International Holdings Limited (Bermuda) and Certain of Its Affiliated Debtors (the "PAIH Plan") [ECF No. 2685-1].

(The CFGL-PARD Plan and the PAIH Plan as the "Plans")

WHEREAS, the Pickenpack Entities have timely filed proofs of claims (collectively, the "Pickenpack Letters of Comfort Claims") as against the Debtors' estates with respect to those certain Letters of Comfort, dated as of December 14, 2012 and June 12, 2015, issued by PAIH in favor of the Pickenpack Entities, respectively, including all agreements, notes, instruments, and any other documents delivered pursuant thereto or in connection therewith (in each case, as amended, restated, modified, or supplemented from time to time prior to the Petition Date) (the "Pickenpack Letters of Comfort") (A schedule of the Pickenpack Letters of Comfort Claims are annexed hereto as Schedule 1, as may be further modified, supplemented and amended by agreement of the parties); and

WHEREAS, in furtherance of the Debtors' Plans, the Parties have agreed on the allowance of the Pickenpack Letters of Comfort Claims for purposes of the PAIH Plan only;

WHEREAS, the Parties have agreed that, for purpose of the Plans only, the Pickenpack Entities shall have a single Allowed Claim with respect to the Pickenpack Letters of Comfort

Claims in the sum of USD \$27,428,571.43 as against the PAIH Debtors which shall be classified as a Class 11 Allowed Claim of the PAIH Plan; and

WHEREAS, the Debtors and the Pickenpack Entities now enter into this Stipulation to set forth, for avoidance of doubt, the solicitation and voting procedures as they relate to the Pickenpack Letters of Comfort Claims.

NOW THEREFORE, the Parties hereby stipulate and agree as follows:

- 1. For purposes of the Plans only, the Pickenpack Letters of Comfort Claims shall be Allowed in the sum of USD \$27,428,571.43 as against the PAIH Debtors and classified as a Class 11 Claim under the PAIH Plan.
- 2. For purposes of the Plans only, the Pickenpack Entities shall be served with and complete a single voting ballot in the amount of USD \$27,428,571.43 as a Class 11 claimant under the PAIH Plan (the "Pickenpack Ballot"), which vote shall be tabulated and applied to each of the PAIH Plan Debtors under Class 11. Unless otherwise agreed to by the parties to this Stipulation, the Pickenpack Ballot shall list each of the Pickenpack Entities as holders of the Pickenpack Ballot.
- 3. For purposes of the Plans only, all remaining Pickenpack Letters of Comfort Claims (the "Remaining Pickenpack Claims"), including without limitation those claims asserted against the CFGL Plan Debtors and the PARD Plan Debtors, shall by agreement be temporarily disallowed only for voting purposes pursuant to Rule 3018(a) of the Federal Rules of Bankruptcy Procedure.
- 4. Upon the Effective Date (as defined therein) of the PAIH Plan and the completion of the distributions to the Pickenpack Entities in accordance with the PAIH Plan, the Remaining Pickenpack Claims shall be forever waived, released and expunged. In the

event of the non-occurrence of the Effective Date, this Stipulation will be of no effect and will cease to be binding between the Parties, and the Parties reserve all rights, and no such rights shall be deemed waived hereunder, including the Pickenpack Entities' rights to prosecute the allowance of the full amounts as filed of the Pickenpack Letter of Comfort Claims.

- 5. This Stipulation may be executed in any number of counterparts by the Parties on different counterpart signature pages, all of which taken together shall constitute one and the same Stipulation. Any of the Parties may execute this Stipulation by signing any such counterpart and each of such counterparts shall for all purposes be deemed an original. This Stipulation may be executed by facsimile, PDF, and/or e-mail, and such execution shall have the same force and effect as an original signature.
- 6. The persons executing this Stipulation on behalf of the respective Parties acknowledges and agrees that they have full authority to execute and enter into this Stipulation on behalf of the respective parties.
- 7. Nothing contained herein shall be deemed to amend or modify the Plans, or the Parties' rights thereunder, except as specifically stated herein. For the avoidance of doubt, this

- Stipulation addresses only the allowance, solicitation and voting procedures as they relate to the Pickenpack Letters of Comfort Claims for purposes of the Plans.
- 8. This Stipulation shall be effective upon being countersigned by the Parties and So Ordered by the Bankruptcy Court.
- 9. A person who is not a party, including any successor or assigns of the parties to this Stipulation, shall have no rights under this Stipulation to enforce or to enjoy the benefit of any term of this Stipulation.
- 10. This Court shall retain jurisdiction with respect to the effect, enforcement, amendment or modification of this Stipulation, including any request for additional relief in or related to this Stipulation.
- 11. Except to the extent that the Bankruptcy Code or other federal law is applicable, the rights, duties and obligations arising under this Stipulation shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, without giving effect to the principles of conflicts of law thereof.
