APPELLANT LAWRENCE M. MEADOWS' STATEMENT OF ISSUES ON APPEAL AND DESIGNATION OF ITEMS TO BE INCLUDED IN THE RECORD

Pursuant to Fed. R. Bankr. P. 8006 and Local Bankr. R. 8007-1, the Appellant Lawrence M. Meadows ("Meadows") hereby files his Statement of Issues on Appeal and Designation of Items to be Included in the Record, for his Notice of Appeal (Doc 13449) of Bankruptcy Court's "Order Signed On 11/29/2021 (I) Authorizing (A) Release Of Excess Reserve Funds Held In Disputed Claims Reserve And (B) Reimbursement Of Pre-Petition Claim; (II) Closing The Chapter 11 Case; And (III) Granting Related Relief" (Doc 13408), and "Memorandum Of Decision Signed On 2/7/2022, Re: Motion To Reconsider Filed By Lawrence M. Meadows" (Doc 13441).

I. Issues Presented

Meadows respectfully request this honorable Court reconsider its Closing Order (Doc 13408) because of the Courts' combined inadvertence, mistake, and abuse of discretion, which were in violation of the Code and the Plan.

1. Did the Bankruptcy Court err by ignoring the fact that there are unresolved contested matters, consisting of two pending Appeals related to this Court's EEOC Consent Decree Order (Doc 12912) and recent Estimation Order for EEOC Proof of Claim ("EEOC POC) No. 9676 (Doc 13361), which may have material adverse impact on the amount of the final distribution of

the Disputed Claims Reserve ("DRC"); thereby, leaving the Plan not yet fully administered in violation of the U.S. Bankruptcy Code Section 350(a) and Fed R BNKR P Rule 3022?

- A. Was the Court's Estimation Amount unreasonable, because it was based upon an EEOC Consent Decree which is not effective and may never be effective, and upon a proof of claim that would never be allowed at the Estimated Amount?
- B. Did the Court fail to Consider the probability of success on the merits of Meadows' pending appeals of the EEOC Consent Decree, which would render the Estimated EEOC Proof of Claim No.9676 and the associated settlement amount used for Estimation invalid, and otherwise leave an unliquidated POC which would bar a final DCR distribution?
- 2. Did the Bankruptcy Court err in allowing a premature American Airlines' "Labor Distribution" of 23.6%, based on the disputed \$9.95M estimated amount of EEOC POC No. 9676, which is not currently an allowed claim, and will never actually be paid if the Debtor's prevail on the pending appeals of this Court's disputed Consent Decree Order, which is wholly inconsistent with the terms of the Debtors' Bankruptcy Plan?
- 3. Did the Bankruptcy Court err by abusing its discretion when it deprived of his due process rights in these proceedings, by treating Meadows with bias and hostile animus, when it prejudicially denied him the opportunity to argue in opposition to Debtr's Closing Motion during the November 4th, 2021 hearing, when he attempted to expose how the American "Labor" distribution violated the Debtors' Bankruptcy Plan?
- 5. Did the Bankruptcy Court err by asserting Meadows' did not have standing with respect to American Airlines' "Labor Union Distribution", despite him at all times being at all times

being treated as a unionized pilot employee, i.e., a Labor Distributee who received multiple share distributions from Debtors' Dispute Claims Reserve ("DRC")?

6. Did the Bankruptcy Court err by depriving Meadows and American's 240 other similarly situated potentially aggrieved disabled pilots of their constitutional right to due process and notice throughout these proceedings in violation of their 4th and 15th Amendments Rights?
