Dear Claimholder:

As you are aware, Grupo Aeroméxico, S.A.B. de C.V. and certain of its affiliates (collectively, “**Aeroméxico**” or the “**Debtors**”) commenced a voluntary reorganization under Chapter 11 of the United States Bankruptcy Code (the “**Cases**”), on June 30, 2020, in the United States Bankruptcy Court for the Southern District of New York (the “**Court**”). The Cases are being administered under Case Number 20-11563 (SCC).

Epiq Corporate Restructuring, LLC (“**Epiq**”) has been appointed by the Court to act as Aeroméxico’s Claims and Noticing Agent.

As a holder of a claim (a “**Claimholder**”) that may receive a distribution in the Cases (the “**Distribution**”), Epiq previously sent you a distribution form (the “**Distribution Form**”), which is reattached to this letter as Exhibit A for your convenience.¹
