STIPULATION AND ORDER REGARDING ASSUMPTION OF EXECUTORY CONTRACTS WITH ACUREN INSPECTION, INC.

The above captioned debtors and debtors in possession (collectively, the "**Debtors**"), Strike Holdco, LLC (f/k/a Strike Acquisition, LLC) (the "**Purchaser**"), and Acuren Inspection, Inc. ("**Acuren**," and together with the Debtors and the Purchaser, the "**Parties**"), by and through their undersigned counsel, hereby stipulate and agree as follows and, upon entry by the United States Bankruptcy Court for the Southern District of Texas, Houston Division (the "**Court**"), it shall be found and ordered as follows (this "**Stipulation and Order**"):

RECITALS

WHEREAS, on December 6, 2021 (the "Petition Date"), the Debtors filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code") with the Court commencing these chapter 11 cases (the "Chapter 11 Cases");

WHEREAS, the Debtors are operating their business and managing their properties as debtors-in-possession pursuant to section 1107(a) and 1108 of the Bankruptcy Code;

The Debtors in these chapter 11 cases, along with the last four digits of each Debtor's federal tax identification number, are: Strike, LLC (2120); STH ShellCo LLC (f/k/a Strike HoldCo, LLC) (0607); Delta Directional Drilling, LLC (9896); SGH ShellCo LLC (f/k/a Strike Global Holdings, LLC) (4661); CIS ShellCo LLC (f/k/a Capstone Infrastructure Services, LLC) (0161); and Crossfire, LLC (7582). The location of Debtor Strike, LLC's principal place of business and the Debtors' service address is: 1800 Hughes Landing Boulevard., Suite 500, The Woodlands, Texas 77380. Additional information regarding this case may be obtained on the website of the Debtors' claims and noticing agent at https://dm.epiq11.com/StrikeLLC.

WHEREAS, the Debtors and Enterprise Products Operating, LLC were party to that certain Pipeline Construction Contract No. 11438 dated October 27, 2020 and the Debtors and South Texas NGL Pipelines, LLC, were party to that certain Pipeline Construction Contract No. 11439 dated October 27, 2020 (collectively, the "Enterprise Contracts") (together, Enterprise Products Operating, LLC and South Texas NGL Pipelines, LLC, are referred to herein as "Enterprise") by which the Debtors agreed to provide certain services related to the projects commonly known as Enterprise Segment B, South Texas 12" Ethylene and 8" PHP Segment B Pipeline DCVG (the "Projects").

WHEREAS, Acuren and Strike, LLC are parties to that certain Master Services Agreement dated September 3, 2015 (the "MSA").

WHEREAS, prior to the Petition Date, Strike, LLC and Acuren executed Subcontract Order 9008161 (the "Purchase Order"), which was issued under the MSA, for Acuren to provide 175 miles of DCVG surveying and other deliverables for the Projects as set forth in the Purchase Order (the "Work").

WHEREAS, before the Petition Date, Acuren performed services contemplated under the Purchase Order and submitted four invoices to Strike, LLC for an aggregate amount of \$734,480.00 (the "Invoices").

WHEREAS, Strike disputes that the invoiced amounts are owed under the MSA and Purchase Order.

WHEREAS, on January 28, 2022, the Court entered the Order (I) Authorizing and Approving the Sale of Substantially All of the Debtors' Assets Free and Clear of All Liens, Claims, Encumbrances, and Interests; (II) Authorizing the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases in Connection Therewith; (III) Authorizing

the Sale Transaction; and (IV) Granting Related Relief [Dkt. No. 588] (the "Sale Order");² which among other things approved the sale of substantially all of the Debtors' assets and the assumption and assignment of certain executory contracts and unexpired leases set forth on Schedule 1 to the Sale Order (the "Assigned Contracts") to the Purchaser or one of its affiliates.

WHEREAS, pursuant to the Sale Order, each of the Enterprise Contracts were designated as an Assigned Contract.

WHEREAS, on February 4, 2022, Acuren timely filed Proofs of Claim Nos. 361³ and 10570 (the "Acuren POCs"), asserting a claim against Strike, LLC for "not less than \$776,955.02."

WHEREAS, on or about February 16, 2022, Acuren filed four liens against the Projects in Matagorda, Calhoun, Jackson, and Brazoria Counties, Texas (collectively, the "Outstanding Liens") and demanded payment from Enterprise for the amounts set forth in the Invoices under Sections 56.002, 56.023, and 56.041 of the Texas Property Code.

WHEREAS, Acuren has outstanding performance obligations under the MSA.

WHEREAS, the Parties have agreed, following good-faith arms'-length negotiations, to resolve all outstanding disputes existing as of the Effective Date (as defined below) with respect to the MSA, Purchase Order, Acuren POCs, Outstanding Liens, and Work on the terms and conditions set forth in this Stipulation and Order.

² Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Sale Order.

Claim No. 361 is also identified as Claim No. 100 in the claims register available on the Court's ECF system.

STIPULATION AND ORDER

NOW, THEREFORE, it is hereby stipulated and agreed to by and among the Parties and, upon being "so ordered" by the Court, it is hereby ordered, as follows:

- 1. Upon the execution of this Stipulation and Order by the Parties (the "Effective Date"), Acuren shall immediately recommence any Work necessary to complete any required deliverables and provide any required deliverables, in conformance with the expectations and requirements of the MSA and Purchase Order, no later than 10 calendar days following the Effective Date.
- 2. Upon the occurrence of the Effective Date, Acuren shall immediately and affirmatively release in connection with the Outstanding Liens any lien rights or other rights of recovery against Enterprise, the Projects, or any other property subject to the Work and execute and deliver any documents required to remove any claims, notices, or lien filings made by Acuren with respect to the Work or Projects as agreed to by the Parties.
- 3. Following completion of the Work and Enterprise's acceptance of the deliverables under the Purchase Order, the MSA and Purchase Order shall be designated as Assigned Contracts pursuant to the Sale Order and shall be assumed by Strike, LLC and assigned to the Purchaser (or one of its affiliates) pursuant to section 365 of the Bankruptcy Code with an agreed Cure Amount of \$250,000 as of the Effective Date (the "Agreed Cure Amount").
- 4. As soon as practicable, and in no event later than two (2) business days following completion of the Work and Enterprise's acceptance of the deliverables under the Purchase Order (such date of payment of the Agreed Cure Amount, the "Cure Date"), the Purchaser shall pay the Agreed Cure Amount to Acuren via ACH payment. The Debtors shall not be liable for any portion of the Agreed Cure Amount.

- 5. Acuren stipulates that other than the Agreed Cure Amount, no other outstanding sums are or will be due under the Purchase Order and the MSA with respect to the Work or Projects.
- 6. The payment of the Agreed Cure Amount constitutes a cure of all defaults and all amounts owed by the Debtors to Acuren under the MSA and Purchase Order as of the Effective Date and is sufficient for the Debtors to comply with the requirements of sections 365(b)(1) of the Bankruptcy Code.
- 7. Upon the payment of the Agreed Cure Amount, (a) each Party shall be deemed to have unconditionally and irrevocably released, waived, and discharged, each other Party, including each of their directors, officers, employees, and affiliates, from any and all claims, obligations, rights, suits, damages, causes of action, remedies, known or unknown, foreseen or unforeseen, existing or arising prior to the execution of this Stipulation and Order, in law, equity, or otherwise, solely to the extent based on or arising from the MSA, the Purchase Order, the Work, or the Invoices prior to the Effective Date; *provided*, *however*, that, nothing in this paragraph 7 shall release Acuren from any warranty or indemnity obligations owed under the MSA and Purchase Order with respect to the Work; and (b) the Debtors, the Purchaser, and each of their successors or assigns shall be deemed to have unconditionally and irrevocably release and waived any and all claims, rights or causes of action for avoidance, recovery, subordination or other relief arising under chapter 5 of the Bankruptcy Code or applicable state fraudulent conveyance, fraudulent transfer, or similar Laws they may hold against Acuren.
- 8. Following the payment of the Agreed Cure Amount, the Acuren POCs shall be deemed satisfied, and the Debtors shall be authorized to expunge the Acuren POCs from the claims register in these Chapter 11 Cases. Acuren agrees not to file any claim or otherwise seek any

recovery from the Debtors on account of the Invoices, the MSA or the Purchase Order with respect

to the Work or Projects.

9. The terms and conditions of this Stipulation and Order are immediately effective

and enforceable upon its entry. This Stipulation and Order shall be enforceable against the Debtors

during these Chapter 11 Cases, any subsequent converted Chapter 7 Case of any Debtor under

Chapter 7 of the Bankruptcy Code, and after the dismissal of any Chapter 11 Case.

10. Nothing in this Stipulation and Order shall constitute an admission by any of the

Parties.

11. The Court retains exclusive jurisdiction with respect to all matters arising from or

related to the implementation, interpretation, and enforcement of this Stipulation and Order. Any

request for relief brought before the Court to resolve a dispute arising from or related to this

Stipulation and Order, and the matters agreed to herein, shall be brought on proper notice and in

accordance with the relevant Federal Rules of Bankruptcy Procedure and the Local Bankruptcy

Rules for the Southern District of Texas.
