Hearing appearances must be made electronically in advance of both electronic and in-person hearings. To make your appearance, click the "Electronic Appearance" link on Judge Jones's home page. Select the case name, complete the required fields and click "Submit" to complete your appearance.

The above-captioned debtors and debtors in possession (collectively, the "**Debtors**") file the following Supplement (the "**Supplement**") to the *Debtors' Emergency Application for Entry of an Order Appointing Epiq Corporate Restructuring, LLC as Claims, Noticing, Solicitation, and Administrative Agent* [Docket No. 7] (the "**Epiq Retention Application**") and state as follows:

1. Paragraph 1 of the Epiq Retention Application references a *Declaration of Deanna* Osborne in Support of Chapter 11 Petitions and Requests for First Day Relief under the defined term "First Day Declaration."² The First Day Declaration is intended to be the *Declaration of W*. Marc Schwartz in Support of Voluntary Petitions and First Day Motions [Docket No. 9] (the "Schwartz Declaration").

2. Any reference to the First Day Declaration in the Epiq Retention Application and any documents attached thereto shall mean the Schwartz Declaration.

3. Additionally, the Declaration of Kate Mailloux in Support of Debtors' Emergency Application for Entry of an Order Appointing Epiq Corporate Restructuring, LLC as Claims, Noticing, Solicitation, and Administrative Agent (the "Mailloux Declaration") filed with the Epiq Retention Application makes reference to a list of all known potential parties in interest ("Schedule 1") and a list of all potential parties in interest connected to Epiq ("Schedule 2"). Schedule 1 and Schedule 2 are attached to this Supplement.

A copy of the Supplement will also be made available on the Debtor's case information website located at https://dm.epiq11.com/ConsolidatedWealth. A separate one-page Notice of the filing of this Supplement shall be posted on the Epiq website and make reference to the existence of the Supplement for all other parties in interest, including any investors. The Debtors submit that, considering the nature of the relief requested, no other or further notice need be given.
