2021 [ECF No. 904] (the “**Omnibus Claims Hearing Procedures**”), the undersigned hereby certifies as follows:

1. Responses to the *Debtors’ Thirty-Fourth Omnibus Claims Objection to Proofs of Claim (Satisfied, Set Amount, Incorrectly Classified, No Liability, Reduced, Foreign Currency, Insufficient Documentation, Misclassified Unliquidated, and/or Late Filed Claims)* [ECF No. 2813] (the “**Objection**”), filed on March 17, 2022 by Grupo Aeroméxico, S.A.B. de C.V. and its affiliates that are debtors and debtors in possession the debtors (collectively, the “**Debtors**”)<sup>2</sup> in the above-captioned chapter 11 cases (the “**Chapter 11 Cases**”), were due no later than April 18, 2022 at 4:00 p.m. (prevailing Eastern Time) (the “**Response Deadline**”).

2. The Case Management Order, the Omnibus Claims Hearing Procedures, and Local Rule 9075-2 provide that pleadings may be granted without a hearing if (a) no objections or other responsive pleadings have been filed on or before the applicable deadline and (b) the attorney for the entity that filed the pleading complies with the relevant procedural and notice requirements.

3. As of the filing of this certificate, the Response Deadline has passed and, to the best of my knowledge, no objection or responsive pleading to the Objection has been (a) filed with the Court on the docket of the Chapter 11 Cases or (b) served in accordance with the Omnibus Claims Hearing Procedures.

4. In addition, the Debtors received informal comments from certain parties to the Objection. Those comments are reflected in the revised schedules (the “**Revised Schedules**”) attached to the proposed order attached hereto as **Exhibit A** (the “**Order**”). A blackline of the

1409; and consideration of the Objection and the relief requested therein being a core proceeding that the Court can determine pursuant to 28 U.S.C. § 157(b)(2); and due and proper notice of the Objection and opportunity for a hearing on the Objection having been given to the parties listed therein, and it appearing that no other or further notice need be provided; and the Court having reviewed and considered the Objection; and the Court having the opportunity to hold a hearing on the Objection; and the Court having determined that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and the Court having found that the relief granted herein being in the best interests of the Debtors, their creditors, and all other parties in interest; and upon all of the proceedings had before the Court; and after due deliberation and sufficient cause appearing therefor,

**IT IS HEREBY ORDERED THAT:**

1. The Objection is hereby granted as set forth herein.
2. The Satisfied Claims identified on Schedule 1 annexed hereto are hereby disallowed and expunged in their entirety.
3. The Set Amount Claim identified on Schedule 2 annexed hereto is hereby modified as set forth in Schedule 2.
4. The Incorrectly Classified Claim identified on Schedule 3 annexed hereto is hereby reclassified as described in the corresponding row labeled “Modified Claim” on Schedule 3 and, to the extent reclassified by this Order, shall not be considered a secured, administrative, and/or priority Claim, as applicable, for any purpose in the Chapter 11 Cases.
5. The No Liability Claims identified on Schedule 4 annexed hereto are hereby disallowed and expunged in their entirety.

6. The Reduced Claims identified on Schedule 5 annexed hereto are hereby modified as described in the corresponding row labeled “Modified Claim” on Schedule 5.

7. The Foreign Currency Claim identified on Schedule 6 annexed hereto is hereby modified as described in the corresponding row labeled “Modified Claim” on Schedule 6.

8. The Insufficient Documentation Claims identified on Schedule 7 annexed hereto are hereby disallowed and expunged in their entirety.

9. The Misclassified Unliquidated Claims identified on Schedule 8 annexed hereto are hereby modified as described therein such that the Misclassified Unliquidated Claims shall not be considered unliquidated for any purpose in the Chapter 11 Cases.

10. The Late Filed Claim identified on Schedule 9 annexed hereto is hereby disallowed and expunged in its entirety.

11. To the extent applicable, all Claims listed on the Schedules annexed hereto that were not asserted in United States dollars are hereby modified to be Claims listed in United States dollars, as described in the respective Schedules attached hereto.

Any stay of this Order pending appeal by any claimants whose Claims are subject to this Order shall only apply to the contested matter that involves such claimant and shall not act to stay the applicability and/or finality of this Order with respect to the other contested matters listed in the Objection or this Order.

13. The Debtors, Epiq Corporate Restructuring, LLC, and the Clerk of this Court are authorized to take, or refrain from taking, any action necessary or appropriate to implement the terms of, and the relief granted in, this Order without seeking further order of the Court.

14. Notwithstanding any Bankruptcy Rule, the Local Bankruptcy Rules for the Southern District of New York, or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

15. This Court shall retain jurisdiction to hear and determine all matters arising from, arising under, or related to the Chapter 11 Cases, to the fullest extent permitted by law, including, without limitation, to enforce this Order.
