As you may know, ION Geophysical and certain of our U.S.-based entities initiated a voluntary Chapter 11 process in the U.S. Bankruptcy Court for the Southern District of Texas on April 12, 2022. This process is intended to improve our capital structure, right-size the business and achieve a more stable financial position in response to the COVID-19 pandemic and pivot towards energy transition that have resulted in shrinking exploration budgets.

As part of the process, we are required to distribute certain legal documents during the case. Enclosed you will find one of those documents, the Notice of Commencement (NOC). The NOC simply informs recipients of the Chapter 11 filing and provides additional information about the case. These notices are typical of the process and are required to be sent to various stakeholders, including clients, current and former employees, and vendors, among others. You may continue to receive notices like these as the case progresses.
