**ORDER GRANTING THE LIQUIDATING TRUSTEE’S SIXTH OMNIBUS  
OBJECTION TO THE ALLOWANCE OF CERTAIN CLAIMS**  
**(Duplicative, Reclassified, Insufficient Documentation, and No Liability Claims)**

This matter is before the Court on the Liquidating Trustee’s Sixth Omnibus Objection to the Allowance of Certain Claims (Duplicative, Reclassified, Insufficient Documentation, and No Liability Claims) [Docket No. 1180] (the “Objection”) dated March 25, 2022. Capitalized terms used, but not defined, in this Order shall have the meanings ascribed to such terms in the Objection.

The Court has considered the Objection and the matters reflected in the record of these bankruptcy cases. It appears that the Court has jurisdiction over this proceeding; that this is a core proceeding; that no further notice is necessary; that no objections have been filed to the relief sought in the Objection; that the relief sought in the Objection is in the best interests of the Debtors, their estates, and their creditors; and that good and sufficient cause exists for such relief.

Accordingly, it is hereby ORDERED, ADJUDGED, and DECREED as follows:

1. The Objection is GRANTED as set forth herein.
2. The Claims that are the subject of the Objection are hereby reclassified or disallowed as requested on Exhibit A to the Objection.
3. The Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order.
