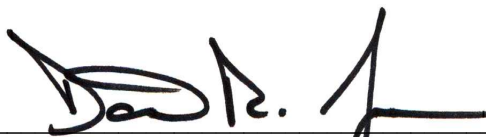
ORDERED THAT:

1. The deadline for filing objections to claims under the *First Amended Chapter 11 Plan of Reorganization, as Immaterially Modified as of January 28, 2019* [Docket No. 451] is extended through and including December 1, 2022.
