## **Notes to the Monthly Operating Report**

## General:

On May 23, 2022 (the "Petition Date"), Christian Care Centers, Inc. filed a voluntary petition with the United States Bankruptcy Court under Chapter 11 of the Bankruptcy Code [Case No.: 22-80000], along with its affiliate Christian Care Centers Foundation, Inc., [Case No.: 22-80001] (last 4 digits of taxpayer identification number 3572).

Debtor-in-Possession Financial Statements - The accompanying schedules have been prepared on an accrual basis and are unaudited, preliminary, and may not comply with generally accepted accounting principles in the United States of America ("U.S. GAAP") in all material respects.

The Monthly Operating Report is limited in scope, covers a limited time period, and has been prepared solely for the purpose of complying with the monthly reporting requirements of the Bankruptcy Court and the United States Trustee. The information presented herein has not been subjected to all procedures that would typically be applied to financial information presented in accordance with U.S. GAAP. Upon the application of such procedures, the financial information could be subject to changes, and these changes could be material.

Reservation of Rights: Given the complexity of the Debtors' business, inadvertent errors, omissions or over inclusions may have occurred. Accordingly, the Debtors hereby reserve all of their rights to dispute the validity, status, enforceability, or executory nature of any claim amount, representation or other statement in this Monthly Operating Report and reserve the right to amend or supplement this Monthly Operating Report, if necessary, but shall be under no obligation to do so.

Part 1, Sections b,c and f represent receipts and disbursement excluding Debtor to Debtor transfers. The actual end of month cash balance, section d, is \$7,721,105.61.

All payments made on behalf of prepetition debts were paid pursuant to First Day Orders (Part 7, section a).

Interest expense and DIP Accrued Interest includes \$150,000 of original issue discount incurred under the DIP Bond.

Payment to Wipfli LLP was inadvertently made but the motion to pay ordinary course professional will filed shortly that includes Wipfli (Part 5, section b and Part 7, section h).

In lieu of a traditional worker's compensation policy (Part 7, Section I), the Debtor has an Occupation Accident Policy which remains on full force and effect.

The Debtor entered into a DIP Financing Trust Indenture with UMB Bank, N.A. dated May 22, 2022 [doc. 15]. See Part 7g of Questionnaire.

The Debtors do not keep separate financial statements for the Foundation. Therefore, \$316,451.77 of investments held in brokerage accounts in the name of Foundation is presented on the Christian Care Centers, Inc.'s balance sheet, but not included in Part 2: Asset and Liability Status because it is reported on the Foundation monthly operating report in that section.

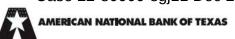
