NOTICE OF REMOVAL OF CONTRACT FROM PROPOSED ASSUMPTION AND
ASSIGNMENT

PLEASE TAKE NOTICE OF THE FOLLOWING:

1. On May 8, 2022 (the “**Petition Date**”), Armstrong Flooring, Inc. and certain of its affiliates, the debtors and debtors-in-possession in the above-captioned cases (collectively, the “**Debtors**,” the “**Company**,” or “**AFI**”), each filed voluntary petitions for relief pursuant to chapter 11 of title 11 of the United States Code (the “**Bankruptcy Code**”) in the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”).

2. On May 13, 2022, the Debtors filed a motion (the “**Motion**”)² seeking, among other things, (a) entry of an order (the “**Bidding Procedures Order**”) approving the bidding procedures (the “**Bidding Procedures**”) for the sale or disposition of certain or all of the Debtors’ assets (the “**Assets**”) in one or more sale transactions pursuant to Bankruptcy Code section 363 (each, a “**Sale Transaction**” and collectively, the “**Sale**”); (b) establishing procedures for the Debtors to designate a stalking horse bidder (the “**Stalking Horse Bidder**”) and to enter into a stalking horse agreement (a “**Stalking Horse Agreement**”) containing bid protections; (c) establishing certain dates and deadlines for the Sale process, including scheduling (i) an auction of the Assets (the “**Auction**”), if any, in accordance with the Bidding Procedures, and (ii) the hearing with respect to the approval of the Sale (the “**Sale Hearing**”); (d) approving procedures for the assumption and assignment of certain executory contracts and unexpired leases (the “**Assumption Procedures**”); and (iv) approving the form and manner of notice of the Sale [Docket No. 141].

3. On May 31, 2022, the Bankruptcy Court entered the Bidding Procedures Order [Docket No. 233]. Pursuant to the Bidding Procedures Order, the Debtors were authorized to, and

did, provide notice of their intent to assume and assign to a Successful Bidder or Successful Bidders with respect to a given Sale Transaction certain executory contracts or unexpired leases.

4. The Bidding Procedures Order further authorized the Debtors to provide notice of the removal of one or more executory contracts or unexpired leases from those to be assumed and assigned to a Successful Bidder or Successful Bidders.

5. On July 11, 2022, the Debtors filed a Notice of Proposed Sale Orders [Docket No. 540] (the “Proposed Sale Orders”) which sought approval of three value-maximizing sale transactions (the “Sales Transactions”): (i) a partial going-concern sale (the “North America Sale”) of their North American Assets to AHF, LLC and Gordon Brothers Commercial & Industrial, LLC through a transaction that will preserve a substantial number of jobs; (ii) a going-concern sale (the “Australia Sale”) of the Debtors’ Australia business to Braeside Mills Investments Pty Ltd, Gippsland Lakes Victoria Holdings Pty Ltd and HS Mc Kendrick Family Nominees Pty Ltd as trustee of the Mills Unit Trust; and (iii) a going-concern sale (the “China Sale”) of the Debtors’ equity in their China business to Zhejiang Gimig Technology Co., Ltd.

6. On July 12, 2022, the Sale Hearing was held before the Honorable Mary F. Walrath, United States Bankruptcy Judge, in the Bankruptcy Court. At the Sale Hearing, the Debtors sought the Bankruptcy Court’s approval of the Proposed Sale Orders. Objections, if any, to the Successful Bidder’s modification(s) of the form of sale order appended to the Motion were due at the Sale Hearing.

7. At the Sale Hearing, the Court indicated that it would approve the Proposed Sale Orders, subject to certain revisions discussed during the Sale Hearing being incorporated in the Proposed Sale Orders. Consistent with the record of the Sale Hearing, the Debtors revised the Proposed Sale Orders (the “Revised Proposed Sale Orders”).

8. On July 12, 2022, the Debtors filed the Revised Proposed Sale Orders [Docket No. 546].

9. On July 13, 2022 the Court entered the *Order (A) Approving the Sale of Certain of the Debtors’ Assets Free and Clear of All Liens, Claims, Encumbrances, and Other Interests; (B) Approving the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases Related Thereto; and (C) Granting Related Relief* for the North America Sale [Docket No. 549].

10. On July 13, 2022 the Court entered the *Order (A) Approving the Sale of Certain of the Debtors’ Assets Free and Clear of All Liens, Claims, Encumbrances, and Other Interests; (B) Approving the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases Related Thereto; and (C) Granting Related Relief* for the Australia Sale [Docket No. 550].

11. On July 13, 2022 the Court entered the *Order (A) Approving the Sale of Certain of the Debtors’ Assets Free and Clear of All Liens, Claims, Encumbrances, and Other Interests; (B) Approving the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases Related Thereto; and (C) Granting Related Relief* for the China Sale [Docket No. 551].

12. **Notice is hereby given that the Debtors no longer intend to assume and assign to a Successful Bidder the executory contracts or unexpired leases listed on Exhibit A hereto.**

13. **The Debtors reserve all rights in respect of the executory contracts or unexpired leases listed on Exhibit A hereto, including without limitation their rights to assume, assume and assign, or reject, such executory contracts or unexpired leases, to dispute whether such contracts or leases are in fact executory, and to seek any other relief in respect thereof.**
