PLEASE TAKE NOTICE OF THE FOLLOWING:

Please Take Notice that on June 2, 2022 the (“Petition Date”), Home Products International, Inc., and its related debtor in the above-captioned cases (collectively, the “Debtors”) filed voluntary petitions for chapter 11 bankruptcy relief under title 11 of the United States Code (the “Bankruptcy Code”) in the United States Bankruptcy Court for the Northern District of Illinois, Eastern Division (the “Court”). The Debtors are managing their respective property as debtors in possession under §§ 1107(a) and 1108 of the Bankruptcy Code.

General Bar Date: October 17, 2022 at 4:00 p.m. (prevailing Central time)

As ordered by the Court, all persons and entities (each a “Creditor” and, collectively the “Creditors”), holding or wishing to assert prepetition unsecured or secured claims (as defined in § 101(5) of the Bankruptcy Code) or administrative expense claims under § 503(b)(9) of the Bankruptcy Code against any Debtor arising or accruing before the Petition Date (each a “Claim” and collectively, the “Claims”) must file a separate, completed and executed proof of Claim (either the proof of claim form enclosed here, a form confirming substantially to Official Bankruptcy Form 410, or another appropriate proof of administrative expense Claim) (each a “Form” and collectively the “Forms”) on account of each such Claim on or before **October 17, 2022 at 4:00 p.m. (prevailing Central time)** (the “General Bar Date”).

Governmental Bar Date: November 29, 2022 at 4:00 p.m. (prevailing Central time)

All governmental units, as defined by § 101(27) of the Bankruptcy Code (the “Governmental Units”) holding or wishing to assert Claims against the Debtors are required to file a separate, completed and executed Form, as described above, on account of each Claim by any

Governmental Unit holds or wishes to assert against any Debtor on or before **November 29, 2022 at 4:00 p.m. (prevailing Central time)** (the “Governmental Bar Date”).

Rejection Claim Bar Date

Except as otherwise set forth in any order authorizing the rejection of an executory contract or unexpired lease, the latest of: (a) the General Bar Date, (b) thirty (30) days after the date of the entry of any order authorizing the rejection of such executory contract or unexpired lease, or (c) thirty (30) days after the effective date of the rejection of such executory contract or unexpired lease, including pursuant to Bankruptcy Code section 365(d)(4), is the date by which a Proof of Claim Form relating to the Debtors’ rejection of such executory contract or unexpired lease must be filed (the “Rejection Claim Bar Date”).

Amended Schedules Bar Date

The later of (i) the General Bar Date, or (ii) 4:00 p.m. (prevailing Central Time) on the first date that is thirty (30) calendar days after the date that a claimant is served with notice that the Debtors have supplemented and/or amended their Schedules and/or Statements of Financial Affairs (collectively, the “Schedules”), is the deadline by which claimants holding a Claim that is affected by such supplement and/or amendment to file a proof of claim with respect to such Claim (the “Amended Schedules Bar Date”).

At this time, proofs of Claim **are not required** to be filed by Creditors holding or wishing to assert Claims against the Debtors of the following types (collectively, the “Excluded Claims”):

- a. Any Entity (i) that agrees with the nature, classification, and amount of his, her, or its Claim as set forth in the Schedules, and (ii) whose Claim against the Debtors is not listed as “disputed”, “contingent”, or “unliquidated” in the Schedules;
- b. Any Entity that has already properly filed a proof of claim against the Debtors;
- c. Any Entity asserting a Claim allowable under Bankruptcy Code sections 503(b) and 507(a)(2) as an administrative expense of the Chapter 11 Cases (other than any 503(b)(9) Claim);
- d. Any Entity whose Claim against the Debtors previously has been allowed by, or paid pursuant to, an order of the Court;
- e. Any current employee of the Debtors on account of any Claim the Court has authorized the Debtors to honor in the ordinary course of business as a wage, commission, or benefit, provided however, that a current employee must submit a Proof of Claim by the General Bar Date for all other Claims arising before the Petition Date, including Claims, if any, for wrongful termination, discrimination, harassment, hostile work environment, and

retaliation and Claims covered by the Debtors' workers compensation insurance; and

f. Any Debtor with respect to its Claims against another Debtor.

If the Court fixes a date in the future, after the General Bar Date, by which time any of the Excluded claims must be filed, you will be notified.

EXHIBIT C

United States Bankruptcy Court

These instructions and definitions generally explain the law. In certain circumstances, such as bankruptcy cases that debtors do not file voluntarily, exceptions to these general rules may apply. How to fill out this form

- **If the claim has been acquired from someone else, then state the identity of the last party** who owned the claim or was the holder of the claim and who transferred it to you before the initial claim was filed.

Understand the terms used in this form

Administrative expense: Generally, an expense that arises after a bankruptcy case is filed in connection with operating, liquidating, or distributing the bankruptcy estate. 11 U.S.C. § 503.

Claim: A creditor's right to receive payment for a debt that the debtor owed on the date the debtor filed for bankruptcy. 11 U.S.C. § 101 (5). A claim may be secured or unsecured.

Creditor: A person, corporation, or other entity to whom a debtor owes a debt that was incurred on or before the date the debtor filed for bankruptcy. 11 U.S.C. § 101 (10).

Debtor: A person, corporation, or other entity who is in bankruptcy. Use the debtor's name and case number as shown in the bankruptcy notice you received. 11 U.S.C. § 101 (13).

Evidence of perfection: Evidence of perfection of a security interest may include documents showing that a security interest has been filed or recorded, such as a mortgage, lien, certificate of title, or financing statement.

Information that is entitled to privacy: A *Proof of Claim* form and any attached documents must show only the last 4 digits of any social security number, an individual's tax identification number, or a financial account number, only the initials of a minor's name, and only the year of any person's date of birth. If a claim is based on delivering health care goods or services, limit the disclosure of the goods or services to avoid embarrassment or disclosure of confidential health care information. You may later be required to give more information if the trustee or someone else in interest objects to the claim.

Priority claim: A claim within a category of unsecured claims that is entitled to priority under 11 U.S.C. § 507(a). These claims are paid from the available money or property in a bankruptcy case before other unsecured claims are paid. Common priority unsecured claims include alimony, child support, taxes, and certain unpaid wages.

Proof of claim: A form that shows the amount of debt the debtor owed to a creditor on the date of the bankruptcy filing. The form must be filed in the district where the case is pending.

Redaction of information: Masking, editing out, or deleting certain information to protect privacy. Filers must redact or leave out information entitled to **privacy** on the *Proof of Claim* form and any attached documents.

Secured claim under 11 U.S.C. § 506(a): A claim backed by a lien on particular property of the debtor. A claim is secured to the extent that a creditor has the right to be paid from the property before other creditors are paid. The amount of a secured claim usually cannot be more than the value of the particular property on which the creditor has a lien. Any amount owed to a creditor that is more than the value of the property normally may be an unsecured claim. But exceptions exist; for example, see 11 U.S.C. § 1322(b) and the final sentence of 1325(a).

Examples of liens on property include a mortgage on real estate or a security interest in a car. A lien may be voluntarily granted by a debtor or may be obtained through a court proceeding. In some states, a court judgment may be a lien.

Setoff: Occurs when a creditor pays itself with money belonging to the debtor that it is holding, or by canceling a debt it owes to the debtor.

Uniform claim identifier: An optional 24-character identifier that some creditors use to facilitate electronic payment.

Unsecured claim: A claim that does not meet the requirements of a secured claim. A claim may be unsecured in part to the extent that the amount of the claim is more than the value of the property on which a creditor has a lien.

Offers to purchase a claim

Certain entities purchase claims for an amount that is less than the face value of the claims. These entities may contact creditors offering to purchase their claims. Some written communications from these entities may easily be confused with official court documentation or communications from the debtor. These entities do not represent the bankruptcy court, the bankruptcy trustee, or the debtor. A creditor has no obligation to sell its claim. However, if a creditor decides to sell its claim, any transfer of that claim is subject to Bankruptcy Rule 3001(e), any provisions of the Bankruptcy Code (11 U.S.C. § 101 et seq.) that apply, and any orders of the bankruptcy court that apply.
