**ORDER GRANTING GUC TRUST'S MOTION FOR (I) APPROVAL OF
FINAL PAYMENT OF TRUST COSTS, TERMINATION OF THE GUC
TRUST, AND DISCHARGE OF GUC TRUSTEE AND OVERSIGHT
COMMITTEE AND (II) ENTRY OF FINAL DECREE CLOSING
REMAINING CHAPTER 11 CASE
(Related Docket No. 1802)**

Upon the motion (the "Motion")² of Drivetrain, LLC, in its capacity as Trustee (the "GUC Trustee") of the Ignite Restaurant Group GUC Trust (the "GUC Trust") seeking entry of an order (this "Order"), (i) approving of (a) the final payment of Trust Costs, (b) the termination of the Trust, and (c) the discharge of the GUC Trustee and the Oversight Committee, and (ii) entry of the Final Decree closing the remaining Lead Debtor chapter 11 case, it is **HEREBY ORDERED THAT:**

1. The Motion is GRANTED as set forth herein.
2. Upon payment of final Trust Costs, the GUC Trust shall terminate under the terms of the GUC Trust Agreement, and the GUC Trustee shall be discharged from all duties under the Plan and GUC Trust Agreement without further order of this Court.

¹ The Debtor in this chapter 11 case and the last four digits of its federal tax identification number is: Ignite Restaurant Group, Inc. (1359). The remaining Debtor cases were closed by an order of the Court entered on December 10, 2019 [Docket No. 1776].

² Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Objection.

3. Upon the termination of the GUC Trust, the GUC Trustee, the Oversight Committee, and their professionals shall be discharged from all liability to the trust, Beneficiaries and all Persons for acts or omissions in the GUC Trustee's capacity or Oversight Committee's capacity contemplated by the GUC Trust Agreement or the Plan. Having complied with the obligations under the Plan, the GUC Trust Agreement, and the Confirmation Order, the GUC Trustee, the Oversight Committee, and its professionals, agents and personnel are not liable to the holder of any Claim or Interest or to any other Person regarding their performance under the GUC Trust Agreement, the Plan, the Confirmation Order, or applicable law.

4. Notwithstanding the termination of the GUC Trust, the GUC Trustee is authorized and directed to take any action that is necessary to effectuate the post-termination administration of the GUC Trust. Such authorized and directed actions by the GUC Trustee include, but are not limited to, performing the duties necessary to complete the administration of the GUC Trust, reviewing and signing tax returns for the GUC Trust, and authorizing counsel to resolve any matters including payment of fees and expenses of professionals and service providers.

5. Notwithstanding entry of this Order closing the remaining Lead Debtor chapter 11 case, (i) all remaining GUC Trust Assets transferred to and vested in the GUC Trust pursuant to the Plan, Confirmation Order, and GUC Trust Agreement shall remain and continue as GUC Trust Assets; and (ii) the GUC Trustee (and its successors and assigns) shall continue to have full authority vested in the GUC Trustee pursuant to the Plan, Confirmation Order, and GUC Trust Agreement, including but not limited to and without further order of the Court, to: (a) sell (including but not limited to one or more remnant or residual asset sales, which sales shall continue to be free and clear of all Claims, Liens, Liabilities, encumbrances, charges, and other interests as set forth in the Plan and Confirmation Order), liquidate, abandon, or otherwise dispose of all

remaining GUC Assets, including, not but limited to, any unknown assets or claims or later-discovered assets or claims that may constitute remnant or residual assets purchased by Oak Point Partners, LLC, (b) make further Distributions (if any) contemplated under the Plan, (c) pay GUC Trust expenses, and (d) administer the GUC Trust until terminated.

6. The bankruptcy case for Debtor Ignite Restaurant Group, Inc., Case No. 17-33550 (DRJ), shall be and hereby is closed.

7. The Clerk of the Court shall enter this Order and Final Decree on the docket of Case No. 17-33550 (DRJ), and such docket shall be marked as “Closed.”

8. The GUC Trustee, no later than thirty days after the date of entry of the Final Decree, shall file any outstanding operating or post-confirmation reports and a post-confirmation report for the 3rd quarter of 2022 through the date of entry of the Final Decree and shall serve a true and correct copy of said statements on the United States Trustee (the “U.S. Trustee”).

9. The GUC Trustee shall pay any outstanding quarterly fees and shall pay the quarterly for the 3rd quarter of 2022 when due and payable and pay subsequent quarters when due and payable under 28 U.S.C. § 1930(a)(6)(A) and (B) by either (1) remitting payment to the United States Trustee Payment Center, PO Box 6200-19, Portland, OR 97228-6200, which payment shall reflect the Debtors account numbers and shall be transmitted with a “Chapter 11 Quarterly Fee Payment” coupon available from the United States Trustee; or (2) by remitting payment via the pay.gov website: <http://www.pay.gov/public/form/start/672415208>, using the ten digit case number for each payment, no later than thirty days after the date of entry of the Final Decree. Debtors shall furnish evidence of such payment to the United States Trustee by email to Henault, Brian R. (USTP) Brian.R.Henault@usdoj.gov. This Court shall retain jurisdiction to

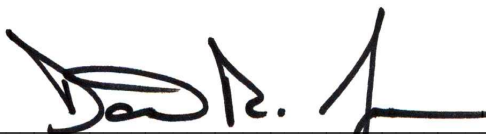
enforce payment of fees assessed under 28 U.S.C. § 1930(a)(6)(A) and (B). This Court retains jurisdiction to enforce payment of fees assessed under 28 U.S.C. § 1930(a)(6)(A) and (B).

10. The terms and conditions of this Order will be immediately effective and enforceable upon its entry.

11. The GUC Trustee, the Claims Agent, and the Clerk of the Court are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Objection.

12. This Court shall retain exclusive jurisdiction to resolve any dispute arising from or related to this Order.
