SUPPLEMENTAL DECLARATION OF SARAH BAKER IN SUPPORT OF MOTION OF DEBTORS FOR INTERIM AND FINAL ORDERS (I)(A) CONFIRMING, ON AN INTERIM BASIS, THAT THE INVENTORY DISPOSITION AGREEMENT IS OPERATIVE AND EFFECTIVE AND (B) AUTHORIZING, ON A FINAL BASIS, THE DEBTORS TO ASSUME THE INVENTORY DISPOSITION AGREEMENT; (II) AUTHORIZING AND APPROVING INVENTORY AND FF&E SALES FREE AND CLEAR OF ALL LIENS, CLAIMS, AND ENCUMBRANCES; AND (III) GRANTING RELATED RELIEF

I, Sarah Baker, hereby declare under penalty of perjury that the following is true to the best of my knowledge, information and belief:

- 1. I am Vice President, Deputy General Counsel of Hilco Trading, LLC ("<u>Hilco Trading</u>"), the ultimate parent company of Hilco Merchant Resources, LLC ("<u>Hilco</u>"), located at 5 Revere Drive, Suite 206, Northbrook, Illinois.
- 2. I submit this supplemental declaration (the "Supplemental Declaration") on behalf of Hilco in support of the Motion of Debtors for Interim and Final Orders (I)(A) Confirming, on an Interim Basis, that the Inventory Disposition Agreement is Operative and Effective and (B) Authorizing, on a Final Basis, the Debtors to Assume the Inventory Disposition

Agreement; (II) Authorizing and Approving Inventory and FF&E Sales Free and Clear of all Liens, Claims, and Encumbrances; and (III) Granting Related Relief (D.I. 10) (the "Motion").

- 3. On September 19, 2022, the Declaration of Sarah Baker in Support of Motion of Debtors for Interim and Final Orders (I)(A) Confirming, on an Interim Basis, That the Inventory Disposition Agreement is Operative and Effective and (B) Authorizing, on a Final Basis, the Debtors to Assume the Inventory Disposition Agreement; (II) Authorizing and Approving Inventory and FF&E Sales Free and Clear of All Liens, Claims, and Encumbrances; and (III) Granting Related Relief (D.I. 94) (the "Original Declaration") was filed in support of the Motion
- 4. The facts set forth in this Supplemental Declaration are based upon my personal knowledge, information, and belief, and upon records kept in the ordinary course of business that were reviewed by me or other employees of Hilco Trading under my supervision and direction. If called as a witness, I would testify to the facts set forth in this Supplemental Declaration.
- 5. In the ordinary course of its business, Hilco Trading, Hilco and its affiliates and subsidiaries (collectively, "Hilco Global") maintain a database (the "Transaction Database") for purposes of performing "conflicts checks." The Transaction Database contains information regarding present and past representations and transactions of Hilco Global. I obtained a list of names of individuals and companies provided by the Debtors for purposes of searching the Transaction Database and determining the connection(s) which Hilco Global has with such entities (attached to the Original Declaration as Schedule 1; collectively, the "Parties in Interest"). Hilco ran the names of all of the Parties in Interest through the Transaction Database to determine whether Hilco Global had in the past, or currently has, any connection to such Parties in Interest. The Transaction Database includes information relating to debt and equity holdings of the entities

comprising Hilco Global (including debt and equity holdings by such entities for the account of a third party, if any). In short, if one of the entities comprising Hilco Global holds debt or equity in a Party in Interest, that connection would be identified in the conflicts check and disclosed. Moreover, the conflicts check conducted by Hilco in connection with the Motion, the Original Declaration and this Supplemental Declaration did not exclude any affiliates of Hilco or its ultimate parent company. Hilco's search of the Transaction Database identified the connections listed on and described in Schedule 2 attached to the Original Declaration.

- 6. I am submitting this Supplemental Declaration to (i) update Schedule 1 to the Original Declaration to include additional parties as reflected in <u>Schedule 1</u><sup>2</sup> attached hereto, which is a cumulative list of all parties in interest searched by Hilco either as part of the Original Declaration or this Supplemental Declaration; and (ii) make additional disclosures and update certain of the connections listed in Schedule 2 to the Original Declaration as follows:
  - a. Pursuant to the Streambank Retention Application, filed on October 5, 2022, the Debtors have engaged Hilco IP Services, LLC d/b/a Hilco Streambank ("Hilco Streambank"), an affiliate of Hilco, as the Debtors' intellectual property disposition consultant. Hilco has no ownership interest in Hilco Streambank, does not share officers or directors with Hilco Streambank, and maintains separate books, records, and financial statements and accounts.
  - b. In addition to the disclosures contained in my Original Declaration, Hilco provides asset monetization and disposition services to Target in matters wholly unrelated to the Debtors and these chapter 11 cases.
  - c. In addition to the disclosures contained in my Original Declaration, from time to time, Hilco and its affiliates have worked with and/or been represented by (i) Latham & Watkins LLP, (ii) Arent Fox LLP, (iii) Holland
