**ORDER (I) APPROVING SALE OF SUBSTANTIALLY ALL OF
THE DEBTORS' ASSETS AND (II) GRANTING RELATED RELIEF**

Upon the motion ("Motion") [Docket No. 142] of Fairport Baptist Homes ("FBH"), Fairport Baptist Homes Adult Care Facility Inc. ("FBH Adult Care"), FBH Community Ministries ("Community Ministries"), and FBH Distinctive Living Communities Inc. ("Distinctive Living") (FBH, FBH Adult Care, Community Ministries and Distinctive Living hereinafter collectively, the "Debtors" or "Debtors"), as debtors and debtors-in-possession in the above-captioned jointly administered Chapter 11 Case,¹ pursuant to Sections 105(a), 363, 365, 503 and 507 of the Bankruptcy Code and Bankruptcy Rules 2002, 6004, 6006 and 9014, for entry of an order approving the sale of substantially all of the Debtors' assets and other related relief, all as further set forth and defined in the Motion ("Sale Order"); and this Court having entered an order approving the bidding procedures for the Purchased Assets and granting certain related relief on August 11, 2022 [Docket No. 246] ("Bidding Procedures Order"); and the Debtors having filed the *Notice of Amended and Restated Asset Purchase Agreement* on August 23, 2022 [Docket No. 253]; and the Auction having been conducted on October 3, 2022 [*see* Docket No. 262]; and the Debtors having filed the *Post-Auction Notice of Prevailing and Back-Up Bidders* on

October 3, 2022 [Docket No. 263]; and the supportive declarations of Debtors' counsel filed collectively as the *Debtors' Supplement in Support of Sale to Prevailing Debtor* filed on October 12, 2022 [Docket No. 278]; and the *Notice of Filing of Declaration of David Katz, Esq.* filed on behalf of the Prevailing Bidder on October 14, 2022 [Docket No. 282]; and this Court having determined that the relief provided herein is in the best interest of the Debtors, their estates, creditors and other parties in interest; and due and adequate notice of the Motion having been given under the circumstances; and upon the record of the hearing on the Motion, and the full record of this Chapter 11 Case; and after due deliberation thereon; and good and sufficient cause appearing therefor,

THIS COURT HEREBY MAKES THE FOLLOWING FINDINGS OF FACT AND CONCLUSIONS OF LAW:²

A. **Jurisdiction and Venue.** This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157(b)(2)(A), (N) and (O) and 157 and 1334. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409. This matter is a “core” proceeding pursuant to 28 U.S.C. § 157(b)(2).

B. **Notice and Opportunity to Object.** Good and sufficient notice of the Motion and the relief sought therein has been given under the circumstances, and no other or further notice is required. A reasonable opportunity to object or be heard regarding the relief provided herein has been afforded to parties in interest with timely and proper notice of the Auction, the sale of the Purchased Assets, and the Bidding Procedures to be employed in connection therewith.

C. **Final Order.** This Sale Order constitutes a final and appealable order within the meaning of 28 U.S.C. § 158(a). Notwithstanding Bankruptcy Rules 6004(h) and 6006(d), the Court

expressly finds that there is no just reason for delay in the implementation of this Sale Order, and expressly directs entry of judgment as set forth herein.

D. **Sale is Appropriate.** The sale transaction ("Sale Transaction") pursuant to the Amended and Restated Asset Purchase Agreement with the Prevailing Bidder, 4646 Nine Mile Point Road LLC ("4646 APA"),³ is authorized pursuant to Section 363(b)(1) of the Bankruptcy Code and Bankruptcy Rule 6005(f). The Sale Transaction represents the sound business judgment of the Debtors and is appropriate in light of the facts and circumstances surrounding the Sale Transaction and the Debtors' Chapter 11 Case because: (i) the Debtors engaged in marketing efforts that were fair, proper, complete and reasonably calculated to result in the best value received for the Purchased Assets; (ii) the pool of potential acquirors was extremely limited, given the limited number of potential parties with both the financial ability and the wherewithal to obtain the regulatory approvals necessary to enter into a transaction like the contemplated Sale Transaction under the deadlines imposed in the Chapter 11 Case; (iii) the terms of the sale were negotiated at arm's length with the Prevailing Bidder and Official Committee of Unsecured Creditors; (iv) the Sale Transaction will provide a greater recovery for the Debtors' estates than would be provided by any other available alternative; and (v) it constitutes reasonably equivalent value (as those terms are defined in each of the Uniform Fraudulent Transfer Act, Uniform Fraudulent Conveyance Act, and Section 548 of the Bankruptcy Code) and fair consideration under the laws of the United States, any State, territory, possession or the District of Columbia. The record of these proceedings indicates that the Debtors face substantial financial losses and that absent a timely sale of the Purchased Assets, there is an imminent likelihood that the Debtors will promptly cease

to operate as a going concern, and that the value of the Debtors' assets, including the Purchased Assets, will be substantially diminished.

E. **Corporate Authority.** The Debtors have full corporate power and authority to proceed with the 4646 APA and execute all other documents contemplated thereby, and to consummate the Sale Transaction contemplated in connection therewith. The Sale has been duly and validity authorized by all necessary action. No consents or approvals other than those expressly provided for in the APA are required for the Debtors to consummate the Sale, APA or the Sale Transaction contemplated thereby.

F. **Business Justification.** The Debtors have: (i) articulated good, sufficient and sound business reasons for consummating the 4646 APA, the sale of the Purchased Assets and the Sale Transaction; (ii) appropriately exercised its business judgment by entering into the Sale Transaction; and (iii) demonstrated compelling circumstances for entry into the Sale Transaction pursuant to Section 363(b)(1) of the Bankruptcy Code, in that, among other things, the immediate approval by the Court of the Sale Transaction with the Prevailing Bidder is necessary and appropriate to maximize the value of the Debtors' estates.

G. **Best Interests.** Approval of the 4646 APA and the consummation of the Sale Transaction are in the best interests of the Debtors, their estates, creditors and other parties in interest.

H. **Highest or Otherwise Best.** As demonstrated by: (i) the record in this Chapter 11 Case; (ii) the testimony and/or other evidence proffered or adduced at the Sale Hearing; and (iii) any representations of counsel made on the record at the Sale Hearing, Prevailing Bidder's bid for the purchase of the Purchased Assets as set forth in the 4646 APA, is fair and reasonable and

constitutes the highest or otherwise best offer received for the Purchased Assets. No other person, entity, or group of entities has offered to purchase the Purchased Assets for greater economic value to the Debtors than the Prevailing Bidder. The Bidding Procedures established by the Bidding Procedures Order have been complied with in all material respects. The terms and conditions set forth in the 4646 APA are fair and reasonable under the circumstances.

I. **Arm's Length Transaction and Prevailing Bidder's Good Faith.** The 4646 APA was negotiated, proposed and entered into from arm's-length bargaining positions, without collusion, in good faith within the meaning of Section 363(m) of the Bankruptcy Code. Prevailing Bidder is not an "insider" or affiliate of the Debtors, as those terms are defined in Section 101(2) and (31) of the Bankruptcy Code. The 4646 APA was not entered into, and neither the Debtors nor Prevailing Bidder has entered into the 4646 APA, or proposes to consummate the Sale Transaction, for the purpose of hindering, delaying or defrauding creditors of the Debtors. Neither the Debtors nor Prevailing Bidder has entered into the 4646 APA or is consummating the Sale Transaction with any fraudulent or improper purpose. The Prevailing Bidder is a good faith purchaser within the meaning of Bankruptcy Code Section 363(m) and otherwise has proceeded in good faith in all respects in connection with this proceeding and is therefore entitled to the full protection of that provision with respect to the 4646 APA and any ancillary documents executed in connection with the Sale Transaction and each term of the Order. The protections afforded Bankruptcy Code Section 363(m) are integral to the Sale Transaction and the Prevailing Bidder would not consummate the Sale Transaction without such protections.

J. **No Liability Under Section 363(n).** Neither the Debtors nor Prevailing Bidder has engaged in any conduct that would cause or permit the 4646 APA to be avoided under Section 363(n) of the Bankruptcy Code. Specifically, Prevailing Bidder has not acted in a collusive manner

with any person and the purchase price was not controlled by any agreement with unrelated third parties.

K. **Free and Clear.** The Purchased Assets constitute property of the Debtors' estates and title thereto is vested in the Debtors' estate within the meaning of Section 541(a) of the Bankruptcy Code. Unless otherwise provided in this Sale Order or the 4646 APA, the transfer of the Purchased Assets will be a legal, valid, and effective transfer of the Purchased Assets, and will vest Prevailing Bidder with all right, title, and interest of the Debtors in and to the Purchased Assets, pursuant to Sections 105(a) and 363(f) of the Bankruptcy Code, free and clear, to the fullest extent available under the Bankruptcy Code or any other applicable law, of all liens (statutory, contractual, or otherwise), claims (including those that constitute a "claim" as defined in Section 101(5) of the Bankruptcy Code), rights, liabilities, encumbrances and other interests of any kind or nature whatsoever (including any Lien, Claim, Encumbrance, Interest or Liability, as such terms are defined in the 4646 APA), including, without limitation, any debts arising under or out of, in connection with, or in any way relating to, any acts or omissions, obligations, demands, guaranties, rights, contractual commitments, restrictions, Medicaid historic recoupment liabilities, environmental liabilities, employment-related claims, employee pension or benefit plan claims, multiemployer benefit plan claims (including withdrawal liability claims), retiree healthcare or life insurance claims, tax claims (including but not limited to those of the Internal Revenue Service and the New York State Department of Finance), in each case of or against the Debtors, and any transferee or successor liability claims, rights or causes of action (whether at law or in equity), whether arising prior to or subsequent to the commencement of the Chapter 11 Case, whether known or unknown, and whether imposed by agreement, understanding, law, equity or otherwise (collectively, the "Claims"), because, in each case, one or more of the standards set forth in Section

363(f) of the Bankruptcy Code have been satisfied. Those holders of Claims who did not object (or who withdrew their objections) to the Motion or the Sale Transaction are deemed to have consented to the Motion and the Sale Transaction pursuant to Section 363(f)(2) of the Bankruptcy Code. Those holders of Claims who did object fall within one or more of the other subsections of Section 363(f) of the Bankruptcy Code and are adequately protected by having their Claims attach to the proceeds ultimately attributable to the Purchased Assets against or in which the Claims are asserted, subject to the terms of such Claims, with the same validity, force and effect, and in the same order of priority, which such Claims now have against the Purchased Assets or their proceeds, subject to any rights, claims and defenses the Debtors or their estates, as applicable, may possess with respect thereto. Prevailing Bidder is not taking an assignment of any contracts other than the Assumed Contracts, as defined in the 4646 APA. Therefore, except as specifically provided in the 4646 APA, and consistent with Section 363(f) of the Bankruptcy Code, Prevailing Bidder shall have no liability for any Claims arising out of or related to the Sale or transfer of the Purchased Assets or arising from Claims against the Debtors or their estates or any liabilities or obligations of the Debtors and/or their estates, based in whole or in part, directly or indirectly, in any theory of law or equity including, without limitation, any laws affecting antitrust, successor, transferee or vicarious liability. Except as specifically provided in the 4646 APA, all persons and entities asserting or holding any Claims in or with respect to the Purchased Assets (whether legal or equitable, secured or unsecured, matured or unmatured, contingent or non-contingent, senior or subordinated), howsoever arising, shall be forever barred, estopped, and permanently enjoined from asserting, prosecuting or otherwise pursuing such Claims against Prevailing Bidder.

L. **No Successor Liability.** The Sale Transaction contemplated under the 4646 APA does not constitute a consolidation, merger or *de facto* merger of Prevailing Bidder and the Debtors

and/or the Debtors' estates. There is no substantial continuity of enterprise between Prevailing Bidder and the Debtors, there is no common identity between the Debtors and Prevailing Bidder, there is no continuity of enterprise between the Debtors and Prevailing Bidder, Prevailing Bidder is not a mere continuation of the Debtors or their estates, and Prevailing Bidder does not constitute a successor to the Debtors or their estates. Except as otherwise set forth in the 4646 APA, the transfer of the Purchased Assets to Prevailing Bidder will not subject Prevailing Bidder to any liability for any Claims against the Debtors or the Purchased Assets existing as of the closing of the Sale ("Closing") by reason of such transfer based, in whole or in part, directly or indirectly, in any theory of law or equity including, without limitation, any laws affecting antitrust, ERISA, successor, transferee or vicarious liability; provided however, that nothing in this paragraph shall be construed as limiting any party's rights to assert a Claim against the Debtors, their estates or proceeds of the Sale unless the liability for such Claim was assumed by Prevailing Bidder.

M. Police or Regulatory Liability. Nothing in this Sale Order or the 4646 APA releases, nullifies, precludes, or enjoins the enforcement of any police or regulatory liability to a governmental unit that any entity would be subject to as the post-sale owner or operator of property after the date of entry of this Sale Order. Nothing in this Sale Order or the 4646 APA authorizes the transfer or assignment of any governmental: (i) license; (ii) permit; (iii) registration; (iv) authorization; or (v) approval, or the discontinuation of any obligation thereunder, without compliance with all applicable legal requirements and approvals under police or regulatory law. Nothing in this Sale Order divests any tribunal of any jurisdiction it may have under police or regulatory law to interpret this Sale Order or to adjudicate any defense asserted under this Sale Order.

N. **Legal and Factual Bases.** The legal and factual bases set forth in the Motion, and subsequent Sale Transaction-related filings, and at the Sale Hearing establish just cause for the relief granted herein.

O. **Validity of Transfer.** As of the Closing, the transfer of the Purchased Assets to Prevailing Bidder will be a legal, valid and effective transfer of the Purchased Assets, and will vest Prevailing Bidder with all right, title and interest of the Debtors in and to the Purchased Assets, free and clear of all Claims.

P. **Non-Moneyed Business.** The Debtors have complied or will comply in all respects with Section 363(d)(1) of the Bankruptcy Code in that the Sale Transaction is in accordance with non-bankruptcy law applicable to the transfer of property of a debtor that is a corporation or trust that is not a moneyed business corporation or trust.

Q. **Incorporation of Sale Hearing.** All findings of fact and conclusions of law made or announced by the Court at the Sale Hearing are incorporated herein.

NOW, THEREFORE, based upon the foregoing findings and conclusions, the Motion, and the record before the Court with respect to the Motion, and good and sufficient cause appearing therefor,

IT IS HEREBY ORDERED AS FOLLOWS:

1. Findings of Fact and Conclusions of Law. The findings of fact set forth above and conclusions of law stated herein shall constitute this Court's findings of fact and conclusions of law pursuant to Bankruptcy Rule 7052, made applicable to this proceeding pursuant to Bankruptcy Rule 9014. To the extent any finding of fact later shall be determined to be a conclusion of law, it

shall be so deemed and deemed so ordered, and to the extent any conclusion of law shall be determined to be a finding of fact, it shall be so deemed and deemed so ordered.

2. Objections. All objections and responses, if any, to the Motion or the relief requested therein, that have not been withdrawn, waived or settled as announced to the Court at the Sale Hearing or by stipulation filed with the Court or pursuant to the terms of this Sale Order, and all reservations of rights included therein, are hereby overruled on the merits, with prejudice. All persons and entities given notice of the Motion that failed to timely object thereto are deemed to consent to the relief sought therein.

3. Approval of the 4646 APA. The Sale and all of the terms and conditions and transactions contemplated in connection with 4646 APA are hereby authorized and approved pursuant to, inter alia, Sections 105(a), 363(b) and 365(a) of the Bankruptcy Code. Pursuant to Section 363(b) of the Bankruptcy Code, the Debtors are authorized to consummate the Sale Transaction pursuant to and in accordance with the terms and conditions in the 4646 APA and this Sale Order. The Debtors, as well as their officers, employees and agents, are authorized and directed to execute and deliver, and authorized to perform under, consummate and implement, the 4646 APA, together with all additional instruments and documents that may be reasonably necessary or desirable to implement the 4646 APA, and to take all further actions as may be: (i) reasonably requested by Prevailing Bidder for the purpose of assigning, transferring, granting, conveying and conferring to Prevailing Bidder, or reducing to possession, the Purchased Assets; or (b) necessary or appropriate to the performance of the obligations contemplated by the 4646 APA, all without further order of the Court. Prevailing Bidder shall have no obligation to proceed with the Closing until all conditions precedent to its obligations to do so have been met, satisfied or waived (in a writing signed by Prevailing Bidder).

4. Good Faith. The Sale Transaction has been undertaken by Prevailing Bidder in good faith. Prevailing Bidder satisfies the good faith requirement of Section 363(m) of the Bankruptcy Code and, accordingly, Prevailing Bidder and the Sale Transaction are entitled to all of the protections afforded thereby. Pursuant to Section 363(m) of the Bankruptcy Code, if any or all of the provisions of this Sale Order are hereafter reversed, modified, or vacated by a subsequent order of this Court or any other court, such reversal, modification, or vacatur shall not affect the validity and enforceability of any sale, transfer or assignment under the 4646 APA or obligation or right granted pursuant to the terms of this Sale Order, and notwithstanding any reversal, modification or vacatur shall be governed in all respects by the original provisions of this Sale Order or the 4646 APA, as the case may be. The Sale Transaction approved by this Sale Order is not subject to avoidance and no damages may be awarded pursuant to Section 363(n) of the Bankruptcy Code.

5. Transfer of Assets Free and Clear.

A. Pursuant to Sections 105(a), 363(b), 363(f) and 365 of the Bankruptcy Code, the Debtors are authorized and directed to transfer the Purchased Assets in accordance with the terms of the 4646 APA. The Purchased Assets shall be transferred to Prevailing Bidder, and upon consummation of the 4646 APA, such transfer shall: (i) be valid, legal, binding and effective; (ii) vest Prevailing Bidder with all right, title and interest of the Debtors in the Purchased Assets; and (iii) be free and clear of all Claims, with all Claims that represent interests in property to attach to the net proceeds of the Sale, in the order of their priority and with the same validity, force and effect that they now have against the Purchased Assets, subject to any rights, claims and defenses the Debtors or their estates, as applicable, may possess with respect thereto. Upon the occurrence of the Closing, this Sale Order shall be considered and constitute for any and all purposes a full

and complete general assignment, conveyance and transfer of the Purchased Assets acquired by Prevailing Bidder under the 4646 APA and/or a bill of sale or assignment transferring indefeasible title and interest in the Purchased Assets to Prevailing Bidder free and clear of all Claims. All persons and entities are prohibited and enjoined from taking any action to adversely affect or interfere with the ability of the Debtors to transfer the Purchased Assets to Prevailing Bidder in accordance with the 4646 APA and this Sale Order.

B. Except as otherwise provided in this Sale Order or the 4646 APA, all Governmental Units (as defined in Sections 101(27) and 101(41) of the Bankruptcy Code) and all persons and entities (and their respective successors and assigns), including, without limitation, all debt security holders, equity security holders, governmental, tax and regulatory authorities, lenders, employees, former employees, pension plans, multiemployer pension plans, labor unions, trade creditors and any other creditors holding Claims (whether legal or equitable, secured or unsecured, known or unknown, matured or unmatured, contingent or non-contingent, liquidated or unliquidated, senior or subordinated) arising under or out of, in connection with, or in any way relating to, the Debtors, the Purchased Assets, business operations prior to Closing or the transfer of the Purchased Assets to Prevailing Bidder, are hereby forever barred, estopped and permanently enjoined from asserting or pursuing any Claims against Prevailing Bidder, its affiliates, successors or assigns, its property or the Purchased Assets, including, without limitation, taking any of the following actions with respect to a Claim: (i) commencing or continuing, in any manner, any action or other proceeding against Prevailing Bidder, its affiliates, successors or assigns, assets (including the Purchased Assets) or properties; (ii) enforcing, attaching, collecting or recovering, in any manner, any judgment, award, decree, or order against Prevailing Bidder, its affiliates, successors or assigns, assets, or properties; (iii) creating, perfecting, or enforcing any liens, claims,

encumbrances or other interests against the Debtors as against Prevailing Bidder, or its affiliates, successors, assigns, assets (including the Purchased Assets) or properties; (iv) asserting any setoff, right of subrogation or recoupment of any kind for any obligation of the Debtors as against any obligation due to Prevailing Bidder, or its affiliates, successors or assigns or their respective assets, including the Purchased Assets; or (v) commencing or continuing any action, in any manner or place, that does not comply, or is inconsistent with, the provisions of this Sale Order or the agreements or actions contemplated or taken in respect thereof.

C. This Sale Order: (i) shall be effective as a determination that, as of the Closing, except as otherwise provided in this Sale Order and the 4646 APA, all Claims, have been unconditionally released, discharged and terminated as to Prevailing Bidder and the Purchased Assets, and that the conveyances and transfers described herein have been effected; and (ii) is and shall be binding upon and govern the acts of all persons and entities, including all filing agents, filing officers, title agents, title companies, recorders of mortgages, recorders of deeds, registrars of deeds, administrative agencies, governmental departments, secretaries of state, federal and local officials and all other persons and entities who may be required by operation of law, the duties of their office, or contract, to accept, file, register or otherwise record or release any documents or instruments, or who may be required to report or insure any title or state of title in or to any lease; and each of the foregoing persons and entities is hereby directed to accept for filing any and all of the documents and instruments necessary and appropriate to consummate the transactions contemplated by the 4646 APA.

D. If any person or entity that has filed financing statements, mortgages, deeds of trust, mechanic's liens, *lis pendens* or other documents or agreements evidencing Claims against the Debtors or the Purchased Assets has not delivered to the Debtors prior to the Closing of the

Sale Transaction, in proper form for filing and executed by the appropriate parties, termination statements, instruments of satisfaction, releases of all interests which the person or entity has with respect to the Debtors or the Purchased Assets or otherwise, then with regard to the Purchased Assets that are purchased by Prevailing Bidder pursuant to the 4646 APA and this Sale Order: (i) the Debtors are hereby authorized and directed, and Prevailing Bidder is hereby authorized, to execute and file such statements, instruments, releases and other documents on behalf of the person or entity with respect to the Purchased Assets; and (ii) Prevailing Bidder is hereby authorized, but not directed, to file, register or otherwise record a certified copy of this Sale Order, which, once filed, registered or otherwise recorded, shall constitute conclusive evidence of the release of all Claims against the Purchased Assets. This Sale Order is deemed to be in recordable form sufficient to be placed in the filing or recording system of each and every federal, state or local government agency, department or office. Notwithstanding and without limiting the foregoing, the provisions of this Sale Order authorizing the sale and assignment of the Purchased Assets free and clear of Claims, shall be self-executing, and neither the Debtors nor Prevailing Bidder shall be required to execute or file releases, termination statements, assignments, consents, or other instruments in order to effectuate, consummate and implement the provisions of this Sale Order.

E. The Prevailing Bidder is hereby authorized in connection with the consummation of the Sale Transaction authorized herein to allocate the Purchased Assets, assumed liabilities, permitted encumbrances, and the assumed contracts among its affiliates, designees, assignees, and/or successors in a manner as it, in its sole discretion, seems appropriate, and to assign, sublease, sublicense, transfer or otherwise dispose of any of the Purchased Assets or the rights under any assumed contract to its affiliates, designees, assignees, and/or successors with all of the rights and protections accorded under this Order and the 4646 APA, and the Debtors shall

cooperate with and take all actions reasonably requested by the Prevailing Bidder to effectuate any of the foregoing. Such allocations shall not be binding in further proceedings before the Court.

F. Following the Closing of the Sale Transaction, no holder of any Claim shall interfere with Prevailing Bidder's title to or use and enjoyment of the Purchased Assets based on or related to any such Claim or based on any actions the Debtors may take in the Chapter 11 Case.

7. No Successor or Transferee Liability.

A. Prevailing Bidder is not and shall not be deemed a "successor" to the Debtors or their estates as a result of any action taken in connection with the 4646 APA, the consummation of the Sale Transaction contemplated by the 4646 APA, the transfer or operation of the Purchased Assets or any other event occurring in the Bankruptcy Case under any theory of law or equity, and Prevailing Bidder shall not assume, nor be deemed to assume, or in any way be responsible for any liability or obligation of the Debtor (or any of its predecessors or Affiliates) and/or its estate including, but not limited to, any Medicaid historic recoupment liabilities, bulk sales law, tax claims (including but not limited to those of the Internal Revenue Service and the New York State Department of Finance), pension or ERISA obligation, WARN Act obligation, Fair Labor Standards Act obligation, CERCLA obligation, any obligation under the Consolidated Omnibus Budget Reconciliation Act, successor liability, or similar liability except as otherwise expressly provided in the 4646 APA. The Sale of the Purchased Assets and the assumption and assignment of the Assumed Liabilities by Prevailing Bidder and the Sale Transaction approved hereby will not cause Prevailing Bidder to be deemed a successor in any respect to the Debtor.

B. Nothing in this Sale Order or the 4646 APA shall require Prevailing Bidder to: (i) continue or maintain in effect, or assume any liability in respect of any employee, collective bargaining agreement, pension, welfare, fringe benefit or any other benefit plan, trust arrangement

or other agreements to which the Debtors are a party or have any responsibility therefor, including, without limitation, medical, welfare and pension benefits payable after retirement or other termination of employment; or (ii) assume any responsibility as a fiduciary, plan sponsor or otherwise, for making any contribution to, or in respect of the funding, investment or administration of any employee benefit plan, arrangement or agreement (including but not limited to pension plans) or the termination of any such plan, arrangement or agreement (including but not limited to any withdrawal liability).

C. Nothing in this Sale Order shall be interpreted to deem Prevailing Bidder as the successor to the Debtors under any state law successor liability doctrine with respect to any liabilities under environmental laws or regulations for penalties for days of violation prior to Closing. Nothing in this Sale Order should be construed to create for any governmental unit any substantive right that does not already exist under law.

8. Surrender of Assets and Real Property. All entities who are presently, or who as of the Closing may be, in possession of some or all of the Purchased Assets hereby are directed to surrender possession of the Purchased Assets to Prevailing Bidder as of the Closing.

9. Assumption and Assignment of Assumed Contracts. The Debtors are authorized to assume and assign the Assumed Contracts designated for assignment to Prevailing Bidder pursuant to the 4646 APA; provided, however, that there shall be no assumption of any such contract absent simultaneous assignment thereof to Prevailing Bidder. Subject in all respects to Section (M) of this Order, (i) no section of any Assumed Contract that purports to prohibit, restrict, impose any penalty or fee, or condition the use, consideration or assignment of any such Assumed Contract in connection with the Tale Transaction shall have any force or effect; (ii) Prevailing Bidder shall be deemed to be substituted for the Debtors as a party to each of the Assumed Contracts; and (iii)

pursuant to Section 365(k) of the Bankruptcy Code, the Debtors and their estates shall be relieved from any liability for any post-Closing breach of any such Assumed Contract after assignment of such Assumed Contract to Prevailing Bidder. In accordance with Sections 365(b)(2) and (f) of the Bankruptcy Code, upon transfer of the Assumed Contracts to Prevailing Bidder and subject in all respects to Section (M) of this Order: (i) Prevailing Bidder shall have all of the rights of the Debtor thereunder, free and clear of all Claims, except as otherwise provided in the 4646 APA, and each provision of such Assumed Contracts shall remain in full force and effect for the benefit of Prevailing Bidder, notwithstanding any provision in such contract, lease or in applicable law that prohibits, restricts or limits in any way such assignment or transfer; and (ii) none of the Assumed Contracts may be terminated, or the rights of any party modified in any respect by any other party thereto as a result of the consummation of the transactions contemplated by the 4646 APA.

10. Rejection of Contracts and Leases. All Contracts and Leases of the Debtors other than the Assumed Contracts shall be deemed to have been rejected by the Debtors effective as of the Closing, unless otherwise agreed to by the Debtors and Prevailing Bidder.

11. Adequate Assurance. The requirements of Sections 365(b)(1) and 365(f)(2) of the Bankruptcy Code are satisfied with respect to the Assumed Contracts based on Prevailing Bidder's evidence of its financial condition and wherewithal presented at the Sale Hearing and without any other or further action by Prevailing Bidder, including, but not limited to, any other or further deposit.

12. Consideration. The Purchase Price shall be the payment at Closing of Fourteen Million Three Hundred Thousand and 00/100 Dollars (\$14,300,000): (i) payoff of outstanding mortgage indebtedness owed to Berkadia/HUD; (ii) payment of any other amounts as directed by this Court; and (iii) remainder in cash to the Debtors.

13. Operation by Prevailing Bidder. To the maximum extent available under applicable law: (i) Prevailing Bidder shall be authorized, as of the Closing, to operate under any license, permit, registration, and any other governmental authorization or approval of the Debtors with respect to the Purchased Assets and the Assumed Contracts; (ii) all such licenses, permits, registrations, and governmental authorizations and approvals are deemed to have been, and hereby are, directed to be transferred to Prevailing Bidder as of the Closing; and (iii) to the extent provided by Section 525 of the Bankruptcy Code, no governmental unit may revoke or suspend any permit or license relating to the operation of the Purchased Assets sold, transferred or conveyed to Prevailing Bidder on account of the filing or pendency of this Chapter 11 Case or the consummation of the Sale Transaction contemplated by the 4646 APA.

14. Enforcement. The terms and provisions of the 4646 APA and this Sale Order, and the Sale Transaction contemplated thereby and hereby, shall, as applicable, be specifically enforceable against and be binding in all respects upon, or shall inure to the benefit of, the Debtors, their estates, and creditors, Prevailing Bidder, and their respective affiliates, successors and assigns, and any affected third parties, including all entities asserting Claims, notwithstanding any subsequent appointment of any trustee, examiner or receiver of the Debtors under any chapter of the Bankruptcy Code or any other law, and all such terms and provisions likewise shall be binding on and specifically enforceable against such trustee, examiner or receiver, and shall not be subject to rejection or avoidance by the Debtors, their estates, creditors, any other representatives of their estates, or any trustee, examiner or receiver.

15. No Bulk Sales. No bulk sales law, or similar law of any state or other jurisdiction shall apply in any way to the Sale Transaction contemplated by the 4646 APA, the Motion and this Sale Order.

16. Compliance with HIPAA. Nothing provided for in this Sale Order shall alter the Debtors' or Prevailing Bidder's obligations to protect the confidentiality of patient records, including but not limited to confidential records as required under applicable non-bankruptcy law and regulations including, but not limited to, the Health Insurance Portability and Accountability Act of 1996 ("HIPAA") and the federal HIPAA privacy regulations at 45 Code of Federal Regulations.

17. Retention of Jurisdiction. This Court shall retain exclusive jurisdiction to, among other things: (i) interpret, enforce and implement the terms and provisions of this Sale Order and the 4646 APA, all amendments thereto, any waivers and consents thereunder and of each of the agreements executed in connection therewith in all respects; (ii) to adjudicate disputes related to this Sale Order or the 4646 APA or the rights and duties provided hereunder or thereunder or any issues relating to the 4646 APA and this Sale Order including, but not limited to, the interpretation of the terms, conditions and provisions hereof and thereof, the status, nature and extent of the Purchased Assets and any Assumed Contracts and all issues and disputes arising in connection with the relief authorized herein, inclusive of those concerning the transfer of the Purchased Assets and Assumed Contracts free and clear of all Claims; and (iii) to enforce the injunctions set forth herein.

18. Modification. The 4646 APA may be modified, amended or supplemented by Prevailing Bidder and the Debtors in a writing signed by both parties without further order of the Court, provided that any such modification, amendment or supplement does not materially change the terms of the 4646 APA or modify the express terms of this Sale Order.

19. Survival. Nothing contained in any subsequent order of this Court or any court of competent jurisdiction in this Chapter 11 Case (or any order entered after any conversion of a

chapter 11 case of the Debtors to a case under chapter 7 of the Bankruptcy Code) or any chapter 11 plan confirmed in the Debtors' Chapter 11 Case or any order confirming any such plan shall nullify, alter, conflict with, or in any manner derogate from the provisions of this Sale Order, and the provisions of this Sale Order shall survive and remain in full force and effect. For the avoidance of doubt, if the Debtors' Chapter 11 Case is converted to a case under chapter 7 of the Bankruptcy Code, the Sale Order shall be binding on the chapter 7 trustee in such chapter 7 case.

20. Failure to Specify. The failure specifically to include any particular provision of the 4646 APA in this Sale Order shall not diminish or impair the effectiveness of such provision, it being the intent of the Court, the Debtors and Prevailing Bidder that the 4646 APA be authorized and approved in its entirety with such amendments thereto as may be made by the parties in accordance with this Sale Order and the terms of the 4646 APA.

21. Non-Severability. The provisions of this Sale Order are non-severable and mutually dependent.

22. Automatic Stay. The automatic stay pursuant to Section 362 of the Bankruptcy Code is hereby lifted with respect to the Debtors to the extent necessary, without further order of this Court, to allow: (i) Prevailing Bidder to give the Debtors any notice provided for in the 4646 APA; and (ii) Prevailing Bidder to take any and all actions provided under or contemplated by the 4646 APA in accordance with the terms and conditions thereof.

23. Order Immediately Enforceable. Notwithstanding the provisions of Bankruptcy Rules 6004 and 6006, this Sale Order shall not be stayed for fourteen (14) days after the entry hereof but shall be a Final Order effective and enforceable immediately upon entry.

24. Automatic Stay. The Prevailing Bidder shall not be required to seek or obtain relief from the automatic stay under section 362 of the Bankruptcy Code to enforce any of its remedies

under the 4646 APA or any other sale-related document. The automatic stay imposed by section 362 of the Bankruptcy Code is modified solely to the extent necessary to implement the preceding sentence, provided that this Court shall retain exclusive jurisdiction over any and all disputes with respect thereto.

25. No Broker's Fee. Prevailing Bidder is not and will not be liable to any agent, broker, person or firm acting or purporting to act on behalf of either the Debtors or Prevailing Bidder for any commission, broker's fee or finder's fee respecting the Sale Transaction.

26. Conflicts. In the event of a direct conflict between the terms of this Sale Order and the terms of: (i) the 4646 APA, or (ii) any other order of this Court, the terms of this Sale Order shall govern and control.

27. No Waiver. Nothing in this Sale Order shall modify or waive any closing conditions or termination rights contained in the 4646 APA, and all such conditions and rights shall remain in full force and effect in accordance with their terms.
