**DECLARATION OF JOHN ROBERT WEISS IN  
SUPPORT OF THE DEBTORS’ APPLICATION  
FOR ENTRY OF AN ORDER PURSUANT TO  
SECTION 327(e) OF THE BANKRUPTCY CODE  
AUTHORIZING AND APPROVING THE EMPLOYMENT  
AND RETENTION OF DUANE MORRIS LLP AS SPECIAL  
COUNSEL FOR THE DEBTORS EFFECTIVE AS OF THE PETITION DATE**

I, John Robert Weiss, being duly sworn state the following under penalty of perjury:

1. I am a partner in the Chicago office of Duane Morris LLP (“Duane Morris”), which has a place of business at 190 South LaSalle Street, Suite 3700, Chicago, IL 60603.

2. I submit this declaration (the “Declaration”) in support of the *Debtors’ Application for Entry of an Order Pursuant to Section 327(e) of the Bankruptcy Code Authorizing and Approving the Employment and Retention of Duane Morris as Special Counsel for the Debtors Effective as of the Petition Date* (the “Application”).<sup>2</sup> Except as otherwise noted, I have personal knowledge of the matters set forth herein.

**Duane Morris' Qualifications**

3. Duane Morris is an international law firm of more than 800 lawyers with recognized expertise and extensive experience in M&A transactions, including in the healthcare industry. The Debtors have engaged Duane Morris for many purposes since early 2019, and Duane Morris is intimately familiar with the Debtors and their operations, particularly in Illinois. Prior to the Petition Date, the Debtors engaged Duane Morris to represent the Debtors in connection with the Illinois Sale. Based on that representation, Duane Morris has substantial experience with and a thorough understanding of the Illinois Sale.

**Services to be Provided**

4. Subject to Court approval, Duane Morris will represent the Debtors as special counsel in connection with the Illinois Sale. This representation will entail, among other things, negotiating and finalizing the definitive documentation for the Illinois Sale and implementing the same. The services and functions to be performed by Duane Morris will not be duplicative of work performed by the Debtors' general restructuring counsel or any other law firm retained by the Debtors.

**Professional Compensation**

5. It is my understanding that, subject to this Court's approval, Duane Morris will be compensated on an hourly basis as set forth in the Engagement Letter and will receive reimbursement of actual and necessary expenses incurred in connection with its representation of the Debtors in connection with the Illinois Sale. Further, Duane Morris intends to apply for allowance of compensation for professional services and reimbursement of expenses incurred in connection with such representation, subject to the Court's approval and in compliance with applicable provisions of the Bankruptcy Code, the Bankruptcy Rules, the Bankruptcy Local Rules, and any other applicable procedures and orders of the Court.

6. Prior to the Petition Date, the Debtors engaged Duane Morris to represent the Debtors in connection with the Illinois Sale. As of the Petition Date, Duane Morris is owed \$257,303.28 for professional services performed relating to the Illinois Sale and related costs.

7. I can affirm that Duane Morris will maintain detailed, contemporaneous records of time and of any actual and necessary expenses incurred in connection with Duane Morris's performance of the legal services described above.

8. I believe that proactive coordination among the Debtors' attorneys and other professionals will add to the progress and efficient administration of these chapter 11 cases. It is my understanding that the Debtors will carefully monitor and coordinate the efforts of all professionals retained by the Debtors, including any special counsel, and will delineate their respective duties to prevent the duplication of services whenever possible.

**No Adverse Interest**

9. Duane Morris has reviewed the list of parties in interest provided by the Debtors, attached hereto as **Schedule 1**. I confirm that a review of the list has been conducted, and it reveals that Duane Morris has not and currently does not represent any such interested party (other than the Debtors) with respect to these chapter 11 cases. I further confirm that, while this review did reveal that Duane Morris has formerly represented and currently represents certain other parties that are identified on the list of parties in interest, Duane Morris represented and represents these parties on matters unrelated to the Debtors' chapter 11 cases.

10. If the Court approves the retention of Duane Morris, Duane Morris will not accept any engagement or perform any service for any entity or person other than the Debtors in these chapter 11 cases.

11. Accordingly, and based on Kirkland's interpretation of the relevant provisions of the Bankruptcy Code, I submit that Duane Morris does not hold or represent an interest adverse to

the Debtors' estates that would otherwise render Duane Morris ineligible to serve as special counsel for the Debtors pursuant to section 327(e) of the Bankruptcy Code.

12. In addition, if any new material facts of relationships are discovered or arise, Duane Morris will provide the Court with a supplemental declaration.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge and belief.
