In accordance with the *Order Authorizing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals*, entered on November 4, 2020 [Docket No. 129] (the "Interim Compensation Order"),² Jones Day hereby submits this twenty-fifth monthly fee statement (the "Twenty-Fifth Monthly Fee Statement"), seeking compensation for services rendered and reimbursement of expenses incurred as counsel to the Debtor, for the period from October 1, 2022 through October 31, 2022 (the "Twenty-Fifth Monthly Fee Period"). 
