FTI Consulting Inc., (together with its wholly owned subsidiaries, agents, independent contractors and employees, "FTI") as financial advisor for the Official Committee of Unsecured Creditors (the "Committee"), hereby files this third monthly statement (the "Third Monthly Fee Statement") for allowance of compensation for professional services rendered and reimbursement of actual and necessary expenses incurred for the period from December 1, 2022 through December 31, 2022 (the "Fee Period"). FTI files this Third Monthly Fee Statement pursuant to sections 330, 331 and 1103 of title 11 of the United States Code (the "Bankruptcy Code"), rule 2016(a) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), rule 2016-1 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the Southern District of Texas (the "Local Rules"), the *Order (I) Establishing Procedures for*

*Interim Compensation and Reimbursement of Expenses for Retained Professionals and (II) Granting Related Relief* [Docket No. 494] (the “Interim Compensation Order”), and the *Order Authorizing the Official Committee of Unsecured Creditors of Pipeline Health System, LLC, et al. to Retain and Employ FTI Consulting, Inc. as Financial Advisor, Effective as of October 17, 2022* [Docket No. 671] (the “Retention Order”). Pursuant to the Interim Compensation Order, FTI requests payment of compensation in the amount of \$213,863.20 consisting of \$213,863.20 (80% of \$267,329.00) on account of actual, reasonable and necessary professional services rendered to the Committee by FTI.

### **SUMMARY OF EXHIBITS**

**CONCLUSION**

**WHEREFORE**, FTI respectfully requests allowance of its fees and expenses incurred during the Fee Period in the total amount of \$213,863.20 consisting of compensation in the amount of \$267,329.00, less a twenty percent (20%) holdback in the amount of \$53,465.80, for a total fee request of \$213,863.20, and further requests such other and further relief as this Court deems necessary and just.
