# DEBTORS' EMERGENCY OMNIBUS MOTION TO REJECT EXECUTORY CONTRACTS AND UNEXPIRED NON-RESIDENTIAL REAL PROPERTY LEASES, EFFECTIVE AS OF THE PETITION DATE

#### (Emergency Hearing Requested)

#### **Basis for Requested Emergency Hearing**

The Debtors seek permission to reject certain executory contracts and unexpired non-residential real property leases on an emergency basis. Immediate rejection will preclude the accrual and assertion of administrative expense claims. The Debtors respectfully request that the Court waive the provisions of Local Rule 9075-1(B), which requires an affirmative statement that a bona fide effort was made in order to resolve the issues raised in this Motion, as the relief requested herein is urgent in nature and does not lend itself to advance resolution.

and through their proposed undersigned counsel, pursuant to 11 U.S.C. § 365(a) and Bankruptcy Rule 6006, file this motion (the "Motion") seeking the entry of an order approving the Debtors' rejection of the executory contracts (collectively, the "Contracts") and unexpired leases (collectively, the "Leases") listed on Exhibit "A", effective as of the Petition Date. In support of the Motion, the Debtors rely upon the Declaration of Edward A. Phillips in Support of Chatter 11 Petitions and First Day Pleadings (the "First Day Declaration") filed on the Petition Date and respectfully represent as follows:

#### I. Jurisdiction and Venue

- 1. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2).
  - 2. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.
- 3. The statutory predicates for the relief sought herein are 11 U.S.C. § 365(a), Bankruptcy Rule 6006 and Local Rule 9075-1.

#### II. Background

- 4. On the date hereof (the "<u>Petition Date</u>"), each of the Debtors filed a voluntary petition for relief under chapter 11 of title 11 of the Bankruptcy Code.
- 5. The Debtors are operating their business and managing their affairs as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 6. For a detailed description of the Debtors and their operations, the Debtors respectfully refer the Court and parties in interest to the First Day Declaration.

#### III. Relief Requested and Basis Therefor

- 7. By this Motion, the Debtors seek authority, pursuant to section 365(a) of the Bankruptcy Code, to reject the Contracts and Leases listed on **Exhibit "A"**. The Debtors have determined in their business judgment that the Contracts and Leases are unnecessary to the administration of these bankruptcy cases and are burdensome to the estates. Specifically, the operating Debtors have ceased operations in the premises subject of the Leases and thus are no longer occupying and deriving any benefit from the use of such premises. With respect to the Contracts, the Debtors have no need for goods or services from the counter-contract parties or they have procured alternative providers. Therefore, maintaining the Contracts and Leases would impose unnecessary cost and burdens on the Debtors' estates with no commensurate benefit.
- 8. Section 365(a) of the Bankruptcy Code allows a debtor, subject to approval of the bankruptcy court, to assume or reject any unexpired lease. *See Stewart Title Guar. Co. v. Old Republic Nat'l Title Ins. Co.*, 83 F.3d 735, 741 (5th Cir. 1996); *In re TOUSA, Inc.*, No. 14-12067, 2015 WL 1346098, at \*5 n. 3 (11th Cir. Mar. 26, 2015) (in dicta). "This provision allows a [debtor] to relieve the bankruptcy estate of burdensome agreements which have not been completely performed." *Stewart Title*, 83 F.3d at 741 (quoting *In re Murexco Petrol., Inc.*, 15 F.3d 60, 62 (5th Cir. 1994)). A debtor's decision to assume or reject an unexpired lease is subject to the "business judgment" test. *Byrd v. Gardiner, Inc.* (*In re Gardinier, Inc.*), 831 F.2d 974, 976 n.2 (11th Cir. 1987); *In re Surfside Resort and Suites, Inc.*, 325 B.R. 465, 469 (Bankr. M.D. Fla. 2005); *see also In re Chira*, 567 F.3d 1307, 1312 (11th Cir. 2009) (describing the business judgment test as "narrow"). The sole inquiry is whether assumption or rejection will benefit the estate. *See id*.

- 9. In applying the "business judgment" test, courts show great deference to a debtor's decision to assume or reject an unexpired lease. See In re Colony Beach & Tennis Club Ass'n, Inc., No. 8:09-cv-535-T-33, 2010 WL 746708, at \*3 (M.D. Fla. Mar. 2, 2010) ("A court may not substitute its judgment for that of a debtor unless the debtor's decision that 'rejection will be advantageous is so manifestly unreasonable that it could not be based on sound business judgment, but only on bad faith, whim, or caprice.'") (quoting Surfside Resort and Suites, 325 B.R. at 469) (internal citations omitted); Summit Land Co. v. Allen (In re Summit Land Co.), 13 B.R. 310, 315 (Bankr. D. Utah 1981) (absent extraordinary circumstances, court approval of debtor's decision to assume or reject an unexpired lease "should be granted as a matter of course"). As long as the decision to assume or reject is a reasonable exercise of business judgment, courts should approve the assumption or rejection of an unexpired lease. See, e.g., NLRB v. Bildisco and Bildisco, 465 U.S. 513, 523 (1984); Group of Institutional Investors v. Chicago M. St. P. & P. R. R. Co., 318 U.S. 523 (1943).
- 10. Because the Debtors will not profit from the continued performance under the Contracts and Leases, and rejection will avoid the accrual of administrative expenses, it necessarily follows that rejection of the Contracts and Leases as of the Petition Date is a decision made in the sound exercise of the Debtors' business judgment, that is, a decision that will benefit the Debtors' estates.

**WHEREFORE,** the Debtors respectfully request entry of an Order in the form attached hereto as **Exhibit "B"** (i) approving the rejection of the Contracts and Leases effective as of the

Petition Date, and (ii) granting such other relief as is just and proper.

<sup>1</sup>On September 14, 2020, Delphi Health Holdings LLC entered into a sublease with Harmony Hills Behavioral Health, LLC regarding a sublease of the property located at 18307-18121 Boys Ranch Road, Altoona ("Sublease"). The Sublease was assigned via a Third Amendment to and Assignment and Assumption of Lease by Delphi Health Holdings, LLC to Palm Beach Recovery, LLC. The rejection of the primary lease as between Palm Beach Recovery, LLC (lessee) and 18307 Boys Ranch Road Owner, LLC necessarily effectuates a rejection of Palm Beach Recovery, LLC's Sublease with Harmony Hills Behavioral Health, LLC. *See Chatlos Sys., Inc. v. Kaplan*, 147 B.R. 96, 100 (D. Del. 1992) (deeming rejected a sublease under a rejected primary lease "since the sublessee's rights in the property extinguish with those of the sublessor"), *aff'd sub nom. Chatlos Sys., Inc. v. Kaplan* (In re TIE Commc'ns, Inc.), 998 F.2d 1005 (3d Cir. 1993) (table); *In re J.T. Moran Financial Corp.*, 124 B.R. 924, 925 (Bankr. S.D.N.Y. 1991) ("The creation of a sublease depends upon the continuing viability of a prime lease, so that the rejection of the prime lease also results in the rejection of the sublease."). Nevertheless, in an abundance of caution, if the Court were to conclude that rejection of the primary lease with 18307 Boys Ranch Road Owner, LLC does not automatically result in the rejection of the Sublease with Harmony Hills Behavioral Health, LLC, the Debtors include the Sublease among the unexpired leases being rejected by way of this Motion.
