# GLOBAL NOTES AND STATEMENT OF LIMITATIONS, METHODOLOGY, AND DISCLAIMER REGARDING THE DEBTOR'S SCHEDULES OF ASSETS AND LIABILITIES AND STATEMENT OF FINANCIAL AFFAIRS

The Schedules of Assets and Liabilities (the "Schedules") and the Statement of Financial Affairs (the "SOFA," and collectively with the Schedules, the "Schedules and Statement") filed by Bolta US Ltd., the above-captioned debtor and debtor in possession (the "Debtor"), in the United States Bankruptcy Court for the Northern District of Alabama (the "Bankruptcy Court"), are unaudited and were prepared pursuant to section 521 of title 11 of the United States Code, 11 U.S.C. §§ 101-1532 (the "Bankruptcy Code"), and Federal Rule of Bankruptcy Procedure 1007 by the management of the Debtor with the assistance of its advisors. The Schedules and Statement remain subject to further review and verification by the Debtor. Subsequent information may result in material changes in financial and other data contained in the Schedules and Statement. The Debtor has used its best efforts to compile the information set forth in the Schedules and Statement from its books and records maintained in the ordinary course of its business. The Debtor reserves its rights to amend the Schedules and Statement from time to time as may be necessary or appropriate.

These Global Notes and Statement of Limitations, Methodology, and Disclaimer Regarding the Schedules of Assets and Liabilities and Statement of Financial Affairs (the "Global Notes") pertain to, are incorporated by reference in, and comprise an integral part of all of the Schedules and Statement. The Global Notes should be referred to and reviewed in connection with any review of the Schedules and Statement. In the event that the Schedules and Statement differ from any of the foregoing Global Notes, the Global Notes shall control.

1. <u>Summary of Significant Reporting Policies</u>. The following conventions were adopted by the Debtor in the preparation of the Schedules and Statement:

The last four digits of the Debtor's tax identification numbers are 5583, and the location of the Debtor's business is 1650 Boone Blvd., Northport, Alabama 35476.

- a) Description of the Case and "As Of" Information Date. On January 13, 2023 (the "Petition Date"), the Debtor filed a voluntary petition with the Bankruptcy Court under chapter 11 of the Bankruptcy Code. The Debtor continues to operate its business and manage its property as debtor in possession as authorized by section 1107(a) and 1108 of the Bankruptcy Code. Except as noted in the Schedules and Statement or herein, all asset and liability data contained in the Schedules and Statement are stated as of the close of business (prevailing Central Time) on January 13, 2023. In some instances, the Debtor has used estimated amounts where actual data as of January 13, 2023 was not available.
- d) Basis of Presentation. The preparation of the Schedules and Statement required the Debtor to make estimates and assumptions that affect the reported amounts of liabilities, the disclosures of contingent liabilities, and the reported amounts of expenses during the reporting period. Actual results could differ from estimates. Some of the Debtor's scheduled assets and liabilities are unknown and/or unliquidated at this time. In such cases, the amounts are listed as "Unknown" or "Undetermined." Accordingly, the Schedules may not fully reflect the aggregate amount of the Debtor's assets and liabilities. The Debtor has sought to allocate liabilities between pre-petition and post-petition periods based on information from research that was conducted in connection with the preparation of the Schedules. As additional information becomes available and further research is conducted, the allocation of liabilities between pre-petition and post-petition periods may change. Given the differences between the information requested in the Schedules and Statement, and the financial information utilized under generally accepted accounting principles in the United States ("GAAP"), the aggregate asset values and claim amounts set forth in the Schedules and Statement do not necessarily reflect the amounts that would be set forth in a balance sheet prepared in accordance with GAAP.
- e) <u>Authorized Signatory</u>. Jeffrey R. Truitt, the Chief Restructuring Officer of the Debtor, has signed the Schedules and Statement on behalf of the Debtor. Mr. Truitt became Chief Restructuring Officer of the Debtor on December 16, 2022. In reviewing and signing the Schedules and Statement, Mr. Truitt has necessarily relied upon the efforts, statements, and representations of various personnel of the Debtor and its advisors. Mr. Truitt has not, and could not have, personally verified the accuracy of each such statement and representation, including, for example, statements and representations concerning amounts owed to creditors.
- f) Claims Description. Schedules D and E/F permit the Debtor to designate a claim as disputed, contingent, and/or unliquidated. A failure to designate a claim on any of these Schedules as disputed, contingent, and/or unliquidated does not constitute an admission that such claim is not subject to objection. The Debtor reserves its rights to dispute, or assert offsets or defenses to any claim reflected on the Schedules as to the nature, amount, liability, or status.
- g) <u>Confidential</u>, <u>Private</u>, <u>and Commercially Sensitive Information</u>. In certain instances, the Debtor may have intentionally altered, revised, redacted or

consolidated certain information in the Schedules and Statement due to the nature of an agreement between the Debtor and a third party, concerns about the confidential or commercially sensitive nature of certain information, or concerns for the privacy of an individual. In addition, in certain instances, the sensitivity of such information may require its omission from the Schedules and Statement. To the extent possible, the alterations, redactions, consolidations and omissions have been limited to the extent determined by the Debtor to be necessary or appropriate to protect the Debtor or third parties while also providing interested parties with sufficient information in response to the Schedules and Statement.

- h) Estimates and Assumptions. In preparing the Schedules and Statement, the Debtor was required to make certain estimates and assumptions that affect the reported amounts of assets and liabilities, and the potential values of contingent assets and liabilities on the date the Schedules and Statement were filed and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates, perhaps materially.
- i) <u>Excluded Asset and Liabilities</u>. Certain deferred charges, accounts, or reserves recorded for GAAP reporting purposes only are not necessarily included in the Schedules and Statement.
- j) Executory Contracts and Unexpired Leases. While the Debtor has made reasonable efforts to ensure the accuracy of the executory contracts and unexpired leases listed on Schedule G, inadvertent errors or omissions may have occurred. The Debtor listed on Schedule G those contracts or leases to which the Debtor may be a party that it could reasonably locate. The Debtor intends to amend Schedule G to the extent further contract or lease information is located. Moreover, some of the Debtor's business is conducted through purchase orders, and the inclusion or reference to a purchase order or agreement on Schedule G does not does not constitute an admission by the Debtor that such purchase order or agreement actually constitutes an executory contract or unexpired lease under section 365 of the Bankruptcy Code. The Debtor expressly reserves the right to challenge the status of any purchase order or agreement included as an executory contract or unexpired lease. The rejection of executory contracts and unexpired leases under section 365 of the Bankruptcy Code will result in the assertion of rejection damages claims; however, the Schedules and Statement do not reflect any rejection damages claims. The Debtor reserves the right to make any arguments and objections with respect to the assertion of any such rejection damage claims.
- k) <u>Insiders</u>. For purposes of the Schedules and Statement, the Debtor utilizes the term "insiders" pursuant to section 101(31) of the Bankruptcy Code to include the following: (a) directors of the Debtor; (b) officers of the Debtor; (c) persons in control of the Debtor; (d) partnerships in which the Debtor is a general partner; (e) general partners of the Debtor; (f) relatives of general partners, directors, officers, or persons in control of the Debtor; (g) affiliates of the Debtor, or insiders of an

- affiliate of the Debtor as if such affiliate were the Debtor; and (h) managing agent of the Debtor.
- l) <u>Insurance</u>. The Debtor maintains general liability insurance policies and various other insurance policies, including, but not limited to, property, casualty, automobile, and professional liability insurance policies. The Debtor maintains additional insurance policies essential to the continued operations of the Debtor. The terms of these policies are characteristic of insurance policies typically maintained by business entities that are similar in size and nature to the Debtor. The Debtor received relief from the Bankruptcy Court to continue its insurance policies under the *Order (I) Authorizing the Debtor To (A) Continue Its Insurance Program, (B) Continue to Finance Insurance Policies, and (C) Pay All Prepetition and Postpetition Obligations with Respect Thereto; And (II) Granting Related Relief [Docket No. 73].*
- m) Net Book Value. Except as otherwise noted, each asset and liability of the Debtor is shown on the basis of the net book value of the asset or liability in accordance with the Debtor's accounting and/or tax books and records as of close of business (prevailing Central Time) on January 13, 2023. Unless otherwise noted, the Schedules reflect the carrying value of the assets and liabilities as listed in the Debtor's books, and are not based upon any estimate of their current fair market values, which may not correspond to book values.
- n) <u>Property and Equipment Owned</u>. Unless otherwise noted, owned property and equipment are stated at net book value.
- o) Property and Equipment Leased. In the ordinary course of business, the Debtor may lease equipment from certain third-party lessors for use in the daily operation of its businesses. Any such leases are set forth in the Schedules and Statement. Nothing in the Schedules and Statement is or shall be construed as an admission or determination as to the legal status of any lease, and the Debtor reserves all rights with respect to any of such issues.
- p) Reservation of Rights. The Debtor reserves all of its rights to amend the Schedules and Statement in all respects and as may be necessary or appropriate, including, but not limited to, the right to dispute or to assert offsets or defenses to any claim reflected on the Schedules as to amount, liability, or classification or to otherwise subsequently designate any claim as "disputed," "contingent," or "unliquidated."

### 2. Specific Schedules and Statement Disclosures

a) Schedules A/B Question 3 – Checking, Savings, Money Market, or Financial Brokerage Accounts. The bank accounts with CB&S Bank that are listed in 3.1, 3.2 and 3.3 are accounts in which the funds are being held in trust for the benefit of the Debtor's customers, SMP Automotive Systems of Alabama Inc. and Volkswagen Group of America Chattanooga Operations, LLC. Further, there is

- no corresponding liability for the amounts held in these accounts reflected elsewhere on the Schedules and Statement.
- b) Schedule A/B Question 25 Property Purchased Within 20 Days Before Petition Date. The Debtor has not included in this amount any inventory that were purchased on a cash in advance or cash on delivery basis and for which no other amounts remain owing for such inventory.
- c) Schedule A/B Questions 39-42 Office Equipment, Furnishings, and Supplies. Assets in these categories include office furnishings, such as tables, chairs, decorations, office equipment, computer software, and furniture. These assets are all listed at net book value as reflected in the Debtor's books and records.
- d) Schedule A/B Questions 47 and 50 Machinery, Fixtures, Equipment, and Supplies Used in Business. Assets in this category primarily include facility operating equipment, machinery, and processing equipment. The Debtor also leases a number of pieces of machinery and equipment. The Debtor has grouped these assets by category as opposed to identifying each individual piece of machinery or equipment. These assets are all listed at net book value as reflected in the Debtor's books and records. The Debtor reserves all rights as to the fair market value of these assets.
- e) Schedule A/B Question 74. The Debtor may have other claims or causes of action against third parties other than what is set forth on Schedule A/B. The Debtor reserves all rights regarding any such claims or causes of action.
- f) Schedule A/B Question 77. The Debtor has applied for certain Employee Retention Tax Credits ("ERTC") provided for in the Coronavirus Aid Relief and Economic Stimulus Act in the aggregate amount of approximately \$6.3 million. The timing and amount of the Debtor's receipt of ERTC funds is currently unknown. As such, the Debtor has listed this entirely as a contingent asset.
- g) Schedule D Creditors Holding Secured Claims. The claim amount balances listed on Schedule D are as of close of business (prevailing Central Time) on January 13, 2023. Although the Debtor may have scheduled claims of various creditors as secured claims for informational purposes, no current valuation of the Debtor's assets in which such creditors may have a lien has been undertaken.

The descriptions in Schedule D are intended only to be a summary. Reference to the applicable loan agreements and related documents and a determination of the creditors' compliance with applicable law is necessary for a complete description of the collateral and the nature, extent, and priority of any liens. Nothing in the Global Notes or the Schedules and Statement shall be deemed a modification or interpretation of the terms of such agreements or related documents.

The Debtor has not included on Schedule D parties that may believe its claims are secured through setoff rights, deposits posted by, or on behalf of, the Debtor, or inchoate statutory lien rights.

Porter Capital Corporation ("Porter") filed an "all assets" lien on the Debtor's assets. As such, Porter may have been a junior lienholder on the other collateral described on Schedule D. As of the filing of the Schedules, however, Porter has been paid in full and its liens have been satisfied in full consistent with its treatment under the *Interim Order (i) Authorizing Debtor to Obtain Secured Postpetition Financing and Use of Postpetition Cash Collateral; (ii) Granting Adequate Protection; (iii) Authorizing and Approving the Security Agreement; (iv) Modifying the Automatic Stay; (v) Setting Final Hearing; and (vi) Granting Related Relief* [Docket No. 91].

The Debtor has a master lease with Deutsche Leasing USA Inc. Most of the individual leases have been paid off but title has not transferred on such equipment due to cross-collateralization among all of the other leases. The individual leases referenced on Schedule D are those where amounts remain outstanding.

h) Schedule E/F - Creditors Holding Unsecured Priority Claims and Creditors Holding Unsecured Claims. The Bankruptcy Court has authorized the Debtor to, *inter alia*, continue to pay certain prepetition wages, salaries and employee benefits,<sup>2</sup> continue to pay prepetition trust fund and other taxes,<sup>3</sup> and continue to pay certain other allowed prepetition payments.<sup>4</sup> Accordingly, to the extent prepetition amounts have been paid in accordance with the Bankruptcy Court orders prior to filing of the Schedules, such claim amounts may or may not be listed. For example, all employee-related priority claims are not listed on Schedule E/F because all of them have been paid in accordance with the Employee Order, but any parties who may end up designated as "critical vendors" under the Critical Vendor Order will have the full amount of their prepetition unsecured claims listed on Schedule E/F.

Further, certain potential or actual priority claims may be subject to ongoing analysis, and the Debtor is otherwise unable to determine with certainty the amount of some of these claims. Therefore, the amounts of all such claims are subject to modification pending final resolution of ongoing analysis of said claims or other outstanding issues.

Schedule E/F may include certain deferred liabilities or general reserves. Such amounts are reflected on the Debtor's books and records as required in accordance with GAAP. Such accruals are general estimates of liabilities and may or may not represent specific claims as of close of business (prevailing Central Time) on January 13, 2023. Schedule E/F also reflects prepetition amounts owed to counterparties to executory contracts and unexpired leases.

i) Schedule G - Executory Contracts and Unexpired Leases. Although reasonable efforts have been made to ensure the accuracy of Schedule G regarding executory contracts and unexpired leases, the Debtor's review is ongoing and inadvertent errors, omissions, or over-inclusion may have occurred. The Debtor may have entered into various other types of agreements in the ordinary course of its business, such as supplemental agreements, amendments/letter agreements, noncompete agreements, and confidentiality agreements. Such documents may not be set forth in Schedule G.

The Debtor expressly reserves the right to challenge the status of any agreement included on Schedule G as an executory contract or unexpired lease. Certain of the contracts, agreements, and leases listed on Schedule G may contain renewal options, guarantees of payments, options to purchase, rights of first refusal, rights to lease additional space and other miscellaneous rights. Such rights, powers, duties and obligations may not be set forth on Schedule G. The Debtor reserves all of its rights, claims and causes of action with respect to the contracts and agreements listed on Schedule G.

- j) <u>Schedule H Co-Debtors</u>. The Debtor has made its reasonable best efforts to list on Schedule H parties who, it believes may have guaranteed certain debts; however, the Debtor hereby reserves all rights to further amend or supplement such Schedule as necessary.
- k) SOFA Question 3 Payments to Creditors within 90 Days. All amounts that the Debtor paid to any creditor within 90 days of the Petition Date are listed on SOFA Question 3 (that total more than \$7,575 in the aggregate for any individual creditor). In addition, the Debtor made numerous transfers of goods to customers during the 90 day period before and ending on the Petition Date, a limited number of which may have been, in whole or part, on account of an antecedent debt. The value of these transfers is not liquidated at this time, and the Debtor reserves all of its rights to amend the Schedules and Statement to account for these liquidated transfers or otherwise.
- SOFA Question 4 Payments Made Within One Year to Insiders. The Debtor and Bolta Investment Ltd. are parties to a "triple net" lease. The payments listed in this section do not include payments made directly to utility providers or directly government entities for taxes that are obligated to be paid under the lease.
- m) <u>SOFA Question 11 Payments Related to Bankruptcy</u>. The Debtor retained and paid for professional services rendered and expenses incurred by various

professionals during the 12 months preceding the Petition Date. Based on the fact that such professionals were engaged to provide a variety of services, only a portion of this amount is attributable to debt counseling, restructuring or bankruptcy preparation; however, the specifics of such amount cannot be readily ascertained with any accuracy.

- n) <u>SOFA Question 18 Closed Financial Accounts</u>. The Debtor instructed CB&S Bank to close two bank accounts on January 12, 2023; however, the Debtor cannot determine if those accounts were actually closed as of the Petition Date. In any event, the accounts both had zero balances as of the Petition Date.
- o) <u>SOFA Question 30 Payments that Benefited Any Insider</u>. Wages and other payments to insider individuals are reflected in SOFA Question 4, and are not duplicated in Question 30.
