#### UNITED STATES TRUSTEE TO APPOINT A PATIENT CARE OMBUDSMAN

THIS CASE comes before this Court after the first day hearings conducted at 2:30 p.m. on February 9, 2023, for the entry of an order directing the United States Trustee for Region 21 to appoint a patient care ombudsman in these jointly administered cases. Under 11 U.S.C. § 333, this Court shall enter such an order no later than 30 days after the petition date. At the first day hearings, the United States Trustee asked for such order, the Debtors were not in opposition to such order being entered and had provided a line-item in their initial budget for such administrative costs. Accordingly, based upon statute,

**IT IS ORDERED** under 11 U.S.C. § 333 that the United States Trustee for Region 21 is **DIRECTED** to appoint a patient care ombudsman who will be responsible to monitor the quality of patient care and represent the interests of the patients of these multiple health care businesses proceeding in this jointly administered case.
