**ORDER DIRECTING JOINT ADMINISTRATION
OF AFFILIATED CASES PURSUANT TO RULE 1015(b)**

THESE CAUSES having come before the Court this day on the *Motion for Order Directing Joint Administration of Affiliated Cases Pursuant to Rule 1015(b)* [Dkt. #125] (the “**Motion**”) filed by (a) Derek Henderson, Chapter 11 trustee for United Furniture Industries, Inc. (“**Trustee**”); and (b) each of the remaining and above-captioned debtors (collectively, the

“**Affiliated Debtors**”). The Court, having considered the Motion, the premises and such other matters as were presented to the Court by counsel, finds that the Motion is well taken and should be granted.

IT IS THEREFORE ORDERED that these cases shall be jointly administered under *In re: United Furniture Industries, Inc., et al.*; Case No. 22-13422-SDM, for procedural purposes only in the interests of convenience and judicial economy and are not substantively consolidated by this Order.

IT IS FURTHER ORDERED, that the Debtors shall combine the creditor matrixes in each Chapter 11 Bankruptcy case and into one consolidated creditor matrix and submit same for filing in the Clerk’s Office in the case of *In re: United Furniture Industries, Inc., et al.*; Case No. 22-13422.

IT IS FURTHER ORDERED that the Debtors’ Chapter 11 cases are not jointly administered for the purpose of filing proofs of claim or interest, and holders of claims against or interests in the Debtors shall file proofs thereof in the applicable Debtor’s case. Independent claims registers shall be maintained for each of the Debtors.

IT IS FURTHER ORDERED that the Debtors’ cases are not jointly administered for purposes of filing Chapter 11 Monthly Operating Reports or payment of quarterly fees to the U.S. Trustee.

IT IS FURTHER ORDERED that all pleadings filed in these jointly administered cases
shall be docketed in Case No. 22-13422 and shall bear the following caption:
