#### **STATEMENT OF ISSUES ON APPEAL**

Whether the United States Bankruptcy Court for the Southern District of New York (Garrity, J.) (the "Bankruptcy Court" or the "court") erred in awarding the chapter 11 Trustee, William A. Brandt Jr., (the "Trustee"), a commission in the amount of \$16,358,871 and expenses in the amount of \$326,622.52, including, without limitation:

- (A) Whether the Bankruptcy Court erred in calculating the fee cap under section 326 of title 11 of the United States Code where, among other things, (i) the court included \$1.895 billion in disbursements made by non-debtor subsidiaries to parties that were not parties in interest in the chapter 11 cases of the debtor entities; (ii) the court included the disbursement of equity interests, even though equity interests do not fall within the relevant statutory language of "moneys disbursed"; and (iii) the court included disbursements from the Trustee to the Plan Administrator.
- (B) Whether the Bankruptcy Court erred in calculating an adjusted lodestar of \$10,905,914.00 based on 13,667 hours submitted by the Trustee for the period from to 2016-2021, including an average of nearly 3,400 hours per year for three of those years.
- (C) Whether the Bankruptcy Court erred in applying a fee enhancement in the form of a 1.5 multiplier applied to the lodestar where, among other things, the Trustee: (i) never accomplished the sale that he viewed as the exclusive path out of bankruptcy; (ii) never proposed a plan; (iii) opposed the plan that was filed with overwhelming creditor support and ultimately confirmed by the court; (iv) allowed hundreds of millions of dollars in additional debt to accrue; (v) paid unnecessary fees to the U.S. Trustee.
