The Official Committee of Unsecured Creditors (the “Committee”) of the above-captioned debtors and debtors-in-possession (collectively, the “Debtors”) hereby files this application (the “Application”) for an order, substantially in the form attached hereto as Exhibit A, pursuant to sections 327(a) and 1103(a) of title 11 of the United States Code (the “Bankruptcy Code”), Rule 2014 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and Rules 2014-1 and 2016-1 of the Local Bankruptcy Rules for the United States Bankruptcy Court for the Southern District of Texas (the “Local Rules”) authorizing and approving the retention of Force Ten Partners, LLC (“Force 10”) as financial advisor to the Committee in connection with

the Debtors' chapter 11 cases, effective February 15, 2023. In support of the Application, the Committee files the declaration of Edward Kim (the "Kim Declaration"), attached hereto as Exhibit B and incorporated herein by reference. In support of the Application, the Committee respectfully represents as follows:

JURISDICTION AND VENUE

1. The Court has jurisdiction to consider this matter pursuant to 28 U.S. C. § 1334. This is a core proceeding pursuant to 28 U.S.C. §157(b). Venue is proper before the Court pursuant to 28 U.S.C. §§1408 and 1409. The statutory predicates for the relief requested herein are sections 327 (a) and 328 (a) of the Bankruptcy Code, Bankruptcy Rules 2014 (a) and 2016 (a), and Local Rules 2014-1 and 2016-1. Compensation will be in accordance with sections 330 and 331 of the Bankruptcy Code.

BACKGROUND

2. On January 23, 2023 (the "Petition Date"), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code with this Court. Since the Petition Date, the Debtors have remained in possession of their assets and have continued to operate and manage their businesses as debtors-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

3. On February 9, 2023, the Office of the United States Trustee for Region 7 appointed a seven-member Committee, which was reconstituted on February 14, 2023 to a six-member Committee consisting of: (i) Leggett & Platt, Incorporated; (ii) Sinomax-USA, Inc.; (iii) BekaertDeslee USA Inc.; (iv) Carpenter Co.; (v) Ryder Truck Rental Inc.; and (vi) Joshua

Brooks.² The Committee selected Kelley Drye & Warren LLP as counsel and Force 10 Partners as financial advisor.

4. The Committee selected Kelley Drye & Warren LLP as counsel and Force 10 as financial advisor.

5. Professionals of Force 10 working on these cases have extensive experience representing official creditors' committees, debtors, creditors, trustees, and others in a wide variety of bankruptcy cases, including, as (i) financial advisor to the official committees of unsecured creditors in the Stimwave Technologies Incorporated, Armstrong Flooring, Inc., BH Cosmetics, LLC, Teligent, Inc., Path Medical, LLC, Paper Source, Inc., NITROcrete, LLC, A.B.C. Carpet, Inc., Avadim Health, Inc., Alex and Ani, LLC, EHT US1, Inc. (Eagle Hospitality), Carbonlite Holdings LLC, TECT Aerospace Group Holdings, Inc., L'Occitane, Inc., Neopharma, Inc., PBS Brand Co., LLC (Punch Bowl), Francesca's Holding Corporation, Furniture Factory Ultimate Holding, LP, White Stallion Energy, LLC, Smartours, LLC, Pier 1, One Web, J Crew, Lucky's Market, Papyrus, American Blue Ribbon Holdings, LLC, BL Restaurants Holding, LLC, Destination Maternity, and Heritage Home Group matters; (ii) financial advisor to the debtors in South Coast Behavioral, Inc., Thomas Health Systems, Watsonville Hospital, Synrgo, Coastal International Inc., Alpha Guardian, Sugarfina, Inc., Carbonlite Holdings LLC, Cinemex Holdings USA, XS Ranch Fund VI, LP, Focus Property Group, and Superior Linen matters; and (iii) trustee in the AFT, PME Funds Inc., Faraday & Future Inc., and Aurasound matters, among others.³

RELIEF REQUESTED

6. By this Application, the Committee respectfully requests that the Court enter an order, substantially in the form annexed hereto as **Exhibit A**, pursuant to sections 327(a) and 1103(a) of the Bankruptcy Code, Bankruptcy Rules 2014 and 2016, and Local Rules 2014-1 and 2016-1, authorizing the Committee to employ and retain Force 10 as its financial advisor in these chapter 11 cases. The Committee selected Force 10 in furtherance of the efficient administration of the estates on behalf of the Committee. The Committee seeks to retain Force 10 effective as of February 15, 2023, the date that Force 10 began providing services to the Committee. The Committee believes that such retention is appropriate in these chapter 11 cases because the Committee required Force 10's assistance prior to such time as a retention application could be submitted to the Court due to the exigencies of these cases, and Force 10 provided services to the Committee beginning February 15, 2023.

SCOPE OF EMPLOYMENT

7. Subject to further order of this Court, the services Force 10 has rendered and may be required to render to the Committee include the following:

- a. becoming familiar with and analyzing the Debtors' DIP budget, assets and liabilities, and overall financial condition;
- b. reviewing financial and operational information furnished by the Debtors;
- c. analyzing current litigation and impact of same on creditors' recoveries;
- d. scrutinizing the economic terms of various agreements, including, but not limited to, the Debtors' various professional retentions;
- e. analyzing the Debtors' proposed business plans and developing alternative scenarios, if necessary;

- f. assessing the Debtors' various pleadings and proposed treatment of unsecured creditor claims therefrom;
- g. preparing, or reviewing as applicable, avoidance action and claim analyses;
- h. assisting the Committee in reviewing the Debtors' financial reports, including, but not limited to, statements of financial affairs, schedules of assets and liabilities, DIP budgets, and monthly operating reports;
- i. advising the Committee on the current state of these chapter 11 cases;
- j. advising the Committee in negotiations with the Debtors and third parties as necessary;
- k. if necessary, participating as a witness in hearings before the Court with respect to matters upon which Force 10 has provided advice; and
- l. other activities as are approved by the Committee, the Committee's counsel, and as agreed to by Force 10.

NO ADVERSE INTEREST OF PROFESSIONALS

8. To the best of the Committee's knowledge and based upon the Kim Declaration attached hereto, neither Force 10 nor any of its employees have any connection with any party in interest, their attorneys or accountants.

9. To the best of the Committee's knowledge, neither Force 10, nor any of its employees represent any interest adverse to that of the Committee in the matters on which they are to be retained.

10. While Force 10 has undertaken, and continues to undertake, efforts to identify connections with the Debtors and other parties-in-interest, it is possible that connections with some parties-in-interest have not yet been identified. Should Force 10, through its continuing efforts, learn of any new connections of the nature described above, Force 10 will promptly file supplemental declarations, as required by Bankruptcy Rule 2014(a).

11. Force 10 represents many debtors, trustees, and committees in other bankruptcy cases, and the debtors, the members of those committees, or those estates may be creditors of the Debtors. However, Force 10 will not represent those debtors, committees, or their members with respect to any claims that they may collectively or individually have against the Debtors.

PROFESSIONAL COMPENSATION

12. The Committee desires to employ Force 10 and compensate Force 10 with reasonable fees to be determined by the Court. No compensation will be paid to Force 10 except upon compliance with the Bankruptcy Code, Bankruptcy Rules, Local Rules, the interim compensation procedures approved by this Court on March 6, 2023 (the “Interim Compensation Order”) and any other applicable procedures and orders of this Court.⁴ Force 10 has received no retainer in these cases to represent the Committee. Neither the Committee nor any of its members (or their representatives) are or will be liable for any fees or costs incurred by Force 10 in its representation of the Committee. The customary hourly rates, subject to periodic adjustments, charged by Force 10 professionals anticipated to be assigned to the Chapter 11 Cases are as follows:

13. The hourly rates set forth above are subject to periodic adjustments to reflect economic and other conditions. Force 10 intends to provide notice to the Debtors, the

Committee, and the U.S. Trustee before implementing any increases in Force 10's rates for professionals working on these chapter 11 cases.

14. In addition, Force 10 will bill for all out-of-pocket expenses reasonably and actually incurred by Force 10 in connection with the matters contemplated by this Application.

15. The Committee requests approval of the employment of Force 10 effective February 15, 2023. Such relief is warranted by the circumstances presented by these cases. The Committee's selection of Force 10 on February 15, 2023 necessitated that Force 10 immediately commence work on time-sensitive matters and promptly devote substantial resources to these cases pending submission and approval of this Application. Among other things, Force 10 was immediately required to address matters related to the Debtors' request to obtain post-petition financing, use of cash collateral and various other first-day motions.

16. No prior application for the relief requested herein has been presented to this Court or any other court.

NOTICE

17. Notice of this Application will be provided to: (a) the Debtors, 2451 Industry Avenue, Doraville, Georgia 30360 (Attn: Kristen McGuffey); (b) counsel to the Debtors, Weil Gotshal & Manges LLP, 700 Louisiana, Suite 1700, Houston, TX 77002 (Attn: Gabriel A. Morgan and Stephanie N. Morrison, Esq.) and 767 Fifth Avenue, New York, NY 10153 (Attn: Ray C. Schrock, Esq. and Alexander Welch, Esq.); (c) the United States Trustee; and (d) any other party entitled to notice pursuant to Local Rule 9013-1(d). Because of the nature of the relief requested, the Committee respectfully submits that no further notice of the Application is necessary or required under the circumstances.

WHEREFORE, the Committee requests that the Court enter the order (the “Order”) annexed hereto as **Exhibit A**, (i) approving the retention and employment of Force 10 as its financial advisor, effective February 15, 2023, to render services as described above with compensation to be paid as an administrative expense in such amounts as this Court may hereafter determine and allow pursuant to the Interim Compensation Order; and (ii) grant the Committee such other and further relief as the Court deems just and proper.

Upon the application (the “Application”)² of the Official Committee of Unsecured Creditors (the “Committee”) in the above-captioned chapter 11 cases for entry of an order authorizing the Committee to employ and retain Force Ten Partners, LLC (“Force 10”) as financial advisor effective February 15, 2023, the date the Committee determined to employ Force 10 as its financial advisor in these cases, pursuant to sections 328(a) and 1103(a) of title 11 of the United States Code (the “Bankruptcy Code”), Rule 2014 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and Rules 2014-1 and 2016-1 of the Local Bankruptcy Rules for the United States Bankruptcy Court for the Southern District of Texas (the “Local Rules”); and the Court having jurisdiction to consider the Application and the relief requested therein in accordance with 28 U.S.C. § 1334; and consideration of the Application and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper

notice of the Application having been provided, and it appearing that no other or further notice need be provided; and it appearing to the Court that the said Application should be approved, it is, therefore, ORDERED that:

1. The Application is granted as set forth herein.
2. Pursuant to sections 328 and 1103 of the Bankruptcy Code, Bankruptcy Rules 2014 and 2016, and Local Rules 2014-1 and 2016-1, the Committee is authorized to employ and retain Force 10 as financial advisor to the Committee effective February 15, 2023.
3. Force 10 shall apply for compensation for professional services rendered and reimbursement of expenses reasonably and actually incurred in connection with the Debtors' cases as set forth in the Application and in compliance with the applicable provisions of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, the Interim Compensation Order and any other applicable procedures and orders of this Court.
4. The Committee and Force 10 are authorized and empowered to take all actions necessary to implement the relief granted in this Order.
5. The Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order.

**DECLARATION OF EDWARD KIM IN SUPPORT OF
APPLICATION OF THE OFFICIAL COMMITTEE OF UNSECURED
CREDITORS OF SERTA SIMMONS BEDDING, LLC, *ET AL.* FOR ENTRY OF
AN ORDER AUTHORIZING AND APPROVING THE EMPLOYMENT OF
FORCE TEN PARTNERS, LLC AS FINANCIAL ADVISOR TO THE OFFICIAL
COMMITTEE OF UNSECURED CREDITORS EFFECTIVE FEBRUARY 15, 2023**

I, Edward Kim, declare under penalty of perjury pursuant to 28 U.S.C. § 1746 and pursuant to Rules 2014(a) and 2016(b) of the Federal Rules of Bankruptcy Procedure and Rules 2014-1 and 2016-1 of the Local Rules as follows:

1. I am a partner with Force Ten Partners, LLC ("Force 10"), which is a financial advisory firm with its principal office located at 5271 California Ave., Suite 270, Irvine, California 92617. Force 10 also has offices in the Los Angeles, Dallas, Las Vegas, and Miami metro areas. I am authorized to submit this declaration (the "Declaration") in support of the Application for Entry of an Order Authorizing and Approving the Employment of Force Ten Partners, LLC as Financial Advisor to the Official Committee of Unsecured Creditors Effective as of February 15, 2023 (the "Application").

2. Neither I, Force 10, nor any employee thereof, insofar as I have been able to ascertain, has any connection with the Debtors, their creditors, or any other parties in interest herein, or their respective attorneys and accountants, the U.S. Trustee, or any person employed in the office of the U.S. Trustee.

3. This Declaration is submitted pursuant to sections 327(a) and 1103(a) of title 11 of the United States Code (the “Bankruptcy Code”), Rule 2014 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and Rules 2014-1 and 2016-1 of the Local Bankruptcy Rules for the United States Bankruptcy Court for the Southern District of Texas (the “Local Rules”) in support of the Application for the entry of an order approving the retention of Force 10 as financial advisor to the Committee, effective February 15, 2023.

4. In connection with its proposed retention by the Committee in these chapter 11 cases, Force 10 undertook a lengthy review to determine whether it had any conflicts or other relationships that might cause it not to be disinterested or to hold or represent an interest adverse to the Debtors. Specifically, Force 10 obtained from the Debtors and/or their representatives the names of individuals and entities that may be parties in interest in these chapter 11 cases (“Potential Parties in Interest”). Such parties are listed on **Exhibit 1** attached hereto. A search was performed for connections to the Potential Parties in Interest within the past three (3) years. Based on a review of the search performed on the Potential Parties in Interest, Force 10 represents that, to the best of its knowledge, Force 10 knows of no fact or situation that would represent a conflict of interest for Force 10 with regard to the Debtors.

5. Force 10 are advisors and crisis managers providing services and advice in many areas, including restructuring and distressed debt. As part of its diverse practice, Force 10 appears in numerous cases, proceedings, and transactions involving many different attorneys,

accountants, investment bankers, and financial consultants, some of whom may represent claimants and parties in interest in these chapter 11 cases. Further, Force 10 has in the past, and may in the future, be represented by various attorneys and law firms, some of whom may be involved in these chapter 11 cases. In addition, Force 10 has been in the past, and likely will be in the future, engaged in matters unrelated to the Debtors or these chapter 11 cases in which it works with or in opposition to other professionals involved in these chapter 11 cases. Moreover, Force 10 might have referred work to other professionals who are retained in these chapter 11 cases. Likewise, certain such professionals who are retained in these chapter 11 cases might have referred work to Force 10. To the best of my knowledge, information, and belief, insofar as I have been able to ascertain after reasonable inquiry, none of these business relationships constitute interests adverse to the Debtors.

6. To the best of my knowledge, information and belief, insofar as I have been able to ascertain after reasonable inquiry, none of Force 10's personnel (a) have any connection with the U.S. Trustee, or any employee in the Office of the U.S. Trustee; or (b) are related or connected to any United States Bankruptcy Judge for the Southern District of Texas.

7. Force 10 is not a "creditor" of the Debtors within the meaning of Bankruptcy Code section 101(10). Further, neither I nor any other member of the Force 10 engagement team serving the Committee, to the best of my knowledge (a) is a creditor, equity security holder, or insider of any of the Debtors; (b) is or has been within two years before the Petition Date, a director, officer, or employee of any of the Debtors; or (c) has any interest materially adverse to the interests of the Debtors' estates or of any class of creditors or equity security holders, by reason of any direct or indirect relationship to, connection with, or interest in, the Debtors, or for any other reason. As such, to the best of my knowledge and based upon the results of the relationship search described above and disclosed herein, Force 10 (i) is a

“disinterested person” as defined in Bankruptcy Code section 101(14) and (ii) neither holds nor represents an interest adverse to the Debtors or their estates. Therefore, Force 10 believes it is eligible to represent the Committee under Bankruptcy Code section 327(a).

8. Based on the result of Force 10’s search, I have been able to ascertain after diligent inquiry that to the best of my knowledge, Force 10 (i) does not represent any entity having an adverse interest in connection with these chapter 11 cases and (ii) does not represent or hold an interest adverse to the interest of the Debtors or its estate with respect to the matters on which Force 10 is to be employed. Moreover, Force 10 is disinterested within the meaning of section 101(14) of the Bankruptcy Code, in that neither I, Force 10, nor any of its partners, employees (including those working on this engagement) or associates:

- a. are creditors, equity security holders or insiders of the Debtors;
- b. are or were within two years before the Petition Date, a director, officer or employee of the Debtors;
- c. have an interest materially adverse to the interest of the estate or of any class of creditors or equity security holders, by reason of any direct or indirect relationship to, connection with or interest in the Debtors or for any other reason; or
- d. hold any debt or equity securities of the Debtors.

9. To the best of my knowledge, information and belief formed after reasonable inquiry, neither I, nor any partner, managing director, director, analyst, or staff member of Force 10, insofar as I have been able to ascertain, is related to the bankruptcy judge assigned to the above-captioned chapter 11 cases.

10. To the best of my knowledge, information and belief formed after reasonable inquiry, neither I, nor any partner, managing director, director, analyst or staff

member of Force 10, insofar as I have been able to ascertain, has a connection to the United States Trustee or any person employed in the office of the United States Trustee.

11. Despite the substantial efforts described above to identify and disclose potential conflicts and connections with parties-in-interest in these cases, neither I nor Force 10 can conclusively identify all potential relationships or state with absolute certainty that every client representation or other connection of Force 10 has been disclosed. To the extent Force 10 discovers any facts or additional information during the period of Force 10's retention that requires disclosure, Force 10 will supplement this Declaration to disclose such information.

12. Force 10 has not received any retainer or payment from the Debtors or the Committee, nor has it received any promise of payment, during the one-year period prior to the filing of the Debtors' petition. No compensation has been paid or promised to be paid from a source other than the Debtors' estates in these chapter 11 cases. No promises have been received by Force 10 nor by any advisors or attorneys thereof as to compensation in connection with these chapter 11 cases other than in accordance with the provisions of the Bankruptcy Code. Force 10 has no agreement with any other entity to share with such entity any compensation received by Force 10 in connection with these chapter 11 cases, except among employees of Force 10. Neither the Committee nor its members (or any of their representatives) are or will be liable for fees or costs incurred by Force 10 in its representation of the Committee.

13. Force 10 intends to apply for compensation for professional services rendered in connection with these chapter 11 cases subject to approval of this Court as stated in the Application, and in compliance with applicable provisions of the Bankruptcy Code, on an hourly basis, plus reimbursement of actual, necessary expenses and other charges incurred by Force 10.

14. The customary hourly rates, subject to periodic adjustments, charged by Force 10 professionals anticipated to be assigned to the Chapter 11 Cases are as follows:

15. The hourly rates set forth above are subject to periodic adjustments to reflect economic and other conditions. Force 10 intends to provide notice to the Debtors, the Committee, and the U.S. Trustee before implementing any increases in Force 10's rates for professionals working on these chapter 11 cases.

16. In addition to the fees described above, Force 10 will bill for all out-of-pocket expenses reasonably and actually incurred by Force 10 in connection with the matters contemplated by this Application.
