The Official Committee of Unsecured Creditors (the "<u>Committee</u>") of Invacare Corporation, *et al*, (the "<u>Debtors</u>") submit this application (the "<u>Application</u>"), pursuant to sections 328(a) and 1103(a) of title 11 of the United States Code (the "<u>Bankruptcy Code</u>"), Rule 2014 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>") and Rule 2014-1 of the Local Rules of Bankruptcy Practice and Procedure for the United States Bankruptcy Court for the Southern District of Texas (the "<u>Local Rules</u>"), for entry of an order, substantially in the form attached hereto as <u>Exhibit A</u>, authorizing the Committee to retain and employ Province, LLC ("<u>Province</u>") as its financial advisor in connection with the Debtors' chapter 11 case (the "<u>Chapter 11 Cases</u>"), effective as of February 24, 2023. In support of this Application, the Committee submits the declaration of Adam Rosen, a principal of Province (the "<u>Rosen</u>

<u>Declaration</u>"), attached hereto as <u>Exhibit B</u>, respectively. In further support of this Application, the Committee respectfully represents as follows:

JURISDICTION AND VENUE

1. The United States Bankruptcy Court for the Southern District of Texas (the "<u>Court</u>") has jurisdiction over this Application pursuant to 28 U.S.C. § 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).

2. Venue in this Court is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

3. The statutory and rule predicates for the relief requested herein are Bankruptcy Code sections 328(a) and 1103, Bankruptcy Rule 2014 and Local Rule 2014-1.

BACKGROUND

4. On January 31, 2023 (the "<u>Petition Date</u>"), the Debtors filed a voluntary petition for relief pursuant to chapter 11 of the Bankruptcy Code.

5. The Debtors continue to operate its business as a debtor in possession pursuant to Bankruptcy Code sections 1107(a) and 1108. No request has been made for the appointment of a trustee or an examiner.

6. On February 17, 2023, pursuant to section 1102 of the Bankruptcy Code, the United States Trustee for Region 7 (the "<u>U.S. Trustee</u>") appointed six creditors to serve on the Committee in connection with these chapter 11 cases. On February 21, 2023, the U.S. Trustee removed two creditors and added one additional creditor to serve on the Committee. The members of the Committee are: (i) Wilmington Trust, National Association as Successor Trustee; (ii) Birlasoft Solutions Inc.; (iii) Rhenus Logistics China Ltd-Xiamen Branch; (iv) Changzhou Dade Machinery Co., Ltd.; and (v) New Prokin (Zhongshan) Ltd.

7. On February 24, 2023 (the "<u>Retention Date</u>"), the Committee, in connection with the exercise of its powers and the performance of the duties conferred upon it pursuant to section 1103 of the Bankruptcy Code, selected Province to serve as its financial advisor.

RELIEF REQUESTED

8. The Committee seeks to retain and employ Province as its financial advisor, pursuant to Bankruptcy Code sections 328(a) and 1103(a), Bankruptcy Rule 2014 and Local Rule 2014-1, effective as of February 24, 2023.

9. The Committee believes that the employment of Province effective as of February 24, 2023, the date the Committee selected Province as its proposed financial advisor, is warranted under the circumstances of this Chapter 11 Case. Upon its selection, the Committee requested Province to commence work immediately on time-sensitive matters and devote substantial resources to this Chapter 11 Case prior to the submission and approval of this Application. Thus, Province has provided, and will continue to provide, valuable services to the Committee. Furthermore, Local Rule 2014-1(b)(1) provides that an application for approval of employment made within thirty (30) days of the commencement of the provision of services is deemed contemporaneous.

RETENTION OF PROVINCE

10. The Committee respectfully submits that it is necessary and appropriate for it to retain and employ Province to assist the Committee by, among other things:

- (a) becoming familiar with and analyzing the Debtors' budget, assets and liabilities, and overall financial condition;
- (b) reviewing financial and operational information furnished by the Debtors;
- (c) monitoring the sale process, reviewing bidding procedures, stalking horse bids, asset purchase agreements, interfacing with the Debtors' professionals, and advising the Committee regarding the process;
- (d) scrutinizing the economic terms of various agreements, including, but not limited to, the Debtors' KEIP and KERP and various professional retentions;

- (e) analyzing the Debtors' proposed business plans and developing alternative scenarios, if necessary;
- (f) assessing the Debtors' various pleadings and proposed treatment of unsecured creditor claims therefrom;
- (g) preparing, or reviewing as applicable, avoidance action and claim analyses;
- (h) assisting the Committee in reviewing the Debtors' financial reports, including, but not limited to, statements of financial affairs, schedules of assets and liabilities, and monthly operating reports;
- (i) advising the Committee on the current state of these chapter 11 cases;
- (j) advising the Committee in negotiations with the Debtors and third parties as necessary;
- (k) if necessary, participating as a witness in hearings before the Court with respect to matters upon which Province has provided advice; and
- (1) other activities as are approved by the Committee, the Committee's counsel, and as agreed to by Province.
- (m) perform such other services as may be required or are otherwise deemed to be in the interests of the Committee in accordance with the Committee's powers and duties as set forth in the Bankruptcy Code, Bankruptcy Rules or other applicable law.

11. Province has extensive experience representing official creditors' committees,

debtors, creditors, trustees, and others in a wide variety of bankruptcy cases, including, as (i) financial advisor to the official committees of unsecured creditors in the A.B.C. Carpet, Alex and Ani, Armstrong Flooring, Ascena Group, Avadim Health, BL Restaurants Holding, Carbonlite Holdings, Cherry Man Industries, Cyprus Mines, DCL Holdings (USA), Destination Maternity, Eastern Outfitters, EHT US1 (Eagle Hospitality), Endo International, Francesca's Holding Corporation, Honx, Insys Therapeutics, J Crew, Lucky's Market, L'Occitane, Mallinckrodt, Neopharma, One Web, Papyrus, Path Medical, Pier 1, PBS Brand Co. (Punch Bowl), Purdue Pharma, Reverse Mortgage, Revlon, Stage Stores, TECT Aerospace Group, True Religion Apparel, and White Stallion Energy matters; (ii) financial advisor to the debtors in 4E Brands, Basic Energy Services, Cherry Man Industries, Cinemex Holdings USA, Coin Cloud, Frontsight Management, Penthouse Global Media, Superior Linen, True Religion Apparel, Vesta Holdings, and Woodbridge Group of Companies; and (iii) the trustee in Aegean Marine Petroleum, Advance

Watch, American Apparel, Borden Dairy, CS Mining, Cycle Force, EBH Topco, Eclipse Berry Farms, Energy & Exploration (ENXP), Fieldwood, Gump's, La Paloma Generating Company, Limetree Bay Services, Mallinckrodt, Maxus Energy, Neogenix, PBS Brand Co. (Punch Bowl), Promise Healthcare Group, RadioShack Corporation, and Samson Resources among others.

12. Because of the financial advisory services that the Committee requires in connection with the Chapter 11 Cases, and the fact that the full nature and extent of such services are not known at this time, the Committee believes that the employment of Province to provide the services described above and such other services as may be necessary for the Committee to satisfy its obligations the Debtors' unsecured creditors is appropriate and in the best interests of the Debtors' estate and its unsecured creditors.

PROFESSIONAL COMPENSATION

13. The Committee desires to employ Province and compensate Province with reasonable fees to be determined by the Court. No compensation will be paid to Province except upon compliance with the Bankruptcy Code, Bankruptcy Rules, Local Rules, and any other applicable procedures and orders of this Court. Province has received no retainer in these cases to represent the Committee. Neither the Committee nor any of its members (or their representatives) are or will be liable for any fees or costs incurred by Province in its representation of the Committee. Province's standard hourly rates are:

14. The hourly rates set forth above are subject to periodic adjustments to reflect economic and other conditions. Province intends to provide notice to the Debtors, the Committee, and the U.S. Trustee before implementing any increases in Province's rates for professionals working on these chapter 11 cases.

15. In addition, Province will bill for all out-of-pocket expenses reasonably and actually incurred by Province in connection with the matters contemplated by this Application.

NO ADVERSE INTEREST

16. Upon information and belief, Province does not represent and does not hold any interest adverse to the Debtors' estate or its creditors in the matters upon which Province is to be engaged, except to the extent set forth in the Rosen Declaration.

NO PRIOR REQUEST

17. No prior request for the relief sought herein has been made to this Court or any other court.

NOTICE

18. Notice of this Application has been served on the Debtors' current Master Service List, including: (i) the Office of the United States Trustee for the Southern District of Texas; (ii) the Debtors; (iii) the Debtors' prepetition secured lenders, collateral agents, and administrative agents; (iv) the ad hoc group of holders of the Debtors' unsecured convertible notes; (v) Highbridge Capital Management, LLC; (vi) Azurite Management LLC; (vii) the Debtors' debtor in possession financing lenders; (viii) the Internal Revenue Service; (ix) the Securities and Exchange Commission; (x) the United States Attorney for the Southern District of Texas; (xi) the state attorneys general for states in which the Debtors conduct business; (xii) the FDA; and (xiii) all

parties in interest who have formally appeared and requested notice. The Committee respectfully submits that no further notice of this Motion is required.

CONCLUSION

section 101(14), as modified by Bankruptcy Code section 1107(b), that its employment is necessary and in the best interests of the Committee and the Debtors' estate; and finding that adequate notice of the Application having been given; and it appearing that no other notice need be given; and after due deliberation and sufficient cause appearing therefor, it is hereby

ORDERED THAT:

1. The relief requested in the Application is granted as set forth herein.

2. In accordance with Bankruptcy Code sections 328 and 1103(a) and Bankruptcy Rule 2014(a), the Committee is hereby authorized and empowered to retain and employ Province as its financial advisor to represent it in this Chapter 11 Case and related matters and proceedings on the terms set forth in the Application and the Rosen Declaration, as modified herein, effective as of February 24, 2023.

3. Province shall be compensated in accordance with the procedures set forth in Bankruptcy Code sections 330 and 331, the applicable Bankruptcy Rules, the applicable Local Rules, and any other applicable order of the Court. Province shall also make a reasonable effort to comply with the U.S. Trustee's requests for information and additional disclosures as set forth in the Revised UST Guidelines in connection with interim and final fee applications to be filed by Province in this Chapter 11 Case. For billing purposes, Province shall keep its time in one tenth (1/10) hour increments in accordance with the Revised UST Guidelines.

4. The hourly rates set forth above are subject to periodic adjustments to reflect economic and other conditions. Province intends to provide notice to the Committee and the U.S. Trustee before implementing any increases in Province's rates for professionals working on these chapter 11 cases.

5. Province will review its files periodically during the pendency of this Chapter 11 Case to ensure that no conflicts or other disqualifying circumstances exist or arise. If any new relevant facts or relationships are discovered or arise, Province will use reasonable efforts to identify such further developments and will promptly file a supplemental declaration, as required by Bankruptcy Rule 2014(a).

6. The Committee is authorized to take all actions necessary to effectuate the relief granted pursuant to this order in accordance with the Application.

7. To the extent the Application or the Rosen Declarations are, inconsistent with this Order, the terms of this Order shall govern.

8. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

9. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation of this Order.

DECLARATION OF ADAM ROSEN IN SUPPORT OF APPLICATION OF THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS TO RETAIN AND EMPLOY PROVINCE, LLC <u>AS FINANCIAL ADVISOR, EFFECTIVE AS OF FEBRUARY 24, 2023</u>

I, Adam Rosen, declare under penalty of perjury pursuant to 28 U.S.C. § 1746 and pursuant to Rules 2014(a) and 2016(b) of the Federal Rules of Bankruptcy Procedure and Rule 2014-1 of the Local Rules as follows:

1. I am a principal with Province, LLC ("<u>Province</u>"), which is a financial advisory firm with its principal office located at 2360 Corporate Circle, Suite 340, Henderson, Nevada 89074. Province also has offices in the Baltimore, Los Angeles, Miami and Stamford metro areas. I am authorized to submit this declaration (the "<u>Declaration</u>") in support of the Application for Entry of an Order Authorizing and Approving the Employment of Province, LLC as Financial Advisor to the Official Committee of Unsecured Creditors Effective as of February 24, 2023 (the "Application").

2. Province's corporate structure, including its parent entities, affiliates, and subsidiaries, is as follows: Province, LLC is a Delaware limited liability company, and Province's

sole subsidiary, which is wholly-owned, is Province Fiduciary Services, LLC, a Nevada limited liability company. All of the membership interests in Province, LLC are held by Province Holdings, Inc., a Delaware corporation ("<u>Holdco</u>"), and Province Management, LLC, a Delaware limited liability company ("<u>Management Holdco</u>"). Neither Holdco, Management Holdco, nor any Province subsidiary (i) has any employees, (ii) has any connection to the Debtors or any person listed on the Entity List (defined below), (iii) has any physical or electronic access to Province's physical or electronically stored information; (iv) will be involved in this engagement; nor (v) have they been engaged to advise the Debtors, the Official Committee of Unsecured Creditors (the "<u>Committee</u>"), or any other party in interest in connection with these chapter 11 proceedings. Additionally, all Province conflicts checks and related disclosures include any connections of each of Province's subsidiary, Holdco, and Management Holdco.

3. Neither I, Province, nor any employee thereof, insofar as I have been able to ascertain, has any connection with the Debtors, their creditors, or any other parties in interest herein, or their respective attorneys and accountants, the U.S. Trustee, or any person employed in the office of the U.S. Trustee, except as set forth herein.

4. This Declaration is submitted pursuant to sections 328 and 1103 of Title 11 of the United States Code (the "<u>Bankruptcy Code</u>"), Rules 2014 and 2016 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), and Rules 2014-1 and 2016-1 of the Local Bankruptcy Rules of the United States Bankruptcy Court for the District of Delaware (the "<u>Local Bankruptcy Rules</u>") in support of the Application for the entry of an order approving the retention of Province as financial advisor to the Official Committee of Unsecured Creditors (the "<u>Committee</u>"), effective February 24, 2023.

5. In connection with its proposed retention by the Committee in these chapter 11 cases and in preparing this Declaration, Province used a set of procedures developed to ensure full compliance with the requirements of the Bankruptcy Code and the Federal and Local Bankruptcy Rules regarding the retention of professionals (the "<u>Retention Procedures</u>"). Pursuant to the Retention Procedures, and under my direction and supervision, Province researched its client connections database, which includes all engagements that concluded within the past twenty-four (24) months, to determine whether it has relationships with any of the entities that were identified to Province as creditors or parties-in-interest in these chapter 11 cases (the "<u>Entity List</u>") attached hereto as <u>Schedule 1</u>. To the extent such a search indicated that Province has a relationship with any of the entities on the Entity List, the identities of such entities and Province's relationship with such entities is disclosed in the attached <u>Schedule 2</u>.

6. Creditors Adjustment Bureau (CAB Collects), which is the US agent for vendor and supplier New Prokin (Zhongshan), has represented other creditors in past Chapter 11 cases in which Province has been retained as Financial Advisor to various unsecured creditors' committees. Additionally, CAB Collects has represented bankruptcy estates and subsequent trusts (in which Province was also retained) in collections of default judgments primarily in preference actions. Additionally, CAB Collects has represented entities unaffiliated with Province or its principals that have both successfully and unsuccessfully bid on remnant asset auctions that were administered by separate counsel in which Province was also retained.

7. Province sent an email questionnaire to each employee inquiring as to whether each employee or any member(s) of his or her household:

- i. owns any debt or equity securities of the Debtors or their non-debtor affiliates;
- ii. holds a claim against or interest adverse to the Debtors or their non-debtor

affiliates;

- iii. is or was an officer, director, or employee of the Debtors or their non-debtor affiliates;
- iv. is related to or has any connections to any Bankruptcy Judge in the United States Bankruptcy Court for the Southern District of Texas, Houston Division;
- v. is related to or has any connections to anyone working in the Office of the United States Trustee for the Southern District of Texas, Houston Division;
- vi. was an officer, director or employee of the Debtors within two years prior to the Petition Date; or
- vii. has a connection with a party in interest listed on the Entity List.
- 8. Province did not receive any responses to the above inquiry.

9. Based on the result of that search and employee questionnaire, I have been able to ascertain after diligent inquiry that to the best of my knowledge, Province (i) does not represent any entity having an adverse interest in connection with these chapter 11 cases and (ii) does not represent or hold an interest adverse to the interest of the Debtors or its estate with respect to the matters on which Province is to be employed. Moreover, Province and its subsidiaries are disinterested within the meaning of section 101(14) of the Bankruptcy Code, in that neither I, Province, any Province subsidiary, nor any of their principals, employees (including those working on this engagement) or associates:

- a. are creditors, equity security holders or insiders of the Debtors;
- b. are or were within two years before the Petition Date, a director, officer or employee of the Debtors;
- c. have an interest materially adverse to the interest of the estate or of any class of creditors or equity security holders, by reason of any direct or indirect relationship to, connection with or interest in the Debtors or for any other reason; or
- d. hold any debt or equity securities of the Debtors.

10. As a part of Province's financial advisory practice, Province's clientele includes: debtors, creditors and other statutory committees, institutional creditors, asset purchasers, venture

capitalists, secured parties, lessors, contract parties, equity holders, directors and officers, courtappointed fiduciaries, plan sponsors, indenture trustees, and bond insurers. The Debtors have numerous creditors and other parties-in-interest. Province may have in the past represented, and may presently or in the future represent or be deemed adverse to, creditors or parties-in-interest in addition to those specifically disclosed in <u>Schedule 2</u> in matters unrelated to these chapter 11 cases. Province believes that its representation of such creditors or other parties in such other matters has not affected and will not affect its representation of the Committee in these proceedings.

11. Except as otherwise set forth herein and in <u>Schedule 2</u>, insofar as I have been able to ascertain, the principals, associates and staff members of Province do not have any connection with the Debtors, the Debtors' officers and directors, the Debtors' creditors, the Debtors' equity security holders and other known parties-in-interests or their respective professionals.

12. To the best of my knowledge, information and belief formed after reasonable inquiry, neither I, nor any principal, associate or staff member of Province, insofar as I have been able to ascertain, is related to the bankruptcy judge assigned to the above-captioned chapter 11 cases.

13. To the best of my knowledge, information and belief formed after reasonable inquiry, neither I, nor any principal, associate or staff member of Province, insofar as I have been able to ascertain, has a connection to the United States Trustee or any person employed in the office of the United States Trustee.

14. Despite the substantial efforts described above to identify and disclose potential conflicts and connections with parties-in-interest in these cases, neither I nor Province is able to conclusively identify all potential relationships or state with absolute certainty that every client representation or other connection of Province has been disclosed. To the extent Province

discovers any facts or additional information during the period of Province's retention that requires disclosure, Province will supplement this Declaration to disclose such information.

15. Province has neither received any retainer nor any payment from the Debtors nor the Committee, nor has it received any promise of payment, during the one-year period prior to the filing of the Debtors' petition. No compensation has been paid or promised to be paid from a source other than the Debtors' estates in these chapter 11 cases. No promises have been received by Province nor by any advisors or attorneys thereof as to compensation in connection with these chapter 11 cases other than in accordance with the provisions of the Bankruptcy Code. Province has no agreement with any other entity to share with such entity any compensation received by Province in connection with these chapter 11 cases, except among employees of Province. Neither the Committee nor its members (or any of their representatives) are or will be liable for fees or costs incurred by Province in its representation of the Committee.

16. Province intends to apply for compensation for professional services rendered in connection with these chapter 11 cases subject to approval of this Court as stated in the Application, and in compliance with applicable provisions of the Bankruptcy Code, on an hourly basis, plus reimbursement of actual, necessary expenses and other charges incurred by Province.

17. Province's standard hourly rates are:

19. In addition to the fees described above, Province will bill for all out-of-pocket expenses reasonably and actually incurred by Province in connection with the matters contemplated by this Application.
