#### ORDER

The Plaintiff initiated this adversary proceeding by filing a complaint on April 27, 2022. [ECF No. 1.] The Defendant filed an answer on February 27, 2023. [ECF No. 4.] The Answer is signed by Peter A. Ianuzzi, J.R. as the C.E.O. of the Defendant.

The Plaintiff moved to strike the Answer because the Defendant is not represented by counsel. [ECF No. 5.] Corporations may not appear in federal court except through a licensed attorney. *See Rowland v. Calif. Men's Colony, Unit II Men's Advisory Council*, 506 U.S. 194, 202 (1993); *see also Doherty v. Am. Motors Corp.*, 728 F.2d 334, 340 (6th Cir. 1984); *Statewide Envtl. Servs., Inc. v. Fifth Third Bank*, 352 S.W.3d 927, 929 (Ky. Ct. App. 2011). A hearing was held on April 27, 2023, and the motion was granted. [ECF No. 8, 10, 12.] The Order granting the Motion to Strike also gives the Defendant an additional 30 days to obtain counsel and file a response to the Complaint. [ECF No. 12.]

The Defendant now seeks an additional 90 days to obtain counsel. [ECF No. 11.] The Motion for an Extension is signed by Mr. Ianuzzi. [*Id.*] Mr. Ianuzzi cannot represent the
