**FINAL DECREE CLOSING NOBLE HOLDING CORPORATION PLC’S CHAPTER 11
CASE AND CONCLUDING THESE BANKRUPTCY CASES**

[Related Docket No. 1279]

Upon the Motion² of the Reorganized Debtors for the entry of this final decree (“Final Decree”) closing the remaining chapter 11 case (the “Lead Case”); the Court having reviewed the Motion and having heard the statements of counsel regarding the relief requested in the Motion at a hearing before the Court, if any, (the “Hearing”); and the Court having found that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334(b) and the Amended Standing Order; (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (c) it may enter a final order consistent with Article III of the United States Constitution; (d) venue is proper before the Court pursuant to 28 U.S.C. § 1408; and (e) due and proper notice of the Motion and the Hearing was sufficient under the circumstances; and the Court having found that the relief

requested in the Motion is in the best interests of the Debtors’ estates, their creditors, and other parties-in-interest; and the Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein and that such relief is in the best interests of the Debtors, their estates, creditors, and all parties-in-interest; now, therefore,

IT IS HEREBY ORDERED THAT:

1. Pursuant to section 350(a) of the Bankruptcy Code and Bankruptcy Rule 3022, the following case is hereby closed, effective as of the date of entry of this Final Decree, provided that this Court shall retain jurisdiction as provided in the *Order Confirming The Modified Second Amended Joint Plan Of Reorganization Of Noble Corporation plc (n/k/a Noble Holding Corporation plc) And Its Debtor Affiliates* [Docket No. 723] (the “Confirmation Order”) and this Final Decree:

2. Entry of this Final Decree is without prejudice to (a) the rights of any party-in-interest, including the Debtors, to seek to reopen the Lead Case for cause shown and (b) the rights of the Reorganized Debtors to dispute any Claim that was filed against the Reorganized Debtors in these chapter 11 Cases as contemplated by the Plan and the Confirmation Order.

3. Nothing in this Final Decree shall change the amount or nature of any distribution, or any other substantive rights, that any claim against or interest in any Reorganized Debtor would have been entitled to under the Plan, the Confirmation Order, the Bankruptcy Code, the Bankruptcy Rules, or otherwise had this Final Decree not been entered.

4. The Reorganized Debtors, no later than thirty (30) days after the date of entry of the Final Decree, shall file a post-confirmation report for the first and second quarters of 2023

through the date of entry of the Final Decree and shall serve a true and correct copy of said statements on the U.S. Trustee.

5. The Reorganized Debtors shall pay the appropriate sum of quarterly fees due and payable under 28 U.S.C. §§ 1930(a)(6)(A) and (B) in connection with the Chapter 11 Cases. This Court shall retain jurisdiction to enforce of fees assessed under 28 U.S.C. §§ 1930(a)(6)(A) and (B).

6. The claims and noticing services (the “Claims and Noticing Services”) provided by Epiq Corporate Restructuring, LLC (“Epiq”) for the Chapter 11 Cases pursuant to the Order Appointing Epiq Corporate Restructuring, LLC as Claims, Noticing, Solicitation, and Administrative Agent [Docket No. 67] are terminated and Epiq shall have no further obligations to this Court, the Reorganized Debtors, or any other party in interest with respect to the Claims and Noticing Services in the Chapter 11 Cases.

7. Notwithstanding the relief granted in this Final Decree and any actions taken pursuant to such relief, nothing in this Final Decree shall be deemed: (a) an admission as to the amount of, basis for, or validity of any claim against a Debtor entity under the Bankruptcy Code or other applicable nonbankruptcy law; (b) a waiver of the Debtors’, Reorganized Debtors’ or any other party in interest’s right to dispute any claim on any grounds; (c) a promise or requirement to pay any claim; (d) an implication or admission that any particular claim is of a type specified or defined in the Motion or any order granting the relief requested by the Motion or a finding that any particular claim is an administrative expense claim or other priority claim; (e) a request or authorization to assume, adopt, or reject any agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; (f) an admission as to the validity, priority, enforceability, or perfection of any lien on, security interest in, or other encumbrance on property of the Debtors’ estates; (g) a

waiver or limitation of the Debtors', Reorganized Debtors' or any other party in interest's, rights under the Bankruptcy Code or any other applicable law; or (h) a concession by the Reorganized Debtors that any liens (contractual, common law, statutory, or otherwise) that may be satisfied pursuant to the relief requested in the Motion are valid, and the rights of all parties in interest are expressly reserved to contest the extent, validity, or perfection or seek avoidance of all such liens.

8. The Reorganized Debtors and their agents are authorized to take all actions necessary to implement the relief granted in this Final Decree.

9. Notwithstanding any provision in the Federal Rules of Bankruptcy Procedure to the contrary, the terms and conditions of this Final Decree shall be immediately effective and enforceable upon its entry.

10. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Final Decree.
