On May 16, 2023], the United States Bankruptcy Court for the Southern District of Texas (the "Court"), having jurisdiction over the chapter 11 cases of Athenex, Inc. ("ATNX"), and its affiliates (collectively, the "Debtors"), captioned as *In re Athenex, Inc., et al.*, Case No. 23-90295 (DRJ) (the "Chapter 11 Cases"), entered an order establishing procedures (the "Stock Procedures") with respect to (i) transfers in the beneficial ownership (including directly or indirectly) of, and claiming a worthless stock deduction with respect to the beneficial ownership of, stock of the Debtors ("ATNX Stock") and options to acquire beneficial ownership of ATNX Stock. *See Order (I) Establishing Notification Procedures and Approving Restrictions on (A) Certain Transfers of Interests in Debtors and (B) Certain Worthless Stock Deduction Claims; and (II) Granting Related Relief* [Docket No. 65] (the "Order").²

In certain circumstances, the procedures restrict transactions involving, and require notices of the holdings of and proposed transactions by, any person, group of persons, or entity that either (i) is a Substantial Stockholder of ATNX Stock or (ii) as a result of such a transaction, would become a Substantial Stockholder of ATNX Stock or (iii) claims by any Majority Holder of a worthless stock deduction under section 165 of the Internal Revenue Code with respect to the beneficial ownership of ATNX Stock (a "Worthless Stock Deduction"). For purposes of the Stock Procedures, a "Substantial Stockholder" is any person or entity (within the meaning of applicable U.S. Treasury regulations, including certain persons making a coordinated acquisition) that beneficially owns at least 413,903 shares of ATNX Stock (representing approximately 4.75% of all issued and outstanding common shares as of the Petition Date (approx. 8,713,754 shares)), or and a "Majority Holder" shall mean any person that either (i) beneficially owned at any time since December 31, 2019 at least 1,743,882 shares of ATNX Stock (representing approximately 45.0% of the lowest amount of outstanding shares of ATNX Stock at any time since that date (approx. 3,875,294 shares)), or (ii) would be a "50-percent shareholder" (within the meaning of section 382(g)(4)(D) of the Tax Code) of ATNX Stock if such person claimed a Worthless Stock Deduction on its federal income tax return at any time on or after the Petition Date. Any prohibited acquisition or other transfer of, or claim of a Worthless Stock Deduction with respect to, ATNX Stock (including options to acquire beneficial ownership of ATNX Stock) will be null and void ab initio and may lead to contempt, compensatory damages, punitive damages, or sanctions being imposed by the Bankruptcy Court.

In addition, the Debtors have requested approval of additional Claims Procedures, to be considered at a continuation of the hearing, that set forth certain circumstances under which any person, group of persons, or entity that has acquired or, as a result of a proposed transaction would acquire, beneficial ownership of a substantial amount of claims against the Debtors can be required (i) to file notice of their holdings of such claims and of such proposed transaction, which transaction
