INTRODUCTION

Envistacom, L.L.C., as debtor and debtor-in-possession in the above-captioned case (the "<u>Debtor</u>"), is filing its Schedules of Assets and Liabilities (each, a "<u>Schedule</u>" and, collectively, the "<u>Schedules</u>") and Statement of Financial Affairs (the "<u>SOFA</u>") with the United States Bankruptcy Court for the Northern District of Georgia, Atlanta Division (the "<u>Bankruptcy Court</u>") pursuant to section 521 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>") and Rule 1007 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>").

These global notes and statement of limitations, methodology, and disclaimers regarding the Debtor's Schedules and Statement (collectively, the "<u>Global Notes</u>") pertain to, are incorporated by reference in, and comprise an integral part of all of the Schedules and SOFA. The Global Notes are in addition to the specific notes set forth below with respect to particular Schedules and SOFA (the "<u>Specific Notes</u>" and, together with the Global Notes, the "<u>Notes</u>"). These Notes should be referred to, and referenced in connection with, any review of the Schedules and SOFA.

The Debtor prepared the Schedules and SOFA with the assistance of its advisors and professionals and has relied upon the efforts, statements, advice, and representations of personnel of the Debtor and the Debtor's advisors and professionals. Given the scale of the Debtor's business, Katie S. Goodman, the Debtor's Chief Liquidation Officer, who has executed the Schedules and SOFA of the Debtor, has necessarily relied upon the prior efforts, statements, and representations of former employees and professionals of the Debtor and has not (and practically could not have) personally verified the accuracy of each statement and representation in the Schedules and SOFA,

including, but not limited to, statements and representations concerning amounts owed to creditors, classification of such amounts, and creditor addresses.

While the Debtor has made reasonable efforts under the circumstances to ensure that the Schedules and SOFA are accurate and complete based upon information that was available to it at the time of preparation, inadvertent errors or omissions may exist. Moreover, because the Schedules and SOFA contain unaudited information, which is subject to further review and potential adjustment, there can be no assurance that the Schedules and SOFA are complete or accurate.

The Debtor and its past or present directors, officers, employees, attorneys, professionals, and agents (including, but not limited to, the Chief Liquidation Officer), do not guarantee or warrant the accuracy, completeness, or currentness of the data that is provided herein and shall not be liable for any loss or injury arising out of or caused in whole or in part by the acts, errors or omissions, whether negligent or otherwise, in procuring, compiling, collecting, interpreting, reporting, communicating or delivering the information contained herein. The Debtor and its past or present officers, employees, attorneys, professionals, and agents (including, but not limited to, the Chief Liquidation Officer) expressly do not undertake any obligation to update, modify, revise or re-categorize the information provided herein or to notify any third party should the information be updated, modified, revised or re-categorized. In no event shall the Debtor or its past or present officers, employees, attorneys, professionals and/or agents (including, but not limited to, the Chief Liquidation Officer) be liable to any third party for any direct, indirect, incidental, consequential or special damages (including, but not limited to, damages arising from the disallowance of any potential claim against the Debtor or damages to business reputation, lost business or lost profits), whether foreseeable or not and however caused arising from or related to any information provided herein or omitted herein.

The Debtor reserves all rights to amend or supplement the Schedules and SOFA from time to time, in all respects, as may be necessary or appropriate, including, but not limited to, the right to dispute or otherwise assert offsets or defenses to any claim reflected on the Schedules and SOFA as to amount, liability, classification, or to otherwise subsequently designate any claim as "disputed," "contingent," or "unliquidated." Furthermore, nothing contained in the Schedules, SOFA, or Notes shall constitute a waiver of the Debtor's rights or an admission with respect to the Chapter 11 Case (as defined below), including, but not limited to, liability for any claims, any issues involving objections to claims, substantive consolidation, equitable subordination, defenses, characterization or re-characterization of contracts and leases, assumption or rejection of contracts and leases under the provisions of chapter 3 of the Bankruptcy Code, causes of action arising under the provisions of chapter 5 of the Bankruptcy Code, or any other relevant applicable laws to recover assets or avoid transfers. Any specific reservation of rights contained elsewhere in the Notes does not limit in any respect the general reservation of rights contained in this paragraph.

The Schedules, SOFA, and Notes should not be relied upon by any persons for information relating to current or future financial conditions, events, or performance of the Debtor or its affiliates.

GLOBAL NOTES REGARDING SCHEDULES & SOFA

1. <u>Description of the ABC Proceeding</u>. On February 28, 2023, Envistacom and Asset Recovery Associates Envistacom, LLC, a Georgia limited liability company (the "<u>Assignee</u>") executed that certain *Deed of Assignment* (the "<u>Deed of Assignment</u>"), filed the same day with the clerk of the Superior Court in Gwinnett County, Georgia, and served a letter informing them of the commencement of an assignment for the benefit of creditors (the "<u>ABC Proceeding</u>") on all of Envistacom's creditors. The filing of the Deed of Assignment commenced the ABC Proceeding and assigned for the purpose of liquidation all of Envistacom's right, title, and interest in all of its assets to the Assignee managed by Katie S. Goodman, the managing partner of GGG Partners, LLC in Atlanta, Georgia.

Following commencement of the ABC Proceeding, certain payments were made by the Assignee to the Debtor's creditors. Such payments are not captured in the Schedules & SOFA.

- <u>Description of the Chapter 7 Case</u>. On March 21, 2023 (the "<u>Petition Date</u>"), five of the Debtor's creditors, including MAG DS Corp., Amentum Services, Inc., SteelGate LLC, Momentum Decisive Solutions USA, Inc., and L3 Technologies, Inc. (collectively, the "<u>Petitioning Creditors</u>"), filed an involuntary bankruptcy petition against Envistacom [Docket No. 1] (the "<u>Involuntary Case</u>").
- 3. Description of the Chapter 11 Case. On May 9, 2023, the Debtor filed the Motion of Envistacom, L.L.C. for Entry of an Order Converting the Involuntary Case to Chapter 11 Pursuant to 11 U.S.C. § 706(a) [Docket No. 40] (the "Motion to Convert"). On May 10, 2023, the Court entered the Order for Relief on Involuntary Petition and Order Converting Involuntary Case to Chapter 11 Pursuant to 11 U.S.C. § 706(a) [Docket No. 40] (the "Motion to 11 U.S.C. § 706(a) [Docket No. 40] (the "Motion to 11 U.S.C. § 706(a) [Docket No. 41]. On May 11, 2023, the Debtor commenced a voluntary case under chapter 11 of the Bankruptcy Code (the "Chapter 11 Case").
- 4. **Basis of Presentation**. The Schedules and SOFA neither purport to represent financial statements prepared in accordance with Generally Accepted Accounting Principles ("<u>GAAP</u>") in the United States, nor are they intended to be fully reconciled with the financial statements of the Debtor.

Given, among other things, the uncertainty surrounding the valuation of certain assets and the valuation and nature of certain liabilities, the Debtor may report more assets than liabilities. Such report shall not constitute an admission that the Debtor was solvent on the Petition Date or at any time before or after the Petition Date. Likewise, reporting more liabilities than assets shall not constitute an admission that the Debtor was insolvent on the Petition Date or any time prior to or after the Petition Date.

5. <u>**Reporting Date**</u>. The reported asset values in Schedules A and B, with the exception of estimated cash balances, reflect the Debtor's asset values as of March

21, 2023 (the "<u>Reporting Date</u>"). Estimated cash balances presented in Schedule A reflect estimated bank balances as of March 21, 2023.

- 6. <u>**Current Values**</u>. Other than estimated bank cash balances, and unless otherwise noted, the liabilities are based on the Debtor's accounting books and records; the assets are based on estimated values unless otherwise noted.
- 7. <u>Excluded Assets</u>. The Debtor has excluded certain categories of assets and liabilities from the Schedules and SOFA, including, without limitation, items such as leasehold improvements that the Debtor does not anticipate a recovery on an economic basis as well as other claims that have yet to be quantified.
- 8. <u>Intercompany Balances</u>. The Debtor has excluded intercompany payables and receivables from the Schedules and SOFA with the exception of certain amounts recorded with Apothym Technologies Group, LLC.
- 9. <u>Accuracy</u>. Although the Debtor has made reasonable efforts under the circumstances to file complete and accurate Schedules and SOFA, inadvertent errors or omissions may exist. The financial information disclosed herein was not prepared in accordance with federal or state securities laws or other applicable non-bankruptcy law or in lieu of complying with any periodic reporting requirements thereunder. Persons and entities trading in or otherwise purchasing, selling, or transferring the claims against or equity interests in the Debtor should evaluate this financial information in light of the purposes for which it was prepared. The Debtor is not liable for and undertakes no responsibility to indicate variations from securities laws or for any evaluations of the Debtor based on this financial information or any other information. The Debtor reserves all rights to amend and/or supplement the Schedules and SOFA as is necessary or appropriate.
- 10. <u>Net Book Value of Assets</u>. In many instances, current market valuations are not maintained by or readily available to the Debtor. It would be prohibitively expensive, unduly burdensome, and an inefficient use of estate resources for the Debtor to obtain current market valuations for all assets. Therefore, estimated values are reflected in the Schedules and SOFA. When necessary, the Debtor has indicated that the value of certain assets is "unknown" or "undetermined." Amounts ultimately realized may vary materially from net book value (or other value so ascribed). Accordingly, the Debtor reserves all rights to amend, supplement, and adjust the asset values set forth in the Schedules and SOFA.
- 11. <u>**Currency**</u>. All amounts shown in the Schedules and SOFA are in U.S. Dollars.
- 12. <u>Inventory</u>. Inventories are reported based on an estimate of the realizable value as of the Reporting Date.
- 13. <u>**Totals**</u>. All totals that are included in the Schedules and SOFA represent totals of all the known amounts included in the Schedules and SOFA and exclude items

identified as "unknown" or "undetermined." If there are unknown or undetermined amounts, the actual totals may be materially different from the listed totals. Where a claim or other amount is marked as "unliquidated," but the Debtor also reports a dollar value, such dollar value may indicate only the known or determined amount of such claim or amount, the balance of which is unliquidated.

- 14. <u>**Reservation of Rights**</u>. Nothing contained in the Schedules, SOFA, or Notes shall constitute a waiver of rights with respect to the Chapter 11 Case, including, but not limited to, the following:
 - a. Any failure to designate a claim listed on the Schedules and SOFA as "disputed," "contingent," or "unliquidated" does not constitute an admission by the Debtor that such amount is not "disputed," "contingent," or "unliquidated." Additionally, the dollar amounts of claims listed may be exclusive of contingent and additional unliquidated amounts. Further, the claims of individual creditors are listed as the amounts entered on the Debtor's books and records and may not reflect credits or allowances due from such creditors to the Debtor reserves the right to dispute and to assert setoff rights, counterclaims, and defenses to any claim reflected on its Schedules as to amount, liability, and classification, and to otherwise subsequently designate any claim as "disputed," "contingent," or "unliquidated."
 - b. Notwithstanding that the Debtor has made reasonable efforts under the circumstances to correctly characterize, classify, categorize, or designate certain claims, assets, executory contracts, unexpired leases, and other items reported in the Schedules and SOFA, the Debtor nonetheless may have improperly characterized, classified, categorized, or designated certain items. The Debtor thus reserves all rights to recharacterize, reclassify, recategorize, or redesignate items reported in the Schedules and SOFA at a later time as is necessary and appropriate.
 - c. The description of an amount as "unknown" or "undetermined" is not intended to reflect upon the materiality of such amount.
 - d. The listing of a claim does not constitute an admission of liability by the Debtor, and the Debtor reserves the right to amend the Schedules accordingly.
 - e. The listing of a claim on Schedule D as "secured" or on Schedule E/F as "priority unsecured," or the listing a contract or lease on Schedule G as "executory" or "unexpired," does not constitute an admission by the Debtor of the legal rights of the claimant, or a waiver of the Debtor's rights to recharacterize or reclassify such claim or contract pursuant to a schedule

amendment, claim objection, or otherwise. Moreover, although the Debtor may have scheduled claims of various creditors as secured claims for informational purposes, no current valuation of the Debtor's assets in which such creditors may have a security interest has been undertaken. Except as provided in any order by the Bankruptcy Court that is or becomes final, the Debtor reserves all rights to dispute and challenge the secured nature or amount of any such creditor's claims or the characterization of the structure of any transaction, or any document or instrument related to such creditor's claim.

- f. In the ordinary course of its business, the Debtor leased property from certain third-party lessors for use in the daily operation of its business. Any such leases are set forth on Schedule G, and any current amounts due under such leases that were outstanding as of the Petition Date are listed on Schedule E/F. Nothing in the Schedules or SOFA is or shall be construed as an admission or determination as to the legal status of any lease (including whether any lease is a true lease or a financing arrangement), and the Debtor reserves all rights with respect to any of such issues, including, the recharacterization thereof.
- g. The claims of individual creditors for, among other things, goods, products, services, or taxes are listed as the amounts entered on the Debtor's books and records and may not reflect credits, allowances, or other adjustments due from such creditors to the Debtor. The Debtor reserves all of its rights with regard to such credits, allowances, and other adjustments, including but not limited to, the right to assert claims objections and/or setoffs with respect to the same.
- h. Although the Debtor has made reasonable efforts under the circumstances to ensure the accuracy of its Schedules and SOFA, they nevertheless may contain errors and omissions. The Debtor hereby reserves all of its rights to dispute the validity, status, and enforceability of any contracts, agreements, and leases set forth on the Schedules and SOFA, and to amend and supplement the Schedules and SOFA as necessary.
- i. The Debtor further reserves all of its rights, claims, and causes of action with respect to the contracts and leases listed on the Schedules and SOFA, including, but not limited to, the right to dispute and challenge the characterization or the structure of any transaction, document, and instrument related to a creditor's claim.
- j. Listing a contract or lease on the Schedules and SOFA shall not be deemed an admission that such contract is an executory contract, such lease is an unexpired lease, or that either necessarily is a binding, valid, and enforceable contract. The Debtor hereby expressly reserves the right to assert that any contract listed on the Schedules and SOFA does not

constitute an executory contract within the meaning of Bankruptcy Code section 365, as well as the right to assert that any lease so listed does not constitute an unexpired lease within the meaning of Bankruptcy Code section 365.

k. Exclusion of certain intellectual property should not be construed to be an admission that such intellectual property rights have been abandoned, have been terminated or otherwise expired by their terms, or have been assigned or otherwise transferred pursuant to a sale, acquisition, or other transaction. Conversely, inclusion of certain intellectual property should not be construed to be an admission that such intellectual property rights have not been abandoned, have not been terminated or otherwise expired by their terms, or have not been assigned or otherwise transferred pursuant to a sale, acquisition, or other transaction.

SPECIFIC DISCLOSURES WITH RESPECT TO THE SOFA

<u>Statement 1</u>. The amounts contained in Statement 1 reflect balances as of January 31, 2023, which is the most recent information available to the Debtor. Due to employee departures in the Debtor's treasury department prior to the Petition Date, the Debtor was not able to update this information to reflect all payments made in the weeks leading up to the Petition Date.

<u>Statement 3</u>. The amounts contained in Statement 3 do not reflect payments made by the Assignee in connection with the ABC Proceeding. Additionally, the Debtor has requested information from Georgia's Own Credit Union regarding employee reimbursements made in the 90-day period prior to the Reporting Date but has yet to receive it. The Debtor will file an amended version of Statement 3 once it receives the additional information from Georgia's Own Credit Union.

<u>Statement 4</u>. The amounts contained in Statement 4 do not reflect payments made by the Assignee in connection with the ABC Proceeding.

Statement 7. Information provided on Statement 7 includes only those legal disputes and administrative proceedings that are formally recognized by an administrative, judicial, or other adjudicative forum and omits threatened litigation that has not yet been commenced. While the Debtor made reasonable efforts under the circumstances to complete Statement 7, it is possible that certain suits and proceedings may have been inadvertently excluded in the Debtor's response to Statement 7. The Debtor reserves all of its rights to amend or supplement its response to Statement 7.

<u>Statement 26(d)</u>. The Debtor contacted various parties in connection with its restructuring efforts, and the Debtor, through its advisors, may have shared certain financial information with those parties, who are not individually disclosed herein due to confidentiality restrictions.
