Pursuant to sections 327, 330 and 331 of title 11 of the United States Code, §§ 101-1532 (the "Bankruptcy Code"), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), the Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals, dated March 16, 2020 [D.I. 121] (the "Interim Compensation Procedures Order"), Epiq Corporate Restructuring, LLC ("Epiq") hereby files this Final Fee Application of Epiq Corporate Restructuring, LLC, as Administrative Advisor to the Debtor for Services Rendered and for

Reimbursement of Expenses for the Period from November 1, 2023 Through February 28, 2023 (the "Application") for final allowance of compensation in the amount of §31,738.10 and reimbursement of expenses in the amount of §0.00 for the period November 1, 2021 through February 23, 2023 (the "Compensation Period"). In support of this application, Epiq respectfully represents as follows:

Jurisdiction and Venue

- 1. This Court has jurisdiction over the Application pursuant to 28 U.S.C. §§ 157 and 1334 and 1334 and the *Amended Standing Order of Reference* from the United States District Court for the Middle District of Pennsylvania. Venue of this proceeding and the Application is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2)(A) and (M).
- The statutory bases for relief requested herein are Bankruptcy Code sections 105(a),
 330, and 331.

Background

- 3. On February 19, 2020 (the "*Petition Date*"), the Debtor filed a voluntary petition for relief with the Court under chapter 11 of the Bankruptcy Code. At all times relevant to this Application, the Debtor was operating its business and managing its properties as debtor in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No trustee or examiner was appointed in these bankruptcy cases.
- 4. On March 6, 2020, the United States Trustee for the Middle District of Pennsylvania appointed the Committee.
- 5. Epiq was retained as Administrative Advisor to the Debtor, effective as of March 24, 2020, pursuant to this Court's *Order Authorizing the Debtor to Retain and Employ Epiq Corporate*Restructuring, LLC as Administrative Advisor Effective as of the Petition Date [D.I. 174] (the

"Retention Order"). The Retention Order authorized Epiq to be compensated on an hourly basis and

to be reimbursed for actual and necessary out-of-pocket expenses.

6. A description of the Debtor's history, business operations, operational structure, the

reasons for commencing the Chapter 11 Case are set forth in the Informational Brief of the Roman

Catholic Diocese of Harrisburg (the "Informational Brief") and the Declaration of Christopher G.

Linscott in Support of First Day Motions (the "Linscott Declaration" and, with the Informational

Brief, collectively, the "First Day Informational Pleadings").

7. On February 17, 2023, this Court entered the *Findings of Fact, Conclusions of Law and*

Order Confirming the Amended Joint Plan of Reorganization for the Roman Catholic Diocese of

Harrisburg (Dkt. No. 1530), confirming the Amended Joint Chapter 11 Plan of the Reorganization

for the Roman Catholic Diocese of Harrisburg (Dkt. No. 1470) (the "Plan").

8. All services for which compensation is requested by Epiq as administrative advisor

were performed for or on behalf of the Debtor.

Summary of Services by Project for the Compensation Period

9. Attached as **Exhibit A** is Epiq's itemized time records of its professionals and

itemized records of reimbursement sought for the Compensation Period. Following is a summary of

the Epiq work for the Compensation Period:

A. 495 – Balloting/Solicitation Consultation

Fees: \$31,236.10

Total Hours: 133.04

This category includes all matters related to the solicitation process, including but not limited

to: (i) preparation for the mailing of solicitation materials; (ii) review of post-solicitation issues,

including receiving and processing ballots submitted in connection with the Plan; (iii) tabulation and

audit of all votes cast; (iv) preparation and finalization of the vote certification for filing with the

Court; and (v) attendance at the hearing to consider confirmation of the Plan as a declarant in support

of confirmation.

B. 642 – Fee Application Preparation

Fees: \$502.00

Total Hours: 2.00

This category includes all matters relating to the preparation of Epiq fee and expense

applications.

Description and Valuation of Services for the Compensation Period

10. The rates charged to the Debtor's estate are Epiq's normal hourly rates for work of this

nature. The reasonable value of the services rendered by Epiq to the Debtor during the Compensation

Fee Period is **\$31,738.10**.

11. In accordance with the factors enumerated in Bankruptcy Code section 330, it is

respectfully submitted that the amount requested by Epiq is fair and reasonable given (a) the

complexity of the case, (b) the time expended, (c) the nature and extent of the services rendered, (d) the

value of such services, and (e) the costs of comparable services, other than in a case under chapter 11

of the Bankruptcy Code. Moreover, Epiq has reviewed the requirements of Local Rule 2016-2 and

believes that this Application complies with such Local Rule.

Actual and Necessary Expenses

12. Epiq incurred a total of \$0.00 in actual and necessary expenses in connection with

representing the Debtor during the Compensation Period.

No Other Payments Received

13. Except as otherwise set forth in this Application, Epiq received no payment and no

promises for payment from any source other than the Debtor for services rendered or to be rendered

in any capacity in connection with the matters covered by this Application.

14. There is no agreement or understanding between Epiq and any other person other than among the members of Epiq for the sharing of compensation to be received for services rendered in the case.

No Prior Relief

15. Except as provided herein, no prior application for the relief requested herein has been made to this or any other court.

No Adverse Interest

16. At all relevant times, Epiq has neither represented nor held any interest adverse to the Debtor's estate.
