# ORDER AUTHORIZING THE DISALLOWANCE OF CERTAIN CLAIMS FOR FAILURE TO FURNISH REQUESTED TAX INFORMATION BY APPLICABLE DEADLINES

Upon the motion (the "Motion")<sup>2</sup> of Daniel H. Golden, in his capacity as liquidating trustee and administrator of the DFC Liquidating Trust and the sole officer and director of the Liquidating Debtors (the "Liquidating Trustee"), for entry of an order, pursuant to sections 105 and 1142 of the Bankruptcy Code, disallowing the Missing TIN Claims to the extent that the Liquidating Trustee does not receive the Tax Information for the respective Missing TIN Claimants prior to the Applicable TIN Deadline; and the Court having jurisdiction to consider the matters raised in the Motion pursuant to 28 U.S.C. § 1334 and the Order of Reference to Bankruptcy Judges, General Order 2012-6 (S.D. Tex. May 24, 2012) (Hinojosa, C.J.); and the Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157; and the Court having found that it may enter a final order consistent with Article III of the United States Constitution; and the Court having found that venue of this proceeding and the Motion in this District is proper pursuant to 28 U.S.C.

6004(a) and opportunity for objection to and a hearing on the Motion having been given to the parties listed therein, and it appearing that no other or further notice need be provided; and the Court having reviewed and considered the Motion and the Wright Declaration; and the Court having determined that the legal and factual bases set forth in the Motion and the Wright Declaration and at the hearing (if any) establish just cause for the relief granted herein; and the Court having found that the relief requested in the Motion being in the best interests of the Liquidating Debtors, their creditors, their estates, and all other parties in interest; and upon all of the proceedings had before the Court; and all objections to the Motion, if any, having been withdrawn, resolved, or overruled; and after due deliberation and sufficient cause appearing therefor,

#### IT IS HEREBY ORDERED, ADJUDGED, AND DECREED AS FOLLOWS:

- 1. The Motion and the relief requested therein is granted and approved as set forth herein.
- 2. Notice of the Motion was fair and equitable under the circumstances and complied in all respects with section 102(1) of the Bankruptcy Code and Bankruptcy Rules 2002 and 6004.
- 3. Each Missing TIN Claim listed on <u>Schedule 1</u> hereto, for which neither the Liquidating Trustee nor any of the Liquidating Trust Professionals receive the Tax Information for the respective Missing TIN Claimant prior to the Applicable TIN Deadline, shall be disallowed in its entirety and such Missing TIN Claimant's right to Plan Distributions in the Chapter 11 Cases on account of such Missing TIN Claim, if any, shall be deemed waived, discharged, and forever barred without further order of the Court.

4. Epiq, as the Claims, Noticing, Solicitation, and Administrative Agent, is

authorized and directed to expunge the Missing TIN Claims from the claims register maintained

in the Chapter 11 Cases to reflect the relief granted in this Order.

5. The Liquidating Trustee and Epiq are authorized to take any action

necessary or appropriate to implement and effectuate the terms of, and the relief granted in, this

Order without seeking further order of the Court.

6. Notwithstanding Bankruptcy Rules 6004 and 7062 and any other applicable

Bankruptcy Rules or applicable Local Rules to the contrary, this Order shall be effective

immediately upon entry and shall not be subject to any stay in the implementation, enforcement,

or realization of the relief granted herein. Any stay of this Order is expressly waived.

7. The Court shall retain exclusive jurisdiction to hear and determine all

matters arising from or related to the implementation, interpretation, and enforcement of this

Order.
