## X GAMES

# Action events in LA for 1st time since 2013

The X Games return to Southern California this week for the first time in 10 years.

The gnarliest tricks and flips on bikes and skateboards will be showcased at the Ventura County Fairgrounds & Events Center.

The event used to be held in Los Angeles each summer but has not been back since 2013.

Some of the most famous athletes to participate in the X Games will make their returns, including Nyjah Houston, who is competing in Men's Skateboard Street. Houston is in the middle of a comeback after tearing his anterior cruciate ligament last fall.

At 55 years old, legendary skater Tony Hawk will be in the broadcast booth for ESPN.

Here's everything you need to know about the X Games, ranging from the many competitions to how to watch.

## What are the X Games?

Created in 1993, the X Games are action events held throughout the year that include skateboarding and BMX biking. There are also winter X Games

with skiing and snowboarding events. This year's X Games includes competitions with BMX bikes, skateboards and Moto X or off-road motorcycles.

The X Games bring together the top action athletes in the world to participate in various competitions. Participants can win bronze, silver and gold medals.

Shaun White and Garrett Reynolds are tied for the most X Games gold medals at 15. Reynolds can surpass that total this weekend as he participates in the Men's BMX Street and Real BMX Best Trick events.

## When are the events?

Competitions will be held from Friday to Sunday.

Events run from 1:30 to 11:30 p.m. EDT on Friday, 1 to 11 p.m. EDT on Saturday and noon to 6 p.m. EDT on Sunday.

## How can you watch the X Games?

The X Games will be broadcast across ABC, ESPN and ESPN2 for a combined 15.5 hours of live competition.

Streaming is also available on the X Games' YouTube channel and Twitch.

The streaming service Caffeine will also broadcast various events.

## What competitions will be held?

**BMX** – Dirt, Dirt Best Trick, Monster Energy MegaPark, Park, Dave Mirra's BMX Park Best Trick, Street.

**Skateboard** – Park (Men's & Women's), Street (Men's & Women's), Street Best Trick (Men's & Women's), Monster Energy MegaPark, Pacifico Vert (Men's & Women's), Vert Best Trick.

**Moto X** – Best Trick, Best Whip, QuarterPipe High Air.

Each competition has its own way of determining winners.

Events with 10 or fewer participants are ranked by their highest scores during a specific number of runs or time limit.

For example, the BMX Dirt has a 20-minute jam run for eight athletes where the riders have as many attempts as possible to land their best trick within that time limit. The athlete with the best score is the winner. Only the Moto X Best Whip competition, which has eight participants, has two rounds similar to larger events.

Events with 11 or more participants go through "heats" or semifinals with a specific number of runs or time limit to determine who can move on to the final round.

For example, the men's and women's

skateboard park event has 12 participants. Two heats of six skaters take as many runs as possible within 18-minute jam sessions. The best scores move on to the finals.

## Who are notable athletes participating in X Games California?

All-time X Games gold medalist Garrett Reynolds will have the chance to make history while defending his 2022 medal in BMX Street. Seven-time gold medalist Rob Adelberg is back after winning two gold medals last year in Moto X Best Trick and Freestyle.

There are four skateboarders from California under the age of 20 who will participate in the men's or women's skateboarding events: Gavin Bottger (16), Raphae Ueda (16), Minna Stress (17) and Bryce Wettstein (19), highlighting the Games' younger side.

Legendary skateboarder Nyjah Houston continues his journey back from a torn ACL. One of the best skateboarders in the world, Pedro Barros, will compete in the men's skateboard park event. In 2014, Barros became the second athlete in X Games history with at least seven consecutive gold or silver medals in the same event.

## LEAGUES CUP EVERYTHING TO KNOW

# MLS-Liga MX tournament set

The burgeoning romance between North America's top two men's professional soccer leagues takes a massive step with this year's edition of the Leagues Cup.

Previously played as a cozy, eight-team tournament, the Leagues Cup evolves into a bombastic 47-team competition featuring every MLS and Liga MX club. Both leagues will halt regular-season play for a month to complete the World Cup-style tournament.

The expanded Leagues Cup is just the latest step in the MLS and Liga MX partnership, which included two joint All-Star games (2021 and 2022) and the Campeones Cup, the annual showdown of reigning champions from each league (this year it will feature LAFC against Tigres on Sept. 27 at BMO Stadium in Los Angeles).

MLS Season Pass on Apple TV+ will broadcast games.

## What is the Leagues Cup?

The Leagues Cup has been held twice before (2019 and 2021) with limited participation from MLS and Liga MX teams. This year every team from both leagues will take part in the tournament.

The 29 MLS and 18 Liga MX clubs were divided into 15 groups in four regions: East, Central, South and West. The group stage starts Friday and continues until July 31. The top two finishing teams from each group – with the exception of Group 1 in the South Region – will advance to the single-elimination knockout rounds, which start Aug. 2. The final will be held Aug. 19.

Los Angeles FC – the 2022 MLS Cup champion – and Pachuca – the Liga MX champion with the most combined points accumulated across the Clausura and Apertura seasons in the 2022 calendar year – earned byes for the group stage and will enter the competition during the knockout stage.

Automatic qualification to the Round of 16 of the Concacaf Champions League goes to the tournament winner. The Leagues Cup runner-up as well as the third-place match winner qualify for the Champions League, too.

## Will Lionel Messi play?

Lionel Messi, who finally signed with Inter Miami CF and was introduced to his new home crowd in the rain at DRV

PNK Stadium on Sunday night, will debut with his new team in the 2023 Leagues Cup. The seven-time Ballon d'Or winner revealed last month he would play in the U.S. for David Beckham's MLS club, but the deal wasn't finalized for weeks.

## Group stage will have no ties

A victory in regulation will count as three points. For games tied after 90 minutes, each team will receive one point and the winner of the subsequent penalty shootout will earn an additional point.

## Where will games be?

All 77 matches will be held either in the U.S. or Canada.

Starting with the Round of 16, matches between two MLS clubs will be hosted by the club with the better finish in the 2022 Supporters' Shield standings. Matches between two Liga MX clubs will be hosted at a venue designated by the tournament organizing committee.

Here is the pool of regional venues for matches between two Liga MX clubs during the knockout rounds:

- **East:** Red Bull Arena (Harrison, N.J.), Subaru Park (Chester, Pennsylvania), Audi Field (Washington, D.C.).
- **Central:** SeatGeek Stadium (Bridgeview, Illinois), Toyota Stadium (Frisco, Texas), Dick's Sporting Goods Park (Commerce City, Colorado), Shell Energy Stadium (Houston).
- **South:** Q2 Stadium (Austin, Texas), Toyota Stadium (Frisco, Texas), Exploria Stadium (Orlando, Florida).
- **West:** BMO Stadium (Los Angeles), Dignity Health Sports Park (Carson, California), America First Field (Salt Lake City), PayPal Park (San

Jose, California).

## How teams qualified

Every MLS and Liga MX team qualified. However, teams were seeded based on previous seasons' standings. MLS clubs ranked 2 to 16 based on 2022 Supporters' Shield finish were seeded first in each group. Liga MX clubs ranked 2 to 16 based on total combined points from Clausura 2022 and Apertura 2022 campaigns will be in the second position in each group, opposite the MLS rankings (for example, Liga MX's 16 seed – Tijuana – was placed in a group with the MLS 2 seed – Philadelphia Union).
