DECLARATION OF DISINTERESTEDNESS OF NATHANIEL BARTCH IN SUPPORT OF EMPLOYMENT OF ALVAREZ & MARSAL TRANSACTION ADVISORY GROUP, LLC AS A PROFESSIONAL UTILIZED IN THE ORDINARY COURSE OF BUSINESS

Nathaniel Bartch, declares and says:

- 1. I am a Managing Director with Alvarez & Marsal Transaction Advisory Group, LLC (together with employees of its affiliates (all of which are wholly-owned by its parent company and employees), its wholly owned subsidiaries, and independent contractors, collectively, "A&M") a professional consulting firm with numerous offices around the world. I submit this declaration on behalf of A&M.
- 2. Instant Brands Acquisition Holdings, Inc. and certain of its affiliates (collectively, the "**Debtors**"), each of which is a debtor and debtor in possession in the above-captioned chapter 11 cases (the "**Chapter 11 Cases**"), have requested that A&M provide certain due diligence services to the Debtors, and A&M has consented to provide those services.

- 3. A&M together with its professional service provider affiliates (the "Firm") utilize certain procedures ("Firm Procedures") to determine the Firm's relationships, if any, to parties that may have a connection to a client debtor. In implementing the Firm Procedures, the following actions were taken to identify parties that may have connections to the Debtors, and the Firm's relationship with such parties:
 - A&M requested and obtained from the Debtors a list of interested parties and significant creditors (the "Potential Parties in Interest"). The list of Potential Parties in Interest which A&M reviewed is annexed hereto as <u>Schedule A</u>. The Potential Parties in Interest reviewed included the Debtors and their non-filing affiliates, prepetition lenders, officers, directors, the thirty (30) largest unsecured creditors of the Debtors (on a consolidated basis), parties holding ownership interests in the Debtors and landlords.
 - A&M then compared the names of each of the Potential Parties in Interest to the names in its master electronic database of the Firm's clients (the "Client Database"). The Client Database generally includes the name of each client of the Firm, the name of each party who is or was known to be adverse to the client of the Firm in connection with the matter in which the Firm is or was representing such client, the name of each party that has, or had, a substantial role with regard to the subject matter of the Firm's retention, and the names of the Firm professionals who are, or were, primarily responsible for matters for such clients.
 - An email was issued to all Firm professionals requesting disclosure of information regarding: (i) any known personal connections between the respondent and/or the Firm on the one hand, and certain significant Potential Parties in Interest or the Debtors, on

the other hand, (ii) any known connections or representation by the respondent and/or the Firm of any of those Potential Parties in Interest in matters relating to the Debtors; and (iii) any other conflict or reason why A&M may be unable to represent the Debtors.

- 4. Known connections between the Firm and the Potential Parties in Interest were compiled for purposes of preparing this Declaration. These connections are listed in **Schedule B** annexed hereto.
- 5. In addition to the disclosures on **Schedule B**, I note that Cornell Capital, LLC, one of the Permitted Holders and Sponsors (each as defined in the Final DIP Order, Docket No. 257), has agreed to provide a back-up indemnity to A&M in addition to the indemnity agreed to by the Debtors.
- 6. Pursuant to rule 2014 of the Federal Rules of Bankruptcy Procedure, and based on the Firm Procedures, A&M hereby confirms that, the Firm does currently perform services, and may perform services in the future, in matters unrelated to the Chapter 11 Cases, for persons that are claimants or other parties in interest in the Chapter 11 Cases. To the best of my knowledge, the Firm does not perform services for any such person in connection with the Chapter 11 Cases.
- 7. A&M, insofar as I have been able to ascertain, does not hold, or represent any interest adverse to the Debtors or their estates with respect to the matters on which A&M is to be employed.
- 8. A&M has not agreed to share and will not share any portion of the compensation to be received from the Debtors with any person other than partners and associates of the Firm.
 - 9. The Debtors owe the Firm \$0 for prepetition services.
- 10. A&M is conducting further inquiries regarding its retention by any creditors of the Debtors and, upon conclusion of that inquiry or at any time during the period of its employment,

if A&M should discover any facts bearing on the matter described herein, A&M will supplement the information contained in this declaration.

11. Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct, and that this declaration was executed on August 5, 2023.
