## NOTICE OF INTENT TO ADDUCE TESTIMONY FROM A REMOTE LOCATION <u>BY TELEPHONE AND VIDEO TECHNOLOGY</u>

- 1. This Notice is filed pursuant to BLR 9017-1(c)(2)(B) by Tribolet Advisors, LLC, in its capacity as Plan Administrator (the "<u>Plan Administrator</u>") in the above-captioned bankruptcy cases.
- 2. This Notice pertains to the matters scheduled for hearing or trial in this case on October 5, 2023, at 1:30 p.m. prevailing Central Time.
- 3. The Plan Administrator is unsure whether claimant Nelu Mihai intends on appearing in person or remotely. Therefore, out of an abundance of caution, the Plan Administrator provides this notice that it intends to call (either as an adverse witness, or to cross-examine if necessary) Nelu Mihai to testify at the scheduled hearing or trial by telephone and video technology.

If the Court does not authorize the testimony to be taken remotely, the Court will schedule a date for the witness's testimony to be given live in open court. Both the witness and the objector must appear in person at the scheduled date.
- 5. This Notice may be withdrawn at any time prior to the scheduled hearing or trial.
