



Note on Legal Entities:

Part 3: Recoveries of the Holders of Claims and Interests under Confirmed Plan

With respect to general unsecured claims, actual and expected payment amounts shall be funded from the \$5.75 million initial funding for the Class 6B Trust, any recoveries from Class 6B Causes of Action, less the expenses of the Class 6B Trust, all to be administered by the Class 6B Trust for the benefit of Other General Unsecured Claims in Class 6B of the Plan. The claims reconciliation process is ongoing with respect to holders of Other General Unsecured Claims, and reporting with respect to such claims is premature at this time. Other amounts in Part 3(d) are related to Ongoing General Unsecured Claims. The recoveries of Holders of Claims and Interests under the Plan excludes certain payments made to creditors who filed proofs of claims for liabilities that are wholly post-petition in nature. Additionally, the information in this section of the post-confirmation report excludes payments made prior to confirmation of the Plan under authority granted by the First Day Orders to pay prepetition liabilities of the Debtors.
