**ORDER GRANTING URGENT MOTION AUTHORIZING DISCOVERY WITH
RESPECT TO PREPETITION FIRST LIEN OBLIGATIONS, PREPETITION FIRST
LIEN AGENT, AND PREPETITION FIRST LIEN LENDERS**

Upon consideration of the urgent motion of the Committee of Unsecured Creditors (the “Committee”), by and through its proposed counsel, Porzio, Bromberg & Newman, P.C., pursuant to Rule 2004 of the Federal Rules of Bankruptcy Procedure and Local Rule 2004-1 of the United States Bankruptcy Court for the District of Puerto Rico, seeking the entry of an order authorizing discovery with respect to the Prepetition First Lien Secured Parties and the Debtors (the “**2004 Motion**”, Docket No. 337)¹, and due and proper notice of the 2004 Motion having been given, IT IS HEREBY ORDERED THAT:

1. The 2004 Motion is **GRANTED**.
2. The document requests set forth in the subpoenas attached to the 2004 Motion as Exhibits B and C (the “Subpoenas”) are authorized pursuant to Fed. R. Bankr. P. 2004 and LBR 2004-1.
3. The Committee is authorized to issue the Subpoenas for live examination attached as Exhibits B and C to representatives of the Debtors and the Prepetition First Lien Secured Parties.
4. Within ten (10) days of service of a Subpoena, the 2004 recipient shall produce all documents responsive to the document requests contained in such Subpoena.

¹ The motion[s] was[were] filed in each of the captioned Chapter 11 Cases. Reference, however, is made only to docket entries in Lead Case No. 23-02510. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the motion[s].

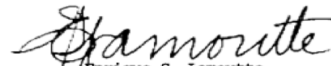

2 5. The Committee may schedule oral examinations on the topics set forth in the
3 Subpoena to occur by remote video means within ten (10) days of service of such Subpoena (or
4 such later date as may be mutually agreed upon by the Committee and the recipient), with the
5 parties to meet and confer within five (5) days of service of the Subpoena to schedule the date of
6 the examination.

7 6. Nothing herein shall prejudice the Committee from seeking further discovery from
8 any party, whether under Fed. R. Bankr. P. 2004 or otherwise.

9 7. This Court shall retain jurisdiction to resolve any dispute arising from or related
10 to this Order and to interpret, implement and enforce the provisions of this Order.

11 IT IS SO ORDERED.
